## PREFACE

Child Help Foundation (CHF) is a Pan-India non-profit organization working towards empowering the poor and marginalized communities. We have been working across India to successfully provide humanitarian aid to the needy over the last 11 years. This Annual Report marks all the endeavors of Child Help Foundation in the financial year 2021-2022.

COVID-19 has impacted billions of people around the globe. It has driven the poorest members of society even further into poverty, increasing the risk of hunger and death. Child Help Foundation (CHF) has been battling, not only to support and save the lives of underprivileged children and their families in need but also the helpless strays who were affected during the pandemic, along with other disasters like floods and earthquakes.

It is a beautiful thing to be able to give back to our community and help the people in need and poor financial situations. We were able to attain our goals with the active participation of our volunteers, partner NGOs, individual donors, corporate sector participation through CSR, government bodies, and well-wishers.

Our organization is mainly child-centric and for them to be able to thrive, it is of utmost importance that the mothers of such children are safe-guarded. In keeping with our goal of providing for the requirements of young children, our carefully chosen theme of the year was Baby Feeding Centers (BFC).

Mothers for their children are the human form of God on this very earth. The healthy future of our society depends on the health of the mothers and their children, who are guardians of that future. We took note of the problems that a mother faces while serving her child's needs and breastfeeding in public places was one of the major issues that most mothers travelling with an infant faced. She either has to breastfeed in public or use the public toilet. Mothers feel helpless in such situations and the baby is left in a crying condition. Thus, it is essential to provide private, safe, and clean nursing or lactation rooms for mothers to breastfeed their infants in public places.

After having recognized the stigma and difficulties associated with breastfeeding, Child Help Foundation started constructing Baby Feeding Centers in India. Currently, the organization has BFCs available in Maharashtra (Kurla, Boisar, Kalyan, and Palghar), Bihar (Katihar), Kerala (Kochi), and West Bengal (New Jalpaiguri). We plan to construct more such Baby Feeding Centers Pan-India for the safety and hygiene of infants and mothers.



## BABY FEEDING CENTERS

Breastfeeding is the most natural and important aspect of mother-baby bond building and child nutrition. It should be encouraged that lactating women feed their newborns at regular intervals. Pediatricians advise mothers to avoid giving their babies even water until they reach the age of six months.

When a lactating mother travels with her baby in a public space and the baby cries out in hunger, there are only two options available to her. She can either breastfeed in public or use the public toilet. Both are equally uncomfortable for the mother. Such situations make the mothers feel helpless and the baby's needs are compromised. It is also important to take note of the social stigma associated with breastfeeding in public spaces.

It is essential to provide private, safe, and clean nursing or lactation rooms for mothers to breastfeed their infants in public buildings, and spaces like malls, shopping centers, cinema halls, bus terminals, railway and metro stations. Child Help Foundation recognized this prevalent yet unnoticed issue! Within our SDG3 program, to maintain "Good health and wellbeing" Baby Feeding Centers (BFC) are being constructed to provide a secure and hygienic environment for mothers and infants across various hospitals and railway stations Pan-India. Mothers can comfortably and safely breastfeed their babies inside the cabins. In collaboration with the Indian Railways, currently, we have BFCs available in Maharashtra (Kurla, Boisar, Kalyan, and Palghar), Bihar (Katihar), and West Bengal (New Jalpaiguri). We have also constructed BFCs in Lakeshore Hospital, Ernakulam General Hospital and Chottaniakkara Temple in Kochi, Kerala.

Maternal and Child Care being one of the focus areas of Child Help Foundation, we plan to construct more Baby Feeding Centers across India for the safety and hygiene of infants and mothers.



## BABY FEEDING CENTERS

### BFCs on Railway Stations

Due to the lack of infrastructure, Child Help Foundation took the initiative to construct BFCs to create a safe and comfortable environment for mothers and have a dedicated space for breastfeeding on railway stations while traveling with infants. The main objective behind this initiative is to uphold the sacred nature of a mother's dignity.

The cabins are painted yellow and carry a representative logo of breastfeeding on the door. Each cabin is equipped with a seat for the mother, a fan, and a light. The cabin is well ventilated with tinted windows and curtains. The station authority and housekeeping staff of the Indian railways look after the cleanliness and maintenance of the BFC cabins.



### Maharashtra

- Child Help Foundation inaugurated its first project of BFCs at Palghar in the year 2019 in collaboration with the Indian Railways.
- In 2019-2020, Child Help Foundation also inaugurated a BFC at Boisar railway station in collaboration with Alkem Laboratories and Indian Railways.
- In the year 2021, with the help of Alkem Laboratories and the Central Railways (Mumbai), Child Help Foundation inaugurated BFCs at Kalyan and Kurla Railway Station.







## BABY FEEDING CENTERS

### Bihar

Child Help Foundation inaugurated a BFC on the Katihar Railway Station, Bihar in the year 2019 to facilitate trouble-free breastfeeding on the railway stations for traveling mothers.

### BFCs in Hospitals and Temples

The BFC ventures on railway platforms were a big success. Child Help Foundation thus thought of expanding the project in the hospitals and other public places. Especially during the pandemic phase, when mothers and their babies waited in line for various tests, the need for the baby to be breastfed appeared to be a high priority in hospitals.

### Kerala

Considering the disgrace that breastfeeding brought to women of different areas of our country, Child Help Foundation also constructed BFCs in the hospitals and temples in Kerala. This was to enable the lactating mothers feel safe and comfortable while carrying out the most natural activity of motherhood.

On 31st December 2021, Child Help Foundation inaugurated a new BFC in Lakeshore Hospital, Kochi, Kerala.

On 14th February 2022, Child Help Foundation inaugurated another BFC at General Hospital, in Ernakulam, Kerala.

The Kerala team of Child Help Foundation, in collaboration with Lourdes Hospital in Kochi and General Hospital in Ernakulam, met the requirements of inaugurating a BFC for the newborns and the mothers in the Chottanikkara Temple, Kerala.

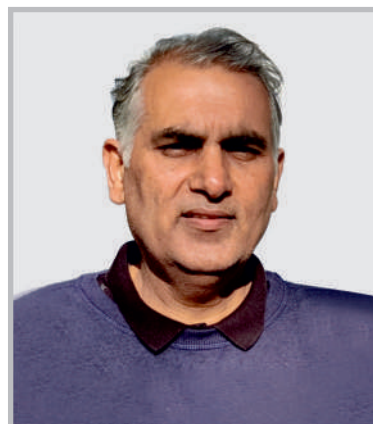
The path ahead is still long and uncertain, but we at CHF will work diligently to live up to our vision and appeal to you for your continued support and blessings to help us reach our goal.

Children are the makers of change. Educating an underprivileged child will make a difference in his/her life, and it will also make a difference in his/her whole family and future generation. One critical illness could deplete the entire family's financial health, sometimes even burying them in debt for years. We know that in the post-pandemic world, healthcare financing is no longer an option, it is a priority. Health emergencies arrive more often than we think, we are less prepared than we believe, and we are all helpless regardless of our economic status.

The year that has gone by has been very eventful and personally satisfying. The number of children we have helped on the path to a better life in a fast-changing world has been numerous. This has spurred us to take on more challenges.

In the financial year 2021-2022, we were able to come up with remarkable and fruitful activities with the support of our donors, volunteers, and the CHF team. We catered to over 16,808 Medical Cases, impacted 13,44,457 in the Zero Hunger Eradication program. We have organized awareness campaigns for adolescent girls through our menstrual hygiene management program and provided clean water and sanitation to 90234 beneficiaries. We catered to 4,68,718 children under the quality education sector and rendered support to 10,88,447 individuals under the Humanitarian Relief and Rehabilitation program. We participated in various events, exhibitions, conferences, plogs, campaigns, and other important meets to take CHF to the next level in serving underprivileged children. We have partnered with various corporates for CSR projects, events, campaigns, employee engagement programs, wish tree activities, and more.

We not only aid and cater to people in need, but we are also working towards programs for feeding and saving wildlife and marine species. Animal lovers from all over the country volunteer with us to help animals in need, so no animal is left unattended because of a lack of funds. Under our programs Life on Land and Life Underwater, we have fed and saved 56,602 stray animals and collected 6,41,580 kilograms of waste from the beaches, seas, and oceans.

Maternal and Child Care being one of the focus areas of CHF, we started constructing Baby Feeding Centers (BFCs) in India to create a safe and comfortable environment for mothers to feed their children. So far we have constructed BFCs on Railway Platforms, in the Hospitals and Temples of Maharashtra, Bihar and Kerala. Our Education Project called the Center of Excellence (CFE) aims to provide modern amenities and educational prospects to underprivileged children and generate resources for school development projects including the physical, academic, social, and mental needs of children.

I am very confident that we will report spectacular progress in the year ahead and do our utmost to uplift the quality of education, lifestyle, medical care, food, and clothing for underprivileged children and their families.

## SDG 2- Let no child die of starvation, striving for Zero Hunger



Child Help Foundation strives to reduce the percentage of malnourished individuals in the predominant cities and rural areas. This will decrease child mortality while also improving nutritional status. Child Help Foundation has supported **13,44,457** children through our Zero Hunger Program. In partnership with Khushiyaan Foundation, we provided warm freshly prepared meals and reached out to **4,96,800** children through our Roti Ghar Program.



## SDG3- Health and Wellbeing of all Children



Child Help Foundation is committed to saving the lives of Children suffering from congenital anomalies and non-communicable diseases like childhood cancer, acquired heart diseases, organ failure, and respiratory diseases. We ensure that children with serious illnesses do not lose their lives. Child Help Foundation provides these children with the best treatment and care in the hospitals. As of today, our efforts have saved **2,358** critically ill children, **6,600** nursing mothers and **50** individuals who were provided oximeters across India.

### SDG 4 – Promoting Inclusive Quality Education



Child Help Foundation aspires to provide inclusive quality education. We aim to empower underprivileged children to become informed, competent and compassionate individuals, thus making them responsible global citizens. Child Help Foundation has made a positive impact in the lives of **4,68,718** children.



### SDG 5 – Standing up for Gender Equality



Child Help Foundation works at the grassroots level to promote education for female children. Our campaign is aligned with the national flagship program, “Beti Bachao, Beti Padhao.” Our educational programs focus on creating equal opportunities for both boys and girls and enable a gender inclusive environment. Child Help Foundation aims to support and cater to the needs of LGBTQIA community as well. Child Help Foundation under its Gender Equality program was able to reach more than **3,04,103** individuals.

## SDG 6 – Ensuring Access to Clean Water and Sanitation



Improving Sanitation and promoting a Clean India is a key priority of the government under the flagship program 'Swachh Bharat Abhiyan'. Child Help Foundation has been at the forefront by facilitating the provision of clean, separate toilets for boys & girls with Water, Sanitation and Hygiene (WASH) facilities. We also promote menstrual hygiene to ensure that adolescent girls are taken care of in residential schools. Child Help Foundation has constructed toilets and WASH facilities in 15 schools, which have directly benefited **89,834** children and **400** individuals through village cleaning.

## SDG 8, 10 – Village Development



In Gulabi Gaon (Bhintighar Village), Nashik, Maharashtra, Child Help Foundation initiated a new village development project in the year 2022. Child Help Foundation aims to improve the lives of rural women through this program so that they can support their families and raise their children in better conditions. Additionally, computer centers for young people are being established, which will help them gain skills and open up more employment opportunities. **793** beneficiaries were reached by this activity.



## SDG 11, 13, 17 – Humanitarian Relief



Child Help Foundation has been at the forefront in responding to Natural Calamities. After the extensive devastation of the floods in Uttarakhand, Assam, Bihar, Kerala, Maharashtra, and Odisha, our teams reached out to provide immediate relief to **10,88,447** affected Victims.

### SDG 14 – Life Below Water



In the year 2019, Child Help Foundation began its new initiative of Beach Clean Ups with For Future India. We successfully removed plastics and other rubbish materials from the beaches of Gorai, Manori, Velankanni, and Juhu in the state of Maharashtra. Child Help Foundation has collected **6,41,580 kgs** of garbage and saved the life of around 2 crore marine species.



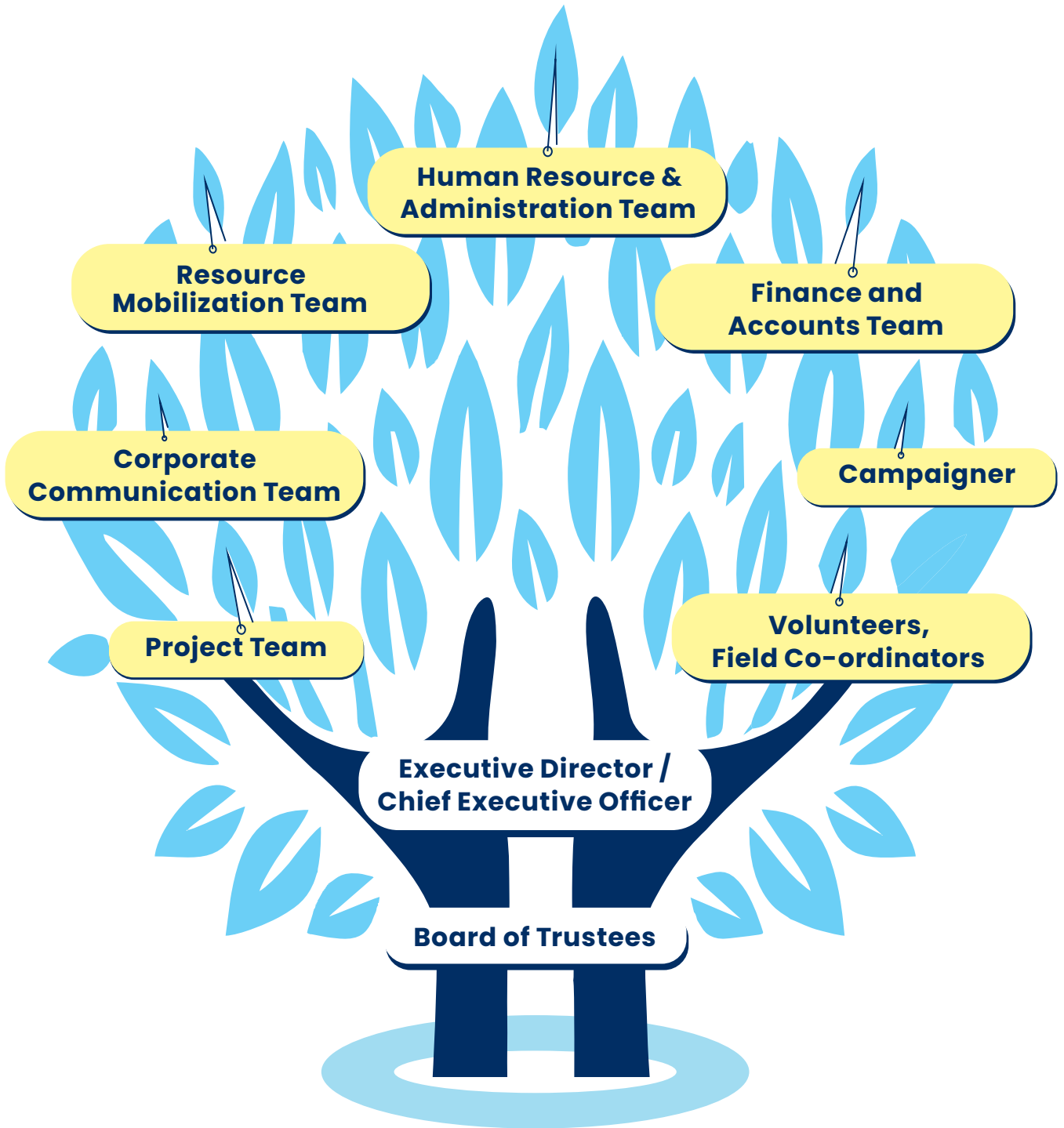
### SDG 15 – Life on Land

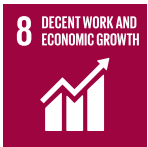

## GOOD HEALTH & WELL BEING (SDG3)

### Emergency Medical Support

The United Nations has set the goal of achieving "good health and well-being" as a part of its third sustainable development goals by 2030. By focusing on providing more efficient funding for health systems, improved sanitation, and hygiene, and increased access to physicians, significant progress can be made in helping to save the lives of millions. Health emergencies such as COVID-19 pose a global risk and have shown the critical need for such preparedness.

Child Help Foundation has largely focused on achieving SDG 3. For anybody who wants to live a healthy and wholesome lifestyle, good health and well-being are necessities. We established our flagship program of Emergency Medical Support to provide medical assistance to children who are in dire need. We hope to improve the life span of children aged 0 to 14 years with this initiative.

We extend medical aid to children who need critical treatment and urgent medical attention and ensure that their families get the support they need throughout the treatment. Our organization funds the treatment of economically disadvantaged children suffering from life-threatening, non-communicable diseases like Congenital Heart Diseases, Cancer, Organ Transplants, and Preterm Babies, amongst many others. We ensure that these children get the required treatment as soon as possible.

### Childhood Cancer

A cancer diagnosis adds up to the miseries of the family of an ailing child. Among children of ages 0 to 14 years, the most common types of cancer diagnosed are leukemias, brain and other central nervous systems (CNS) tumors, and lymphomas and solid tumors, such as neuroblastoma and Wilms tumors. There are more than 12 major types of pediatric cancers and over 100 subtypes. The occurrence of cancer in children between 5 – 14 years is rampant. Pediatric Oncology is the medical specialty focused on the treatment of cancer in children. It's critical to know that this kind of expertise exists and that many children have had successful therapies.

Child Help Foundation takes such cases and works with various doctors and hospitals to find the best treatment for the children fighting from cancer. We extend our support to underprivileged children who need treatment and cannot meet its costs. We have ties with 31 Network Hospitals that specialize in cancer treatment. When patients from low income households are unable to afford treatment, these hospitals recommend the cancer patients to us for financial assistance. Our website contains information on all our medical cases while our group of tele-callers work to raise funds for the treatment of these children. In addition, advertisements are placed on social media networks to increase awareness and raise funds.



## GOOD HEALTH & WELL BEING (SDG3)

The year 2021 - 2022 marks 11 years of Child Help Foundation serving the children suffering from terminal illnesses. This year, we helped 26 children suffering from Cancer. Treatment for Cancer diagnosed in childhood significantly improves their chances of survival. The Medical Social Workers (MSWs), the Hospital, and the Parent Connection with Child Help Foundation have exceptionally helped the Paediatric Cancer patients, illuminating hope in their fight against the disease.

### Referral Systems

Child Help Foundation works through referral systems which means that the Medical Professionals or Social Workers at our Partner Hospitals refer these children to us. When a child is diagnosed with cancer, parents are often shook and on top of it, they are faced with the challenging task of raising the funds for their child's expensive treatment. Our organization thus provides financial aid and emotional support in the form of counselling to the underprivileged patients.

### In the Hospitals

Child Help Foundation coordinates with the patients for good care and counselling throughout their hospital journey. We work alongside the medical partners in the Pediatric oncology wards.

### In the Community

Our support extends in the post treatment phase of the cancer surviving patients to enable their overall development. Cancer treatment also has long term side effects. We help the children by fulfilling nursing services beyond hospice care and also by supporting their education enabling them to adapt to the new normal phase of schooling.

### Follow up

After the Hospital Care, the children are given Home-Based Care. Our medical coordinators' team keeps in touch with the patient's family to monitor the child's overall progress.

### Networking with Best Hospitals or Medical Professionals

Child Help Foundation has a network of 51 hospitals across India. We connect the patients with the best doctors, nurses, and medical professionals for the most advanced technology for treatment. In addition, we are partners with the leading oncology departments.



## MEDICAL SUCCESS STORIES

### 1. Mohd. Husain



Before

Master Mohd. Husain needed heart surgery. Husain's Father, Mr. Afzal is a farmer, and his mother, Mrs. Shenaaz is a homemaker. Husain is their younger child. At the time of birth, Husain had difficulty in breathing. After a few days, his parents noticed that the baby was getting a bluish discoloration. He was taken to the doctor, and after all medical tests, he was diagnosed with Congenital Heart Disease. He was admitted to Indraprastha Apollo Hospital, New Delhi. The treatment cost was Rs. 3, 00,000/- Mr. Afzal contacted Child Help foundation, thanks to the suggestion of their relatives. After necessary verifications, Child Help Foundation assured the parents to support Mohd. Hussain. Child Help Foundation raised the required amount for Husain's surgery. The joyful smile is back on his face and his family thanks the donors and Child Help Foundation for support.

### 2. Ritvik Panchal

Ritvik is a three-year-old boy from Ghaziabad, who needed heart surgery. When Ritvik was about 1.5 years old, his mother noticed he had difficulties in breathing. She also noticed bluish discoloration in Ritvik's body. The baby had poor weight gain during that period and his health also deteriorated. They consulted a doctor at that time and found cardiac issues. The doctors at Indraprastha Apollo Hospital, New Delhi, estimated the surgery cost to be about Rs. 4,00,000/- A medical social worker advised the parents to contact Child Help Foundation for support after necessary verifications; Child Help Foundation raised the funds for the surgery. Ritvik's health is good, and he is showing good improvements. Heart defects no longer threaten the sweet boy's life.

### 3. P. Jecintha



P. Jecintha is a seven-year-old girl from Tirunelveli, Tamil Nadu, who was diagnosed with heart disease at the age of four. She is the only child of Mr. Ponraj Nadar and Mrs. Jaya Mary. Her father works in a store and her mother is a homemaker. In the year 2018, Jecintha underwent two surgeries in Mumbai. Her father used to work in Mumbai before the pandemic. But he lost his job, and the family had to travel back to their hometown. Jecintha required one more surgery as a part of her treatments. She needed heart surgery, the estimated cost of which was up to Rs. 3,50,000/- to Rs. 4,00,000/- Mr. Ponraj contacted the medical social worker in the hospital, and with the help of Child Help Foundation, the required amount for P. Jecintha's surgery was raised. She has recovered, and her health is in a better condition now.

### 4. Baby of Ushakumari



The baby of Ushakumari was born prematurely. His father works as a daily wage laborer, and his mother is a homemaker. They live in Alappuzha, Kerala. At birth, the baby had low weight and suffered from difficulty breathing. He was admitted to SBM hospital, Kerala, where the doctors said that he will need Continuous Positive Airway Pressure (CPAP) and other supportive care for his breathing difficulty. The estimated cost of his treatment was Rs.4,00,000/-. The family could not raise these funds due to low incomes.

On behalf of the family, Child Help Foundation was successful in raising the money for the baby's treatment. After the treatment, the baby was in a healthier state and was taken home by the parents. They have named him Kartik and has gained 1.8 kgs of weight.

### 5. Rudranandini



Rudranandini is a six-year-old girl from Thrissur, Kerala. Her father, Mr. Satheesh is a fisherman, and her mother is a homemaker. Rudranandini was diagnosed with neuronal ceroid lipofuscinosis type 7 (a progressive disorder that affects the brain). Since then, she suffered from a gradual loss of cognition, loss of vision and was confined to the bed. She was admitted to Aster Medicity Hospital, Kerala, where the doctors suggested Percutaneous Endoscopic Gastrostomy Surgery. The estimated cost of her treatment was Rs. 2,00,000/-. Mr. Satheesh could not afford her treatment and turned to Child Help Foundation for help. Our team managed to raise the required funds for Rudranandini's treatment. The surgery was successful and she was discharged from the hospital. She has become more responsive and is recovering well. Rudranandini can now clearly see her parents smile at her.

### 6. Kunal Barse



Kunal Barse is a 13-year-old boy from Ambegaon, Pune. Kunal's Father, Mr. Kishore Barse is a tuition teacher, and his mother, Mrs. Kavita Barse is a homemaker. Kunal's knees started to ache, and he experienced tremendous pain in his legs. When taken to the doctor, he was diagnosed with kidney disease. He had been suggested medication for the same. After two months, he was diagnosed with pneumonia and had to undergo dialysis thrice a week. His father is the only earning person in the family and was not able to bear the expenses of his son's treatment. He was admitted to Deenanath Mangeshkar Hospital, Pune for a kidney transplant, the estimated cost of which was Rs. 7, 50,000/-. Kunal's mother was his donor. As Kunal's parents did not have enough finances, their close friend suggested contacting Child help Foundation. After all the necessary verifications, Child Help Foundation helped Kunal get the much-needed treatment. He is on a path of new life.

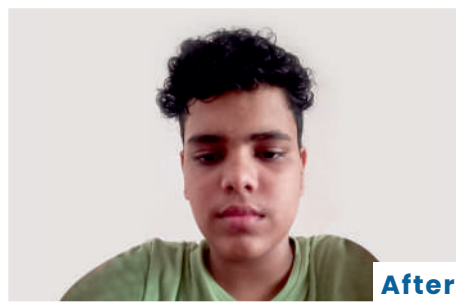

### 7. Jagan Raj

Jagan Raj is the 14-year-old son of Mr. Jagan, a Fisherman, and Mrs. Revathi, a homemaker from Kerala. Jagan's father used to work as a fiberglass fabricator but lost his job due to the pandemic. Jagan's body had multiple swelling and he was fatigued very often. Concerned about his health, his father consulted several doctors. He was diagnosed with Hodgkin's Lymphoma (a type of cancer) and was admitted to MVR Hospital, Kerala. He was suggested to undergo Salvage chemotherapy and Autologous Bone Marrow Transplant.

The estimated cost of his treatment was Rs. 10,00,000/- and Jagan's family was unable to raise money, so a Medical Social Worker contacted Child Help Foundation to help Jagan Raj. The staff of Child Help Foundation visited Jagan's Parents to do the necessary verifications. Child Help Foundation Supported Jagan by collecting the necessary amount. He has recovered and is at home safe and healthy.

### 8. Baby of Shweta Tiwari

Baby of Shweta Tiwari is a premature baby boy born in the seventh month of pregnancy. His father, Mr. Shailesh used to work in a private company and his mother, Mrs. Shweta is a homemaker. Unfortunately, Mr. Shailesh lost his job two months before the baby was born.

Mrs. Shweta started facing difficulty in the seventh month of her pregnancy, and hence she had to undergo a cesarean to deliver the baby. Her baby was born underweight (1.130kg) and had respiratory distress syndrome. He was immediately shifted to the NICU at Dr. Joshi Children's hospital, Virar. Doctors had suggested that the baby would need NICU to stay for six-eight weeks. The estimated cost of his treatment was Rs. 4, 00,000/-. The baby's father was unemployed, and hence, was not able to afford the cost of his treatment. A Medical Social Worker contacted Child Help Foundation for support, and after all the necessary verifications, the baby of Shweta was helped with his treatment. They have named the sweet boy Rudransh. He is currently at home and weighs 2kg.

### 9. Viraj Satpute



Vijay Satpute is a two-year-old boy from Pune. His father, Mr. Yogesh Satpute works at a pizza shop, and his mother Mrs. Varsha Satpute is a homemaker. He was born with a heart defect which was diagnosed only after 14 days of his birth. Since then, he had difficulty breathing. He cried continuously causing his skin to turn bluish. He was treated at the Jehangir Hospital, Pune. He needed to undergo urgent Intracardiac Repair for Tetralogy of Fallot (heart surgery). The estimated cost of his treatment was Rs. 4,50,280/-.

His father earned a very low income and hence was not able to afford the cost of his treatment. Seeing the parent worried for the child the Medical Social Worker in the Hospital contacted Child Help Foundation for help. Child Help Foundation raised funds for his surgery. Viraj's health is good, and he is showing good improvements. Heart defects no longer threaten the little boy's life.

### 10. Triplets of Sunita



The babies of Sunita were born premature (two girls, one boy). Mr. Premi, the father, works as a farmer, and their mother, Sunita, is a homemaker. Sunita had been suffering from high blood pressure since the fifth month of her pregnancy. On 14th June 2021, she was rushed to Life Care Hospital, Rohtak, as she suffered from high blood pressure and early labor. Sunita was only 32 weeks (eight months) pregnant when she delivered her triplets. The triplets were kept in the NICU to recover for three weeks. The estimated cost of the babies' treatment was Rs. 9,78,000/-. Mr. Premi, being the only earning member in the family of eight, was not able to afford the cost of his babies' treatment. This is when a Medical Social worker at the hospital approached Child Help Foundation for help. Child Help Foundation helped the triplets with their much-needed treatment. The babies are healthier and have gained weight.



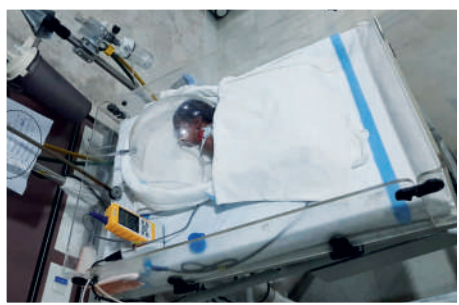

### 11. Baby of Suvarna



Baby of Savarna was born prematurely in the seventh month of pregnancy. Baby's father, Mr. Vinay Pimple, the only earning member in the family is a driver. The baby suffered from respiratory distress and was admitted to Nanavati Super Speciality Hospital, Mumbai. The doctors treating him suggested the baby be kept in NICU for four weeks and be given ventilator support with medicines. The estimated cost of the baby's treatment was Rs. 8,00,040/-. The Pimple family was not able to bear the expenses of their son's treatment. The doctor asked the parents to contact Child Help Foundation as their financial condition was very weak. The parents contacted Child Help Foundation for help, and after necessary verifications, Child Help Foundation supported the baby of Suvarna. After the treatment, the baby was in a healthier state and was taken home by the parents.

### 12. Baby of Ajitha



The baby of Ajitha was born prematurely in the eighth month of pregnancy. Her father, Mr. Udesk Kumar is a fisherman and her mother, Ajitha is a homemaker. The baby was admitted to Amrita Hospital, Kochi. The doctor treating her suggested the baby be kept in NICU for more than three weeks. She was also suggested to be given ventilator care along with medicines and nutritional supplements. The estimated cost of the baby's treatment was Rs. 2,40,000/-. Her father, being the only earning person in the family, was not able to bear the expenses of his baby's treatment. Seeing the parents worried, a Medical Social worker approached Child Help Foundation after the necessary verifications. Child Help Foundation supported the treatment of the baby by raising the required funds. The baby is home, smiling and safe in the arms of her parents.

### 13. Baby of Rekha Lokhande



The baby of Mrs. Rekha Lokhande was born prematurely in the seventh month of her pregnancy. The baby's father, Mr. Yogesh Lokhande works as a salesman in a shoe shop. She is their first born baby. She was given Ventilator Support and was taken to a NICU soon after the delivery as she had low weight. She was diagnosed with extreme prematurity, extremely low birth weight, and Respiratory Distress syndrome. Doctors had suggested that the baby would be kept in the NICU for four weeks.

The child was admitted to City Criticare Hospital Kalyan, East. The estimated cost of her treatment was Rs. 2,50,000/-. Her father earns little income and couldn't bear the expense of his child's treatment. In these distressing moments, he was looking out for financial support. Mr. Yogesh contacted Child Help Foundation for help. The treatment of the baby was supported by Child Help Foundation. The baby is now growing and enjoying fun times with Mrs. Rekha and Mr. Yogesh at home.

### 14. Twins of Amruta



Twins of Amruta (1 boy, 1 girl) were born prematurely in the seventh month of pregnancy. Their father, Mr. Digambar Mhatre is a sanitation worker in the Municipal Corporation and their mother, Amruta is a homemaker. The babies were admitted to Abhinav Hospital, Virar. The doctor treating them suggested the babies be kept in NICU for 80 days and given ventilator care. The estimated cost of the babies' treatment was Rs. 20,00,000. Their father, being the only earning person in the family, was not able to bear the expenses of their treatment. The Medical Social worker in the Hospital contacted Child Help Foundation for Help. Child Help foundation helped the twin babies by raising the required amount. After a long wait, Amruta enjoys motherhood with her twins.

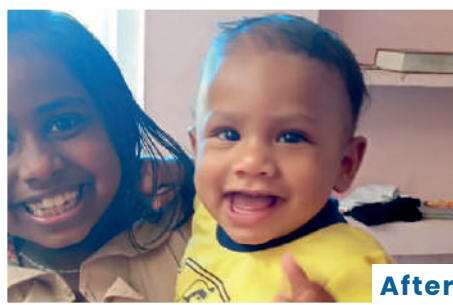

He needed plastic surgery and various other medical treatments for his recovery. The estimated cost of his treatment was Rs. 10,00,000/-. Unfortunately, his father was unable to raise these funds for their son's treatment and turned to Child Help Foundation for help. Child Help Foundation helped Jishan with his treatment by raising the required amount. This little boy can now dream and live again.

### 16. Baby of Ancy Anson

The estimated cost of treatment was Rs. 3,00,000/-.

The baby's father was unemployed due to the pandemic and could not afford the cost of treatment. Mr. Joseph contacted Child Help Foundation for support. After the necessary verifications, Child Help Foundation supported the baby by raising the required amount. The hospital has helped the baby to bring him into stable condition, and he has recovered. The baby is now growing and enjoying fun times with Mrs. Ancy and Mr. Joseph at home. They have named him Abil and he weighs 2.2kg.

The baby's father, being a fisherman does not have a proper income and hence it was becoming difficult for him to afford the treatment cost of his baby. He then contacted Child help Foundation for support. Our team raised the required funds for the baby's treatment. After a long wait, Asha enjoys motherhood with her son.

### 18. Manish Kumar

Manish is a six-year-old boy from Uttar Pradesh. His father, Mr. Tejpal works as a daily wage laborer. Manish had been suffering from a congenital heart defect. He had one unsuccessful surgery as he had begun facing the same health issues. His parents consulted several hospitals but only got disappointed as their son failed to get treated by any of them. A ray of hope fell on Manish's parents when his treatment started in Indraprastha Apollo Hospital, Delhi. Manish was suggested to undergo open-heart surgery. The estimated cost of his treatment was Rs. 4, 00,000/-. Child Help Foundation supported Manish by raising the amount required for treating his heart defect. The surgery was a success and he was discharged from the hospital soon after. He is growing up to be a healthy boy and will need regular checkups for a year to make sure he has completely recovered.

After four months, she underwent a second surgery. Dhanushkka had to undergo a third surgery for her complete recovery in the Amrita Institute of Medical Sciences and research center Hospital. The estimated cost of her surgery was Rs. 5,40,250/-. Her family approached Child Help Foundation for help. Heart defects no more threaten the sweet girl's life.

### 20. J. Sanvika



Sanvika is a two-year-old girl from Warangal, Telangana. Her father, Mr. J. Srinivas is a laborer. Sanvika frequently experienced running fevers and complained about body pain. Concerned about her health, her parents consulted a local doctor. The medical tests indicated that Sanvika was suffering from Blood Cancer. She was then shifted to Rainbow Children's Hospital, Hyderabad. The doctors suggested that she needed to undergo chemotherapy with supportive care. The estimated cost of her treatment was Rs. 10,00,000/-. Sanvika's father approached Child Help Foundation to support his baby's treatment. The amount required for Sanvika's chemotherapy and supportive care was raised. She has much more energy than before and she is on her way to recovery.

The estimated cost of his treatment was Rs. 1,40,000/-. Unfortunately, Subhadip's father who works as a farmer was unable to afford the cost of his treatment due to minimal income and had requested Child Help Foundation for assistance. Child Help Foundation helped the brave little fighter fight cancer by supporting his treatment.

### 22. Nitesh Metre

After medical tests were done, Nitesh was diagnosed with hearing difficulty and a heart disease. In 2019, he underwent heart surgery however, he continued to experience breathing issues. To treat him further, another surgery was scheduled, which cost about Rs. 1,80,000/-. His treatment was going in the Bai Jerbai Wadia Hospital, Mumbai. Being a driver with minimal income, Nitesh's father is the only breadwinner for the family. Having spent all his savings for Nitesh's earlier treatments, he was left penniless. With the help of the Medical Social Worker, the family contacted Child Help Foundation for help. Nitesh's surgery was done successfully with the support of Child Help Foundation. He is now recovering gradually.

### 23. Ritika Uppara



Baby Ritika is a one-year-old girl from Andhra Pradesh. She was born with Thoracic Scoliosis with Sprengel Shoulder. One of her shoulder blades was higher than the other, restricting the normal movements of the shoulders. Ritika was treated in the Bhagwan Mahaveer Jain Hospital, Bengaluru, Karnataka. The doctors treating her had suggested that she needed D4 to D8 pedicle screws instrumentation, B12 Facetectomy, deformity correction, and fusion with Sprengel shoulder release. The estimated cost of her treatment was Rs.3,80,000. Ritika's father, being the only earning person in the family of seven members, was not able to afford the cost of her surgery and hence contacted Child Help Foundation for support. The surgery was successful and she is on her path to recovery. She goes to the hospital for check-ups and follow-ups.

### 24. Baby of Priya



Mrs. Priya gave birth to a baby boy in Andhra Pradesh. His father, Mr. Bhanu Chenna is a farmer, and his mother, Mrs. Priya is a homemaker. This baby is their only child. The baby was born with a heart defect. His body weight was unusually low and he has been suffering from respiratory issues. Worried about their only child, his parents took him to the doctor. Through the tests, he was diagnosed with a heart defect. The child was suggested to undergo open-heart surgery and shifted to Rainbow Children's Heart Institute, Hyderabad. The estimated cost of his treatment was Rs.3, 50,000. The baby's father is the only breadwinner with minimal income. He could not afford such a huge amount. Child Help Foundation helped him raise funds for his baby's treatment. The baby is healthy and weighs 2.3 kg. They have named the little boy Navdeep.

### 25. Baby of Smitha



The baby of Smitha was born prematurely in the 29th week of her pregnancy. His father, Mr. Viswan, is a driver, and his mother, Mrs. Smitha, is a homemaker. This baby is their younger child, and he has an elder brother of 18 years. The baby was born with a low weight and required ventilator support with extensive care. The baby is now growing and enjoying fun times with Mrs. Smitha and Mr. Viswan at home.

### 26. Rajveer Kasbe



Rajveer Kasbe is a two-year-old boy from Latur. His father, Mr. Avinash Kasbe is a daily wage laborer and his mother, Mrs. Ujwala Kasbe, is a homemaker. Rajveer has an elder sister, Kartiki Kasbe (4).

Rajveer, since birth, had problems with urination. His urine would not pass properly causing him pain. The pain provoked irritation levels in the child. Concerned about his condition, the parents consulted several doctors.

At last, he was admitted to Lahane Hospital, Latur, Maharashtra, for treatment. He needs to undergo three surgeries to recover. The cost of his surgery was Rs. 1,05,000. Being a daily wage laborer, his father could not raise money for Rajveer's treatment and had sought help from Child Help Foundation for the same. Child Help Foundation successfully raised the funds for Rajveer's treatment. This little boy has recovered and his parents are happy to see their playful boy run around in the house.

### 27. Inayat Fatima

The twin babies of Sheela were born prematurely in the seventh month of pregnancy. Their father, Mr. Satish Satyawana works in a factory, and their mother, Mrs. Sheela Satyawana is a homemaker. Mr. Satish lost one of his arms while working in the factory.

After the birth, both the babies were shifted to the NICU in Neo Clinic, Jaipur, due to low birth weight and mild respiratory distress. The babies were admitted to the NICU for two months. The estimated cost of their treatment was Rs. 7,50,000/-. Child Help Foundation helped the family to raise this huge amount of money and supported the family throughout the babies' treatment. They were discharged on 11th November 2021. They are named Prahil and Pranshul and they have a healthy weight of 1.9 kg and 2 kg respectively.

Ahaan had to undergo an open heart surgery which would cost Rs.4, 00,000/- and hence contacted Child Help Foundation for help. Child Help Foundation helped Ahaan by raising the required funds for his surgery. Heart defects no longer threaten the little boy's life.

Her treatment was going on in Ashoka Medicover Hospital, Nasik. She had to undergo a fourth surgery for the fracture in her leg. The estimated cost of her treatment and surgery was Rs. 2,50,000/-. Vaishnavi's father, being the only earning person in the family, was unable to bear the expenses of his daughter's treatment. The family approached the Child Help Foundation team in need of financial help. Child Help Foundation helped Vaishnavi throughout her surgery. She has returned home safe after a successful surgery and she is recovering well.



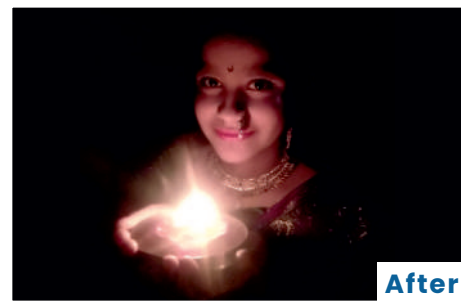

### 33. Baby of Manjula



The Baby of Manjula was born prematurely in the eighth month of pregnancy. Baby's father, Mr. Sagar works as a Driver and his mother, Manjula is a housewife. Sagar barely earns enough to support his family of four. Their baby had a low birth weight of 1.5 kgs and was suggested to be kept in the NICU for recovery. The cost of the baby's treatment was Rs. 6,96,500. The family was not able to manage the expense of their child's further treatment as all their savings had already been drained for his treatment. The baby needed further treatment for which Mr. Sagar had requested Child help Foundation for help. Child Help Foundation was able to support the family in their hard times. The baby has now recovered and weighs 1.85 kg. Mr. Sagar and Mrs. Manjula were very happy to welcome their baby home for the first time after a long wait.

### 34. Aditi Waghmare



Aditi Waghmare is a 12-year-old girl from Solapur, Maharashtra. Her father, Mr. Pramod Waghmare works as a daily wage laborer, and her mother, Mrs. Reshma Waghmare is a housewife. Aditi is the eldest child and has two younger siblings.

Aditi was born with a congenital heart defect which was not noticed by her family until she was a few days old and would not stop crying. She was given medication by the doctor but was suggested to undergo surgery for her heart defect which would cost Rs. 3,72,000/-. Aditi's father had been out of work due to the pandemic and was finding it very difficult to arrange finances for her surgery. Child Help Foundation helped them raise funds for Aditi's treatment which went successfully. Aditi was discharged from the hospital and has recovered.

### 35. Twins of Renuka

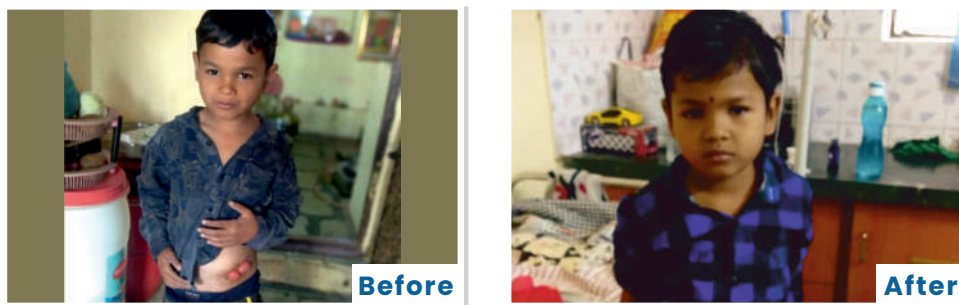


Twins of Renuka were prematurely born babies. Their Father, Mr. Prashant works as a Peon in Municipal Corporation (Mumbai), and his mother, Mrs. Renuka is a homemaker. The babies are their firstborn.

They were the Couple undergoing infertility treatment and had conceived through assisted fertility. The babies were born on 28th August 2021 in the 26th week of carrying.

The Premature babies were immediately shifted to the NICU and were given Ventilators. Their treatment went on for eight weeks and the babies were kept in NICU for their treatment. The estimated cost of her treatment was Rs. 20,00,000/- (rupees Twenty lakhs only). Child Help Foundation helped the parents raise funds for their little bundles of joy. They named the babies Ashwath and Ojaswi and they have a healthy weight of 1.9 kg and 2.1 kg respectively.

### 36. Shubham Mule



Shubham Mule is a nine-year-old boy from Beed. His father, Mr. Somnath Mule works in a printing press, and his mother, Mrs. Shukantala Mule is a homemaker. Since he was born, Shubham needed to be kept in the incubator as his body was very weak. His mother observed that his nose would bleed whenever he was being fed. He was then shifted to another hospital where he was kept under observation and had to undergo tests. Through his tests, his Anorectal Malfunction was diagnosed. Shubham had to undergo his first surgery just four days after his birth. His second surgery was done at the age of seven. He underwent his third surgery at the Kalpataru Hospital, Aurangabad. The estimated cost of this surgery was Rs. 1,00,000/-. His father had exhausted all his savings in Shubham's earlier treatment. A relative of theirs contacted Child Help foundation and we helped Shubham with his treatment and needs. He is recovering and goes to the hospital for check-ups and follow-ups.

### 37. Kunal Aher



Kunal Aher is a 10-year-old boy from Nashik. He was suffering from Progressive Bilateral Equinovarus Foot Deformity with loss of bladder control. In simpler terms, it is a congenital limb disorder or clubfoot (by birth the child's feet are inward) and a part of the spinal cord is split. He needed spinal surgery under advanced technology of spinal neuromonitoring along with Bilateral Feet Correction. He was being treated in the Ashoka Medicover Hospital, Nashik. The estimated cost of Kunal Aher's treatment and hospitalization was Rs 5,00,000/-.

His father Sudam Aher is a farmer and sole earner of the family. Ever since the Pandemic, the family had been under a huge financial crisis leaving them helpless. With the help of a Medical Social Worker his parents contacted us for help. Child Help Foundation supported the child throughout his surgery. This little boy has recovered and his parents are happy to see their playful boy run around in the house.

### 38. Mohd. Aydin



Mohd. Aydin is a four-month-old baby boy from Kannur, Kerala. He is the only son of Mr. Firos and Mrs. Ramseena. The baby's father is a driver and his mother a homemaker. The family consists of four members, and Mr. Firos is the only earning member. In September 2021, Mohd. Aydin had suffered from a severe cough. On 29th September, he suddenly experienced difficulty breathing and was immediately shifted to MIMS Hospital, Kannur. Here, his treatment kept happening for a month, but he was later shifted to Amrita Institute, Kochi, for further treatment. There, he was diagnosed with a neuromuscular disorder. He was given ventilator support for 3-6 months along with other treatments. The estimated cost of his treatment was Rs. 6,31,000/-. Aydin's father was unable to raise funds for his treatment. So the Doctor in the Hospital contacted Child Help Foundation. Child Help Foundation successfully raised the funds for Mohd. Aydin's treatment. Mr. Firos and Mrs. Ramseena were very happy to welcome their baby home for the first time after a long wait.

### 39. Noor Khan



Noor is a two-year-old daughter of Mr. Gagandeep Khan, who owns a small grocery shop, and her mother, Mrs. Sompal Kaur, is a homemaker. Noor is the youngest and has an elder brother, Alphaz Khan (8). The family hails from Punjab.

Noor was born with a heart defect which was diagnosed a few hours after her birth. The heart defect was confirmed with a series of medical tests. Doctors had advised waiting for the surgery as in some cases over time the hole in the heart gets in its normal function but nothing happened. Unfortunately, Noor kept suffering due to her heart defect. She was later admitted to Paras Hospital, Gurgaon, and had to undergo PDA device closure and Balloon Pulmonary valvuloplasty. The estimated cost of her treatment was Rs. 2,50,000/-. With a minimal income, Mr. Gagandeep could not afford his daughter's treatment. Child Help Foundation helped the family in making the surgery a success.

### 40. Sagar Jana



Sagar Jana is an 11-year-old boy from West Bengal. His father Mr. Panchanan Jana is a daily wage laborer, and his mother, Mrs. Dali Jana is a homemaker. In December 2020, Sagar started suffering from persistent vomiting. Concerned about his health, his parents consulted several doctors. After various tests, he was diagnosed with End-Stage Renal Disease, for which he was being treated at the CK Birla Hospital, Kolkata. The doctors suggested he undergo a kidney transplant. His mother Mrs. Dali was his donor. The estimated cost of his treatment was Rs. 11,78,000. Being a daily wage laborer, Mr. Panchanan was unable to bear the cost of his treatment. Sagar's father contacted Child Help Foundation for support. After the necessary Verifications, Child Help Foundation Supported Sagar's treatment by raising the amount required for a kidney transplant. He has recovered, and her health is in a better condition now.

### 41. Prathyush Giri

Prathyush Giri is a three-year-old boy from Pune. His father, Mr. Khokan Giri is a daily wage laborer and her mother, Mrs. Kavitha Giri is a housewife. Prathyush is their only son and the family consists of three members.

Prathyush was very young when his heart defect was diagnosed by a doctor during medical tests. Since then he has been under medication. He kept suffering from the time of his birth. He was treated in Care hospital, Hyderabad. He was suggested to undergo Multiple VSD closure and ASD Closure surgery. The estimated cost of his treatment was Rs. 5,00,000/-. A medical social worker advised the parents to contact Child Help Foundation for support after necessary verifications; Child Help Foundation raised the funds for the surgery. Pathyush's health is good, and he is showing good improvements. Heart defects no longer threaten the sweet boy's life.

### 42. Piyush Kamat

Piyush Kamat is a three-year-old boy from Gwalior, Madhya Pradesh. His father, Mr. Madan Kamat, a daily wage laborer, is the sole breadwinner in the family of four.

Soon after Piyush's birth, his parents noticed that he was having difficulty breathing when they heard wheezing noises from his chest. The local doctor also raised concerns and asked them to consult a specialist. The family borrowed money from their neighbors and loved ones to bear Piyush's medical test costs. He was diagnosed with Congenital Heart Disease. The doctors at Paras Hospitals, Gurgaon had suggested that he undergo open-heart surgery. The estimated cost of his treatment was Rs. 4, 50,000/-. As Piyush's parents were not able to afford the cost of the Surgery they contacted Child Help Foundation for help. Child Help Foundation supported Piyush's treatment by raising the amount required. The surgery was successful. This little boy can now dream and live again.

### 43. Baby of Bhagyashree

The baby boy of Bhagyashree was born as a premature baby. His father, Mr. Siddharth Singh, is regularly unwell and is unemployed. Mrs. Bhagyashree, the baby's mother, worked at a garment factory, as a helper. The family's only support left was the baby's maternal grandmother, who works as a domestic worker.

The patient was born with complications of a preterm baby. His body weight was minimal and he suffered from respiratory distress due to immature lungs. The little child was admitted to Queens Hospital, Thane. Dr. Talib Surve, the doctor-in-charge, had suggested a NICU stay for about 35 days. The baby continued to require oxygen support, monitoring of his vitals, daily blood check-ups, and NIV support. The entire cost being Rs. 3,00,000/-. The Medical Social worker in the Hospital contacted Child Help Foundation for Help. The required amount was raised and the baby has been named Kartiki.

### 44. Baby of Jagruti

The baby of Jagruti was born prematurely. Since her birth, she has been in the Newborn Intensive Care Unit (NICU) in Queens hospital, Thane. The baby as she was fighting for her life every day. The special care costed them Rs. 10,000/- per day. The doctors had advised them to continue the ventilator support for two months for her to recover. The estimated cost of which was Rs. 3,00,000/-. The baby was showing signs of recovery. But the family had drained all of their savings. They were unable to afford her further treatment due to the expensive daily NICU charges. Child Help Foundation supported this infant's treatment by raising the amount required for the treatment. The baby is now growing and enjoying fun times with Mrs. Jagruti and Mr. Shreyans at home. The baby girl weighs 2.4 kg and is named Kashvi.

### 45. Baby of Jijitha



The baby boy of Mrs. Jijitha A. R. was born in the seventh month of pregnancy, as a premature baby. His father, Mr. Sudeesh E. M. is a fisherman, who barely makes an earning of Rs. 4000/- per month, and her mother is a homemaker.

The baby was suffering from Respiratory Distress Syndrome and low birth weight. He also suffered from neonatal sepsis which is a type of blood infection. The doctors at Amrita Institute of Medical Sciences, Kochi, had suggested the baby be kept in the NICU for four weeks. The parents had already spent around Rs. 4,50,000/- for their baby's treatment. The child's further treatment was estimated to cost Rs. 9,00,000/-. He contacted Child Help Foundation for support. The treatment was successful and after a long wait, Jijitha is now able to enjoy motherhood with her baby.

### 46. Paras Sakate



Paras Sakate is a two-year-old boy from Pune, Maharashtra. His father Mr. Hanumant Sakate, a daily wage laborer, is the sole breadwinner in the family of four. When Paras was six months old, his parents noticed a small lump below his right ear. The lump seemed harmless at first but kept growing with time. Paras used to cry a lot but his parents were unable to understand his pain, as he could not speak. Later, when he was taken to AIMS Hospital at two years of age, he was diagnosed with a Multilocular Cystic Lesion, which is a type of slow-growing tumor. As a part of his treatment, he needed to undergo Excision of Large Hamartoma Surgery to extract the tumor. The estimated cost of the surgery was Rs. 4,35,000/-. After necessary verifications, Child Help Foundation assured support for Paras Sakate. The surgery was successful and the baby is now lively.

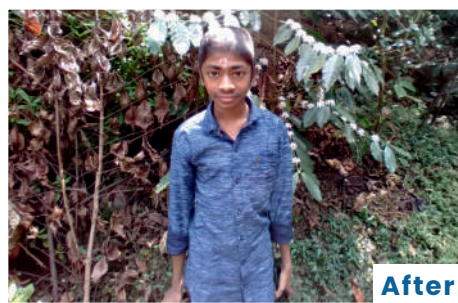
### 47. Vitthal Bhosale



Vitthal Bhosale is a 12-years-old boy, who suffered from Congenital Heart Disease (CHD). His father Mr. Karan Bhosale and mother Mrs. Sukanya Bhosale, are daily wage laborers. They manage to earn Rs. 300/day on good days. The family lives in a rented house with a monthly rent of Rs. 2,000/- in Sonpeth, Parbhani District, Maharashtra.

The doctors had detected his heart defect early and had warned the parents that it would prolong. With age, the defect worsened. As he turned 12, Vitthal's symptoms aggravated. He was taken to AIMS Hospital, Pune. The doctors there suggested he undergo an Urgent Balloon, Pulmonary, valvuloplasty Heart Procedure. The cost of his treatment was Rs. 2, 38,000/-. The team of Child Help Foundation visited Vitthal's Parents and supported Vitthal by raising the necessary amount. His surgery was successful. He has recovered and is at home safe and healthy.

### 48. Dheena Dayal



Dheena Dayal is a 13-year-old boy from Idukki, Kerala. After eight months of his birth, Dheena Dayal began to suffer from continuous vomiting. He had lost weight and experienced fatigue. He underwent medical tests and screenings after which he was diagnosed with Thalassemia Major. His treatment began at a private hospital but due to expensive medical treatments, his Bone Marrow Transplant could not be done.

On the advice of a doctor, he was then shifted to Aster Medcity, Kochi. Here, Dheena Dayal underwent a Bone Marrow Transplant. The estimated cost of his treatment was Rs. 17,00,000/-. As a farmer, his father Mr. K R Chinna Thampi could never collect this huge amount. Child Help Foundation helped the family raise funds for the treatment, and his surgery was performed successfully. Dheena's health is good, and he is showing good improvements.

### 49. Kayrab Baghel

Kayrab Baghel, a one-year-old boy lives in Gwalior, Madhya Pradesh. His father Mr. Jeetender Baghel works at a medical store and earns a petite income of Rs 6,000/- per month for the entire family. Kayrab's parents noticed that their newborn was having high fever quite often. They took him to Mangal Nursing Home, Gwalior, where Kayrab was diagnosed with Cyanotic Congenital Heart Disease.

The initial treatment fell short and Kayrab's symptoms resurfaced. His heart defect had taken a toll on his limbs. One of his legs is not able to function normally. The doctors at Paras Hospital, Gurugram suggested that Kayrab needed to undergo Open Heart Surgery. The estimated cost of the surgery was Rs 4,50,000/- (Rupees Four Lakhs Fifty Thousand only). Child Help foundation came forward and raised the amount for the surgery. His surgery was successful. He is recovering and goes to the hospital for check-ups and follow-ups.

### 50. Twins of Harbai

The twins of Mrs. Harbai and Mr. Ram Saini from Dausa, Rajasthan, suffered from symptoms of prematurity. Their father, Mr. Ram Saini works as a daily wage laborer on a contractual basis with little or no working opportunities.

The parents were facing difficulty in conceiving and had to undergo an IVF treatment. Their expenses had forced them to sell their only piece of farming land that they owned.

The premature babies were admitted to the Neo Clinic Hospital, Jaipur. They suffered from extremely low birth weight and respiratory syndrome, for which they needed to undergo a NICU stay for a few months. The estimated cost of their treatment was Rs.7,50,000/- (Rupees Seven Lakhs Fifty Thousand only). Child Help Foundation raised the requirements and the babies were discharged from the hospital soon. The Saini couple has named their babies Yashvant and Yashraj. The babies now weigh 2.1 kg and 2.50 kg respectively.

### 51. Baby of Darshana Patil



The baby of Mrs. Darshana Patil and Mr. Mangesh Patil, is a baby girl from Thane, Maharashtra. The baby's father is a fisherman, with a monthly income of only Rs. 5,000/-.

The baby was born preterm and suffers from extremely low birth weight, RDS, Neonatal sepsis, and IntraCranial Bleeding. She was also suffering from Neonatal jaundice which was cured by medication. The baby was admitted to Dr. Bedekar Hospital for Women and Children, Thane. The doctors had advised the parents to keep their daughter in the NICU for a couple of months. The estimated cost of the baby's treatment was Rs. 5,00,000/-.

He then visited Child Help foundation with his concern. Child help Foundation helped Mr. Mangesh by raising the required amount. They have named her Vaidehi who is now at home safe and healthy with her parents.

### 52. Aneek Chowdhury



Aneek Chowdhury is a 13-year-old boy from Kolkata, West Bengal. He is the only son of Mr. Debabrata Chowdhury, a helper at a private office, and Mrs. Kajuri Chowdhury, a homemaker. In 2019, Aneek was diagnosed with Ewing Sarcoma (Bone Cancer), for which he was treated with Chemotherapy. He also underwent Internal Right Hemipelvectomy, due to which his pelvis girdle was removed. He was later diagnosed with Cholelithiasis (Cancer in the Gallbladder). The doctors at Apollo Hospital, Kolkata had suggested Laparoscopic cholecystectomy (Removal of Gallbladder). The estimated cost of the surgery was Rs. 1,58,000/-. The social worker from the hospital contacted Child Help Foundation. After talking to the doctor, Child Help Foundation team raised funds and supported Aneek. He was discharged from the hospital post his surgery and is now recovering from his condition.

### 53. Tanu Bhosale

Tanu Bhosale, a four-year-old girl was suffering from Liposarcoma AV Malformation. Her father, Mr. Gorakhanath Bhosale, and mother, Mrs. Radhika Bhosale work as daily wage farm laborers.

When Tanu was three-years-old, her parents noticed an unusual swelling on the right side of her face. Tanu couldn't eat well as it caused her immense pain to swallow. After several checkups at a local hospital at Sangli, it was discovered that Tanu was diagnosed with Liposarcoma AV Malformation (Tumor in soft tissue). The doctors suggested an Excision of Soft Tissue, Mass on the Face and Neck, and Aggressive Postoperative Medical Management Surgery. Tanu was shifted to AiMS Hospital, Pune for the treatment. The estimated cost was Rs. 2,52,000/-. Child Help Foundation supported Tanu by raising the required finances for her treatment. She was discharged from the hospital after the surgery and is on her path to recovery.

### 54. Swaraj Rathod

Swaraj Rathod is from Osmanabad, Maharashtra. His father, Mr. Avinash Rathod is a daily wage laborer. He earns about Rs. 200/- per day.

A week after Swaraj's birth, his parents got worried because their baby was continuously crying. The doctors asked them to get some tests done and found a hole in his heart. He was diagnosed with VSD with Sub Infundibular Pulmonary Stenosis. The baby was referred to the Balaji Heart Hospital, Mumbai.

Swaraj needed to undergo Intracardiac Repair of VSD with Sub Infundibular Pulmonary Stenosis as a part of his treatment. The estimated cost was Rs. 3,30,000/-. Swaraj's parents could not afford such a huge amount so Child Help Foundation helped them to raise the necessary funds for their son. Currently, Swaraj is at home and is showing signs of recovery.

### 55. Baby of Payal Chavan



The baby of Mrs. Payal Chavan is from Jategaon, Maharashtra. The entire family works as daily laborers on sugarcane farms.

During the sixth month of pregnancy, Mrs. Payal started suffering from severe pains. When taken to the doctor, an emergency C-section was performed and the baby was born with symptoms of prematurity - low birth weight, respiratory distress syndrome, hyaline membrane disease, and Apnea of Prematurity. The doctors at Yashoda Children's Hospital, Beed, suggested that the baby needs to be kept under NICU treatment for a few months. The estimated cost of which was Rs. 1,42,000/-. Since the family could not afford the treatment, Child Help Foundation raised funds for their baby. The child has now recovered completely and has gained 1.9kgs weight.

### 56. Mohd. Vahil



Mohd. Vahil is an eight-year-old boy from Ernakulam, Kerala. His mother, Jaseela is a homemaker. Vahil's father left them when he was very young and is living separately. The expenses of the family are looked after by Vahil's Stepfather. He is their only son.

During the time of birth, Vahil suffered from breathing issues and was treated for the same. At the age of two, Vahil suffered from a high fever. While treating his fever, doctors observed that he had weak kidneys. Since then he has been treated for his kidneys. Vahil had already undergone surgery, but he had still not recovered. He experienced occasional dribbling of urine.

He was treated at Lakeshore Hospital, Kochi for Hydroureteronephrosis. The estimated cost of his surgery was Rs. 4,00,000/-. The stepfather's minimal income wasn't sufficient enough to bear the expense of his child's treatment and sought support from Child Help Foundation. Mohd. Vahil was discharged and was taken home by his parents post surgery. He is a healthy boy now.

### 57. Saras Khare

Saras Khare, a five-year-old who lives in Konch, Uttar Pradesh, suffered from Complex Congenital Heart Disease. His father, Mr. Narendra Kumar is a farmer and earns Rs 5,000/- per month.

When Saras was one, his family noticed that his body developed bluish discoloration. He could not eat well as he vomited most of the food consumed. After a few check-ups at Birla Hospital, Gwalior, Madhya Pradesh it was discovered that Saras's heart is on the right side instead of the left and has nerve blockages. His family took him to Paras Hospital, Gurugram, and Haryana for better treatment. The cost of his open heart surgery was Rs. 4,50,000/-. The team of Child Help Foundation visited Saras's Parents to do the necessary verifications. Child Help Foundation Supported Saras by collecting the necessary amount. His heart surgery was successful. He has recovered and is at home safe and healthy.

### 58. Vihansh Butti



Vihansh Butti is just four-years-old, but since January 2022, this little boy has been tormented by severe disorders. He started suffering from high fevers, loose stools, and dark-colored decreased urine output.

The doctors at Star Hospital, Telangana discovered that Vihansh was suffering from Kidney Failure and AIHA (a rare type of anemia). He was admitted and treated at the same hospital initially, but was later shifted to Rainbow Children's Hospital, Hyderabad. To add to his despair, after being on ventilator support for one week, he suffered a cardiac arrest and his brain was partially damaged. The doctors suggested Dialysis and continued ventilator support for his survival.

The estimated cost for his treatment was Rs. 8,00,000/- (Rupees Eight Lakhs Only). This treatment was the only chance for Vihansh to survive. Child Help Foundation helped raise funds for Vihansh and his surgery was a success. He now goes to the hospital for his routine follow-ups and check-ups.

### 59. Giridhar V

Giridhar V. is an 11-year-old boy from Bengaluru, Karnataka. His father, Mr. S. Vijaykumar, works as a laborer who gets paid on a contractual basis.

Giridhar was fighting the battles life had been throwing at him since the tender age of six. He was suffering from painful symptoms which unfortunately went neglected by his parents as common injuries. Later, when he turned 10, Giridhar was diagnosed with Cervico Dorsal Scoliosis which is an unusual but potentially severe disfiguring cause of the spinal deformity. His parents took him to the Department of Spine Surgery at Bhagwan Mahaveer Jain Hospital, Bengaluru, Karnataka. The doctors suggested urgent surgery to save him. The estimated cost was Rs. 4,50,000/-. After necessary verifications, Child Help Foundation raised funds for Giridhar's surgery and the surgery was performed on time.

### 60. Twins of Lila Devi

The twins of Lila Devi were born prematurely after she faced blood pressure fluctuations. The twins were born with extreme symptoms of prematurity- low birth weight, respiratory failure, and neonatal jaundice (NNJ- a condition in newborns). Because of their fragile condition, they were taken to the Neo Clinic, Jaipur. The babies were on ventilator support and needed continued NICU support for a few weeks. The estimated cost for which was Rs. 6,00,000/-.

The father (Mr. Rupachand) and the mother worked as daily wage laborers and collectively earn a mere income of Rs. 7,000/- per month. Out of this very little amount, Rs. 2,000/- are spent for their monthly house rent. With negligible savings and no relatives to help, they were unable to afford the treatment for the babies. Child Help Foundation team raised funds after talking to the doctors and supported the twins throughout the treatment. At present, the baby brothers are healthy and safe at home and have gained weight.

### 61. Sanskar Bhaganagare



Sanskar Bhaganagare, a five-year-old boy, suffered from complicated heart diseases including Congenital Heart Disease (CHD), Shwachman-Diamond syndrome (SDS), Severe Valvar Pulmonary Stenosis, and Tricuspid regurgitation. Since birth, he has been visiting the hospital, making his childhood difficult and distressing. Like any normal child, Sanskar could neither go to school nor play outside, as even a little bit of exertion could worsen his health.

The doctors at AIMS Hospital and Research Centre, Pune, had suggested an Urgent Balloon Pulmonary Valvuloplasty Heart Procedure. This surgery required a huge amount of Rs. 2,58,000/- (Rupees Two Lakhs and Fifty-Eight Thousand Only).

Sanskar's father (Mr. Pradeep) was trying to make ends meet with his very little income of Rs. 5500/- per month. Child Help Foundation assured the parents and helped them raise funds. Sanskar was discharged from the hospital and is on a path to a healthy life.

### 62. Ayush Kumar



Three-year-old Ayush Kumar is the elder child of Mr. Sanjit Ray and Mrs. Fulkumari Devi. Mr. Sanjit works as a daily wage laborer and earns a monthly income of Rs. 7,500/-.

Ayush suffered from a complicated Adult Congenital Heart Disease (ACHD), Pink tetralogy of Fallot (PTOF), Large PM ventricular septal defect (VSD), Severe Infundibular PS (DCRV), Confluent and fair-sized branch PAs. When Ayush was born, his health was fragile as he was constantly running fevers. The doctors suggested the parents take him to Mahavir Heart Hospital, Patna. The suggested surgery for his treatment was an intracardiac repair (ICR) along with an atrial septal defect (ASD) closure. The estimated cost of his treatment was Rs. 2,30,691/- (Rupees Two Lakhs Thirty Thousand Six Hundred Ninety-One Only). Mr. Sanjit Ray was in a dilemma of how to raise this big sum of money. He had turned to Child Help Foundation for support. After necessary verifications, Child Help Foundation raised the required amount for Ayush's heart surgery. He is currently at home and has recovered completely.

### 63. Rashod Ali

Rashod is a two-year-old boy from Howrah, West Bengal. Mr. Asman Ali (father) works as a laborer and his mother Mrs. Rijiya Khatun is a housewife.

Rashod started losing weight and got frequent fevers. Concerned about his health, his parents consulted several doctors for his recovery but to their dismay, he did not show any recovery. Hence the doctor advised his father to shift him to St. John's Medical College, Bangalore.

Rashod's father consulted a doctor from St. John's Medical College for treatment. After the medical tests were done, he was diagnosed with acute Lymphoblastic Leukemia. He was suggested to undergo Chemotherapy as a part of his treatment.

The cost of Rashod's treatment was Rs. 11,50,000/-.

### 64. Nashra Shaikh



Nashra is a 10-year-old girl from Nandurbar, studying in Class 3. Nashua is the eldest among her twin sisters, Zulera and Mariyam.

At the age of three months, Nashra suffered from high fever, cold, and cough. Her body started turning yellowish. When her blood reports indicated drastically lower levels of Hemoglobin, she was advised to take other medical tests. Her test reports showed that Nashra was suffering from thalassemia Major. Since then she needed a blood transfusion every month. Nashra was treated at Kokilaben Dhirubhai Ambani Hospital, Mumbai. She needed an urgent Bone marrow transplant. The estimated cost of her treatment was Rs. 10,50,000/-. Mariyam, Nashra's younger sister, was her bone marrow donor. After talking to the doctors and MSW, Child Help Foundation team raised funds and supported Nashra throughout the surgery. She was discharged from the hospital post treatment. She goes to the hospital for routine check-ups.

### 65. Rahul Banoth

Rahul Banoth is a 10-year-old boy from Marredpally, Telangana. He is the son of Mr. Babu Banoth and Mrs. Padma Banoth. Mr. Babu worked as a cable technician with a monthly salary of Rs. 15,000/-. He has been unemployed since the COVID-19 Pandemic.

In 2018, Rahul began suffering from severe joint pain, and he kept running high fevers. Concerned, his parents took him to a local doctor. And he was diagnosed with B-Cell Acute Lymphoblastic Leukemia. After four rounds of chemotherapy, at Rainbow Children's Hospital, Hyderabad, his symptoms had subsided.

Amidst the festivities of Ganesh Chaturthi in 2021, his symptoms resurfaced. The doctor treating him suggested three more rounds of chemotherapy along with an urgent Bone Marrow Transplant (BMT). The estimated cost of the entire treatment was Rs. 14,00,000/-. Child Help Foundation helped the family raise funds. Rahul has recovered and is now at home safe and healthy.

### 66. Khadija Khanam Khan

Khadija Khanam Khan is a five-year-old girl from Dhule, Maharashtra. Her father Mr. Mujaid Khan is the sole breadwinner in the family of five.

Khadija was 3.5 years old when her parents noticed a swelling in her stomach. She could not pass urine at all for many days. When taken to the local doctor, she was diagnosed with Thalassemia Major along with Hypersplenism. Her spleen was abnormally enlarged, and her body could not detoxify itself.

Mr. Mujaid's family friend advised her father to visit Ashoka Medicover Hospital, Nashik, where her Splenectomy took place. The estimated cost of her surgery was Rs. 2,25,000/-. Khadija's father was unable to raise this huge amount and reached out for help. After necessary verifications, Child Help Foundation team raised funds for the same. The surgery was successful and Khadija was discharged from the hospital.

### 67. Twins of Remani

The twin baby girls of Remani are from Idukki, Kerala. Mrs. Remani N. is a homemaker, and her husband, Mr. Prasad N. is a farmer. He earns a minimal income of Rs 3,000/- per month.

Mrs. Remani was suffering from Blood Pressure fluctuations during the seventh month of her pregnancy. She was rushed to Lourdes Hospital, Kochi, where she gave birth to two preterm baby girls. The twins suffered from symptoms of prematurity including an extremely low birth weight of merely 710 grams and 630 grams respectively.

The doctors had advised to keep the babies in the NICU with ventilator support and continue the treatment for the next few months. The estimated cost was Rs 5,00,000/-. Prasad's income was not enough to fund the treatment. Child Help Foundation raised funds and extended support for the treatment. Finally, Mrs. Remani is enjoying motherhood with her twin baby girls.

### 68. Shreya

Shreya is a nine-year-old girl from Guttahalli, Bengaluru, Karnataka. Her Father, Mr. Nagesh is an auto driver, and her mother, Mrs. Bhavya is a housewife. During lockdown, Shreya was facing difficulty lifting her left leg. This was when she was taken to the hospital. After the medical tests and examination, she was diagnosed with Proximal Dorsal Scoliosis and Springel shoulder. This means that she had a curved spine and an uneven shoulder which restricts her movements.

Her treatment was going on in Bhagwan Mahaveer Jain Hospital, Bangalore. The estimated cost for bilateral posterior Instrumentation and deformity correction surgery was Rs. 2,80,000/-. Mr. Nagesh (father) contacted Child Help Foundation for financial help. The Child Help Foundation team raised the required funds for Shreya's surgery. After a successful surgery she is at home and is on the path to recovery.

### 69. Titli Mondal

Titli Mondal, an eight-year-old girl from Kolkata, West Bengal, was diagnosed with cancer about six months ago. She is the birth daughter of Late Mr. Sufal Mondal and Mrs. Bulti Mondal. Mr. Prasunath, her stepfather has been looking after Titli and her sister, Soumili, who is 14, since their father's death. Mr. Prasunath works in a glass shop with a minimum salary of Rs. 7,000/- per month, and Mrs. Bulti is a homemaker. Out of Rs. 7,000 earned, Rs. 3,000 goes towards their house rent.

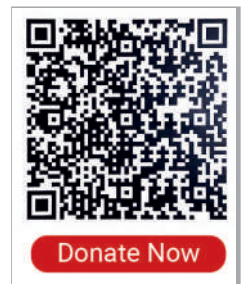
About six months before her diagnosis, Titli started feeling a sharp pain in her right leg, which led to swelling and caused her massive discomfort. After being taken to the hospital, she was diagnosed with Cancer. Titli underwent regular chemotherapy sessions at Tata Memorial Hospital, Kolkata. She underwent chemotherapy every 14-15 days, the cost for which was around Rs. 10,00,000/-. The family had to borrow from several friends and relatives to meet these high treatment expenses. They were forced to sell their gold and other belongings for their daughter's treatment.

Titli's family took her to Medica Superspecialty Hospital, Kolkata, for her further treatment. After test results, the doctors found a tumor in the bone on her right knee. To get better, she needs to undergo surgery to extract the tumor. The estimated cost of the surgery was Rs. 5,75,000/-. Child Help Foundation helped the family to raise this huge amount of money and Titli's surgery was performed successfully. Cancer can no longer threaten this sweet angel's life. She has won the battle against cancer.

### 1. Amerah Efra Denson

Amerah Efra Denson is the nine-month-old baby girl of Mr. Denson George and Mrs. Anju Joy. The baby's father is a fisherman with a monthly income of only Rs. 3,500/-. Her mother is a homemaker. Amerah has a three-year-old elder sister Grace Maria Denson. The family of four lives in a rented house in Thiruvananthapuram, Kerala.

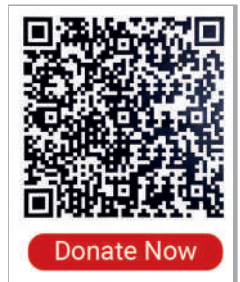
Amerah was born with a Neural Tube Defect involving lumbar Meningomyelocele type 2 Arnold Chiari Malformation and urinary problems in Sree Avittam Thirunal Hospital, Thiruvananthapuram, Kerala. Normally the cerebrospinal fluid protects the brain, and the spinal cord is present in the tissues of the spine. Meningocele occurs when a fluid sac pushes through the gap between the vertebrae. Chiari malformation causes the brain tissue to extend into the spinal canal. Due to this disorder, when Amerah was born, her legs were numb, and she could not move her legs as a healthy newborn would. She has already undergone two surgeries for the repair of meningocele and ventriculoperitoneal shunting.

Amerah is undergoing physiotherapy for motor development and intermittent catheterization for urinary problems in the KIMS Health Hospital, Thiruvananthapuram, Kerala. Physiotherapy is helping her to move her right leg. However, this is not enough. To recover and move like a normal baby, she needs to continue physiotherapy for another two years. The estimated cost is Rs. 2,00,000/-. The family approached Child Help Foundation for help.

### 2. Twin of Neeta Changlani



Twin baby girls of Neeta Changlani are 26-days old premature babies born in Jaipur, Rajasthan. Their father Mr. Nitin Changlani works as a salesman in a local shop and earns Rs. 8,000/- per month and their mother Mrs. Neeta is a homemaker. Nitin's father and mother live with them in a rented house which costs them Rs. 3,500/- per month.

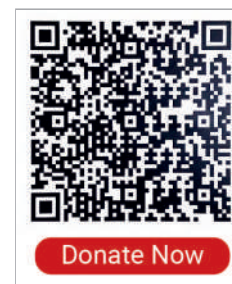
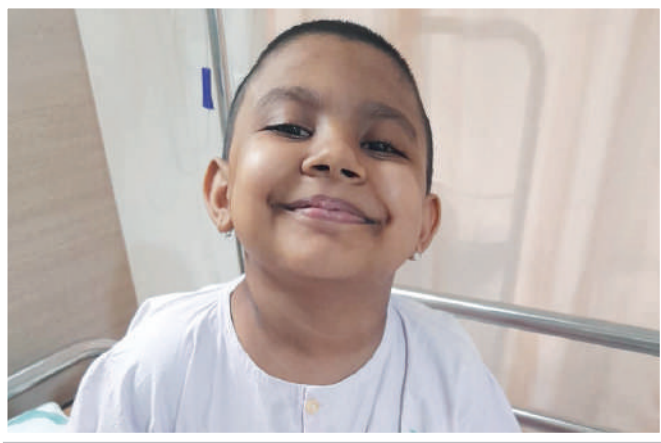
During the sixth month of pregnancy, Neeta was suffering from blood pressure fluctuations. She was rushed to Rohit Hospital in Ajmer. Prolonged pregnancy was a danger to the twins' and mother's lives, and hence, Neeta had to undergo an immediate C-section delivery. The twin girls were born with extremely low birth weight and suffer from other symptoms of prematurity.

The doctors at Rohit Hospital had advised keeping the twins under NICU treatment for the next couple of months. The twins were shifted to Neo Clinic, Jaipur for NICU stay. The estimated cost of their treatment is Rs. 13,00,000/- (Rupees Thirteen Lakhs Only). Nitin and Neeta need help as they cannot afford such a huge amount. They contacted Child Help Foundation for supporting their baby girls' treatment.

### 3. Ritanya De Sarkar



Ritanya De Sarkar is a 7-year-old girl from Kolkata. Her father, Mr. Sayanta De Sarkar used to work as a caterer with a meager income. Her mother, Mrs. Paramita De Sarkar is a homemaker. Ritanya has a younger brother, Reyaansh, who is 4-years-old. The family is currently living in a rented room in Chennai, Tamil Nadu, near Ritanya's hospital. The rent is Rs. 4,000/- per month.

Ritanya started showing symptoms in September 2021, wherein she would be having frequent fevers, headaches, muscle aches, and stomach pain. The family took her to the nearest local doctor, who suspected an appendix and did a CT scan. However, he failed to diagnose Ritanya's case and suggested the family visit the Tata Memorial Hospital, Kolkata. After several blood tests, Ritanya was diagnosed with Blood Cancer.

The doctors at the Tata Memorial Hospital recommended she go to Chennai's Christian Medical College (CMC) for further treatment. At CMC, Ritanya's treatment began with chemotherapy which will go on for six months. The doctors have advised a Haploidentical stem cell transplant. The cost of this treatment is estimated to be Rs. 25,00,000/-.

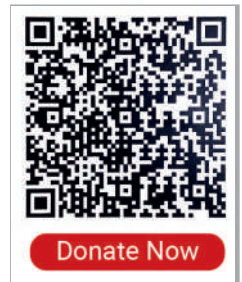
Ritanya's father is out of work and has sought help from Child Help Foundation to pay his daughter's medical bills.

### 4. Andriya Sanil



Andriya Sanil is a 9-month-old baby girl from Ernakulam, Kerala. Her father Mr. Sanil Varghese works as a daily wage laborer with an annual income of Rs. 30,000/- only. He is the only breadwinner in the family of seven. The baby's mother Mrs. Joby Paul is a homemaker. The couple has an elder son, Albert (2.5 years), and a set of triplets- Alchya, Anliya, and Andriya.

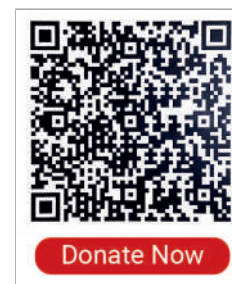
When Andriya was three-months-old, her parents noticed that her head was growing abnormally. It grew in an elongated shape. Worried, the parents took her to Kottayam Medical college hospital, Gandhi Nagar, Kerala. After several tests, it was found that Andriya is suffering from Multi Sutural Craniosynostosis. This congenital condition causes the head of the infant to stop growing in some areas as it would grow healthily and expand abnormally in other areas.

Andriya's parents took her to Amrita Institute of Medical Sciences and Research Center, Kochi, Kerala, for better treatment. The doctors at the hospital advised that Andriya should undergo Craniofacial surgery (correction for craniosynostosis). The estimated cost of the surgery is Rs. 2,05,000/-. With time, medical expenses have drained all the savings of Andriya's family. They have approached Child Help Foundation for support.



## ONGOING MEDICAL CASES

### 5. Dimpal Kumari



Dimpal Kumari, a four-year-old, is the elder daughter of Mr. Mangal Thakur and Mrs. Rani Kumari. The family consists of five members, including Dimpal's grandmother and her younger brother Rishabh, who is two. They live in Muzaffarpur, Bihar. Dimpal's father is the only breadwinner and earns only Rs. 7,000/- per month.

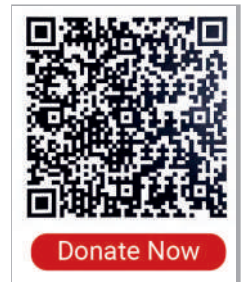
When Dimpal was around 3.5-years-old, she constantly suffered from respiratory issues, wherein she was unable to breathe properly, wheezed, and coughed while breathing. Her parents were worried about this and took her to a local doctor. The doctor indicated that Dimpal could be having a heart problem. Later, she was taken to the Mahavir Heart Hospital, Patna.

Several medical test reports diagnosed Dimpal with Adult Congenital Heart Disease (ACHD), Trivial Aortic regurgitation (AR), and Dilated left atrium and left ventricle. The doctors suggested she undergo a PDA Device Closure. The estimated cost of this procedure is Rs. 1,20,000/-. The parents have contacted Child Help Foundation for supporting their baby girls' treatment.

### 6. Omakar Mohite



10-year-old, Omakar Mohite lives in Osmanabad, Maharashtra. His father Mr. Ram Mohite, and mother, Mrs. Vaishali Mohite work as daily wage laborers, and they both earn a minimum income of Rs. 500/- collectively per day. The family consists of seven members- Omakar, his parents, three sisters, and his grandmother.

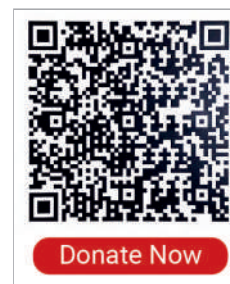
Two years ago, when Omakar was coming back from school, his sister noticed that his eyes were swollen and red, and his tongue and nails were discolored. The family rushed him to a nearby hospital. After a few check-ups, Omakar was diagnosed with Tricuspid atresia with severe pulmonary stenosis perimembranous VSD with large ASD. In simpler terms, a portion of his heart is undeveloped, resulting in respiratory issues.

Omakar's parents shifted him to Balaji Heart Hospital and Diagnostic Centre, Solapur, for better treatment. The doctors suggested that Omakar needs to undergo Bidirectional Glenn (BDG) Shunt, a surgery to improve blood oxygenation for patients with a congenital cardiac defect. The estimated cost of the surgery is Rs. 3,30,000/-. For a family who lives in a remote village, and earns very little to meet their basic requirements, the expense is enormous. They have contacted Child Help Foundation to support them in their difficult time.

### 7. Twins of Farsana



The twins of Farsana suffer from extreme prematurity as they were born in the sixth month of pregnancy (26 weeks). A month before the twins were born, their father, Mr. Mohammed Sajeer, went to the Gulf, in search of a job. However, he is unable to find a way of earning to date. The family hails from Malappuram, Kerala.

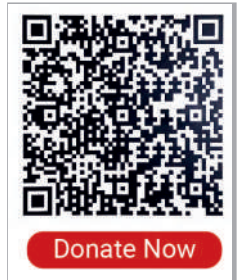
The twins, a boy, and a girl suffered from various conditions like Respiratory Distress Syndrome, Bronchopulmonary Dysplasia. Additionally, one of them suffers from Grace IV IntraVentricular Hemorrhage on the right side, and the other one suffers from Bilateral Grace II germinal matrix hemorrhage. Their treatment is being carried out at Iqraa Hospital, Kozhikode, Kerala.

The doctors have suggested treatment including CPAP IV antibiotics and supportive medications for one baby, and HFNC O2 and supportive medications for the other. The babies are currently in NICU and require a month-long stay to get better. The estimated cost of the treatment is Rs. 4,00,000/-. Farsana is unable to afford the treatment and has sought help from Child Help Foundation to pay her daughters' medical bills.

### 8. Harshita



Harshita is a five-month-old baby girl from Gurugram, Haryana. Her father, Mr. Mahesh Kumar works as an autorickshaw driver and earns around Rs. 5,000/- to Rs. 7,000/- per month. Harshita's mother is a homemaker, and her brother Naksh is seven and studies in the second grade. The family of five lives in Farrukhnagar, Gurugram, Haryana. Harshita's grandmother also lives with them.

When Harshita was some weeks old, she caught a cold and suffered from a high fever. Whenever she cried, her face developed a bluish discoloration. The local doctor advised the family to get her heart checked. The medical tests left her parents shocked. It was discovered that there is a hole in her heart. The baby's parents took her to Paras Hospital, Gurugram for further treatment.

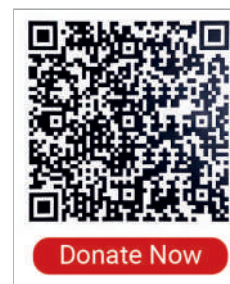
The doctors at Paras Hospital have suggested that Harshita needs an Open Heart Surgery for VSD Patch Closure. The estimated cost of this is Rs. 5,00,000/- (Rupees Five Lakhs Only).

With no savings and any help, Harshita's father is left in distress. He has turned to Child Help Foundation for support.

### 9. Samiksha Lachake



Samiksha Lachake, a 13-year-old, is suffering from Thalassemia Major. Her father, Mr. Vijay Lachake is a farmer and earns an annual income of Rs. 55,000/-. Her mother, Mrs. Jaya Lachake is a homemaker, and her brother Jay is 12. The family lives in Nashik, Maharashtra.

When Samiksha was seven, she ran fevers frequently and suffered from skin issues. Worried, her parents took her to a local hospital in Nashik. After a few tests, it was discovered that Samiksha is diagnosed with Thalassemia Major.

Since her body cannot make blood by itself, she requires a blood transfusion every 15 days. Samiksha's blood transfusions have been feasible for all of these years because of a generous blood bank that has assisted her with her monthly blood infusions.

After a few years, Samiksha's symptoms worsened, and she was shifted to Kokilaben Dhirubhai Ambani Hospital, Mumbai, for advanced treatment.

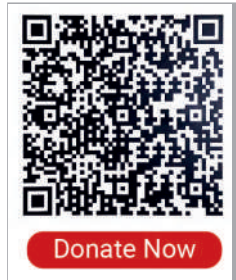
The doctors suggested that she needs a Bone Marrow Transplant. The estimated cost of which is Rs. 10,50,000/-. Her brother Jay is her donor.

Being from a weaker financial background, the Lachake family is not able to gather this huge amount. They need support. They have contacted Child Help Foundation to help them in their difficult times.



## ONGOING MEDICAL CASES

### 10. Baby of Jency



Mrs. Jency gave birth to two preterm baby girls – Catherine and Caroline. The twins were one-month-old when they were admitted to the hospital, as they suffered from extreme prematurity being born in the sixth month of pregnancy.

Baby Catherine has an abnormally large kidney, causing multiple health issues. She requires a NICU stay and is on ventilator support. She is currently being treated at Lisie Hospital, Kerala. The doctors have suggested HHFNC and IV antibiotics for onset sepsis along with continued NICU support for treating her prematurity and low birth weight. The estimated cost of this is Rs. 5,00,000/-.

Baby Caroline suffered from an intraventricular hemorrhage with mild hydrocephalus, which means that there was a clot in her brain. Unfortunately, despite all the efforts by the doctors, baby Caroline passed away due to her blood infection.

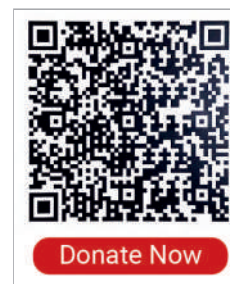
The twins' father Mr. Sanjo is food-delivery personnel who earns a daily income of Rs. 350/- only. Their mother used to work as a nurse but left her job during her pregnancy. The couple is already in debt as they have borrowed a huge amount of money from their relatives and friends. The couple and their now only baby live in a rented house in Ernakulam and have to pay a monthly rent of Rs. 7,500/-.

Having already lost a child, the parents need help and prayers to bring their baby Catherine back home. They have turned to Child Help Foundation for support.

### 11. Sajiya Ismail Nalband



Sajiya Ismail Nalband, a 15-year-old is suffering from Swelling over the Mandibular region, Heterogeneous enhancement (a cyst formation on face tissues), and Hemangioma (vascular tumor). Her father, Mr. Ismail Nalband, and mother, Tanzila Nalband work as laborers and collectively earn up to Rs. 500/- as and when they get work. Sajiya has three younger siblings and grandparents. The family of eight lives in Satara, Maharashtra in a rented house. They pay a rent of Rs.1200/- per month.

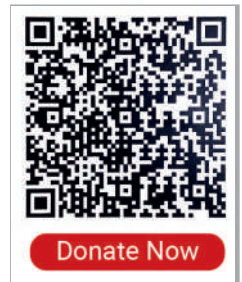
A couple of months ago, Sajiya was suffering from frequent fevers and swelling started developing on her face. Worried, her parents took her to a local hospital. After a few check-ups, she was diagnosed with Hemangioma and mandible swelling. The doctors there suggested that she undergo an urgent Excision of soft tissue, Injection Sclerotherapy for Varicose veins, and post-operative Medical Management. She has been shifted to AIMS, Pune, Maharashtra for the surgery. The estimated cost of which is Rs. 2,52,000/-. The family is extremely distressed as Sajiya is suffering from such a fatal condition. The family approached Child Help Foundation for help.





## ONGOING MEDICAL CASES

### 12. Hemavathi



Three-year-old Hemavathi is the younger child of Mr. Shreenivas, a tailor, and Mrs. Renuka, a homemaker. Hemavathi's elder brother Lakshman is five. The family of four lives in Shorapur Taluka, Yadgir District, Karnataka.

Baby Hemavathi suffers from Dorsal Lumbar Kyphoscoliosis. In simpler terms, Kyphoscoliosis is an abnormal curve of the spine on two planes: the coronal plane, or side to side, and the sagittal plane, or back to front. Since Hemavathi was six months old, her parents noticed that she was not growing like a normal baby. She was frail and her body lacked many essential vitamins. Her parents took her to a local doctor, who suggested that the baby requires advanced treatment.

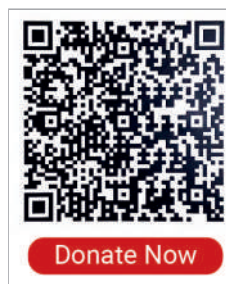
The family then took her to the Department of Spine Surgery at Bhagwan Mahaveer Jain Hospital, Bengaluru, Karnataka. Here, the doctors have suggested that Hemavathi needs Posterior instrumentation with growth rod application. The estimated cost of this treatment is Rs. 3,50,000/- (Rupees Three Lakhs Fifty Thousand Only).

Mr. Shreenivas is the sole breadwinner who only earns Rs. 8,000/- per month. He is left afraid of this unsettling financial need. He turned to Child Help Foundation for financial support.

### 13. Aradhaya Lokhande



Aradhaya Lokhande is a four-year-old girl suffering from Bilateral Retinoblastoma. Her father, Mr. Samadhan Lokhande is the only breadwinner of the family and earns up to Rs. 200/- per day. Aradhaya, along with her mother, younger sister, and father lives in Pune, Maharashtra.

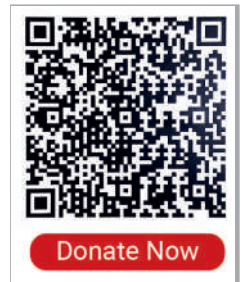
When Aradhaya was six months old, her left pupil started to look white and she suffered from constant severe colds and coughs. Worried, her parents took her to a local hospital. A CT scan discovered that Aradhaya is suffering from Bilateral Retinoblastoma. It is a tumor of the eyes. Aradhaya and her mother used to travel to Coimbatore at SRI Ramakrishna Hospital for better treatment, as she was suggested 6 cycles of chemotherapy. For a couple of years, the chemotherapy showed good results but during the lockdown, they couldn't travel to Coimbatore. This worsened her condition and the doctors suggested an eye removal surgery.

It was detected that Aradhaya's right eye has a tumor too and another 6 cycles of chemotherapy are suggested along with a Bone scan and Radiotherapy to treat cancer. The estimated cost of the treatment is Rs 1,54,000/-. Aradhaya's mother used to work as a housekeeping staff in a local hospital in Pune but was fired as she took frequent leaves to take care of her daughter. With time, medical expenses have drained their savings and they need help to afford their daughter's treatment. The family has approached Child Help Foundation for help.

### 14. Arun Kamboj



Arun Kamboj is a one year seven months old boy, suffering from complex heart disease. His father Mr. Sanjay Kumar is a daily wage laborer who earns a minimum income of Rs. 4,000/- per month. His mother Mrs. Bimla is a homemaker. Arun along with his parents, grandparents, and twin brother (Varun) live in Haryana.

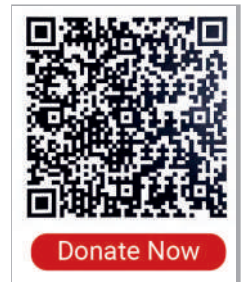
After his birth, Arun's parents noticed that he was born with fused fingers. They took him to doctors and a few tests later it was discovered that Arun is suffering from complex congenital heart disease. The parents took Arun to Paras hospital, Gurugram for treatment. The doctors here have suggested that he needs open-heart surgery to overcome the condition.

The estimated cost of the surgery is Rs. 4,50,000/-. The Kamboj family is afraid that they will lose their child due to the high cost of surgery, which they cannot pay. They have asked Child Help Foundation to support them in their difficult times.



## ONGOING MEDICAL CASES

### 15. Baby of Lalita



The baby girl of Mrs. Lalita and Mr. Shakti Patti is their only child. The baby is only eight-days-old and suffers from extreme prematurity. The baby was born in the 7th month of pregnancy and is currently in critical condition. Mr. Shakti, the sole breadwinner, is a daily wage laborer and earns Rs. 5,000/- per month. Mrs. Lalita lives in Vikhroli, Mumbai with her parents and brother in a rented house with a monthly rent of Rs. 1,200/-.

Mrs. Lalita underwent some complications during her pregnancy. Due to high blood pressure problems, her doctors suggested an urgent C-Section to deliver the baby. When their little angel was born, her birth weight was extremely low, and suffered from respiratory distress, early-onset sepsis, and neonatal hyperbilirubinemia.

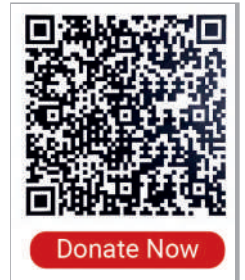
The baby is currently receiving treatment at Platinum Hospital Maharashtra. The doctors have suggested continued NICU treatment, IV Fluids, and Phototherapy along with proper monitoring. The estimated cost of the treatment is Rs. 6,00,000/-.

The baby's father has exhausted his savings during the C-Section. They have sought help from Child Help Foundation to save their only child!



## ONGOING MEDICAL CASES

### 16. Niyamuddin Shaikh



Niyamuddin Shaikh, a seven-year-old boy from Bhiwandi, Maharashtra suffers from Dextrocardia (a condition in which the heart is pointed toward the right side of the chest). He also has a single ventricle heart defect. Niyamuddin is the second child of Mr.Mehboob Shaikh and Mrs. Sultana Shaikh. His elder sister is nine-years-old and his younger brother is three-year-old. His father works as a daily wage laborer earning up to Rs. 3000/- per month. His mother is a homemaker.

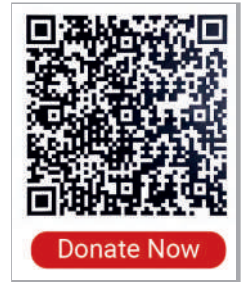
Niyamuddin was born with complications in his heart for which he underwent two surgeries to date. Despite this, his body keeps developing severe bluish discoloration. For his current treatment the doctors at Fortis Hospital, Mumbai suggested undergoing corrective open-heart surgery CT and Fontan Completion. The estimated cost of his surgery is Rs. 3,37,000/- (Rupees Three Lakhs Thirty-Seven Thousand).

His father is the only earning member in the family of five. Due to the nature of his job his income is not fixed. Mr.Mehboob turned to Child Help Foundation to help save his Son's life.



## ONGOING MEDICAL CASES

### 17. Santhosh



Santosh R. is a five-year-old boy living with his parents, Mr. Ramesh, and mother Mrs. Dyamakka. Mr. Ramesh is a laborer who works at different construction sites and earns up to Rs. 5000/- per month. Santosh's mother is a homemaker. He has a younger sister- Inchara (2) and a grandmother. The family of five lives in Dummi Chitradurga, Karnataka.

When Santosh was two years old, his parents noticed that he was unable to walk or crawl as babies usually do. They took him for a check-up in a local hospital where it was found that Santosh is suffering from Congenital Dorsolumbar Scoliosis. It is a sideways curvature of the spine that is caused by a defect that is present at birth.

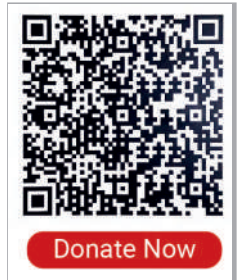
Basic check-ups and treatments were started for Santosh in a government hospital in the vicinity of their house but since COVID-19 lockdowns, his parents could not manage to take him for doctor's visits.

His condition worsened and so his parents took him to Bhagwan Mahaveer Jain Hospital, Bangalore, for treatment. The doctors have suggested a complicated surgery including posterior instrumentation, and deformity correction, along with laminectomy, adhesiolysis, and neurolysis. The estimated cost of which is Rs. 3,50,000/-. Child Help Foundation is helping them in their difficult times.

### 18. Baby of Shareen



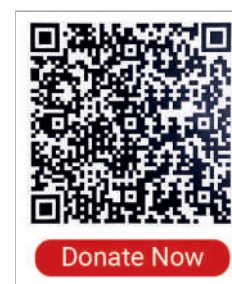
The twins of Mrs. Shareen and Mr. Solomon are seven-days-old. Born in the seventh month of pregnancy, they suffer from extreme symptoms of prematurity. Their father, the sole breadwinner in the family of five, is a fisherman and earns only Rs. 7,000/- per month. Their mother is a homemaker, and their grandfather is a retired fisherman. The family lives in Ernakulam, Kerala.

Mrs. Shareen faced some complications during her pregnancy. The doctors at Lourdes Hospital suggested an urgent C-Section to save the babies and the mother. The babies are currently in the NICU at Lourdes Hospital, Kerala. The estimated cost of both their treatments collectively is Rs. 6,00,000/-. The babies would require one month of NICU stay. Mr. Solomon cannot afford the treatment and has sought help from Child Help Foundation.



## ONGOING MEDICAL CASES

### 19. Muhammed Shahal



Muhammed Shahal, a 14-year-old boy, is suffering from T- cell Lymphoblastic Lymphoma. His father, Mr. Saleem is a laborer who works as and when he gets work and earns up to Rs. 900/- per day. His mother, Mrs. Rasina is a homemaker. The family lives in Kozhikode, Kerala.

In December 2021, Muhammed Shahal noticed that he is not able to breathe properly and it pains in his chest whenever he tries to breathe. His parents took him to a government hospital, where a test result showed swelling in his lungs.

Later when his parents took him to MVR Cancer Centre and Research Institute, Kerala, several tests diagnosed him with blood cancer. The doctors suggested Chemotherapy as a part of Muhammed Shahal's treatment.

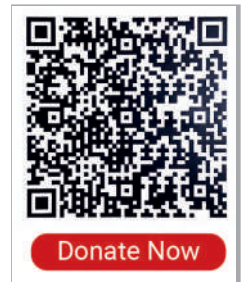
The estimated cost of the treatment is Rs. 6,00,000/-. Child Help Foundation is supporting Muhammed in his fight against cancer.

### 20. Satya Narayan Ram



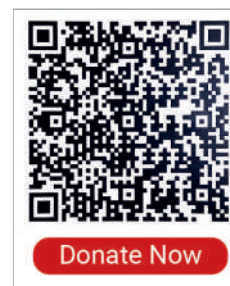

Satya was suffering from extreme pain in his legs since April 2020. His parents were unable to consult a doctor due to the lockdown. He was later taken to the hospital after the lockdown and was diagnosed with Osteosarcoma (Bone Cancer). He underwent a few sessions of chemotherapy and was later suggested to undergo surgery at Dharamshila Narayana Hospital, Delhi. He needs to undergo 12 cycles of chemotherapy as a treatment for his cancer. The estimated cost of his treatment is Rs. 12,00,000. The parents have contacted Child Help Foundation to support their son's treatment.

### 21. Durva Khatale



Durva is a two-year-old baby girl from Dhargaon, Nasik. Her father Mr. Deepak Khatale is a security guard and her mother, Mrs. Gayatri Khatale is a housewife. Durva has an elder brother Ayush, five-years-old.

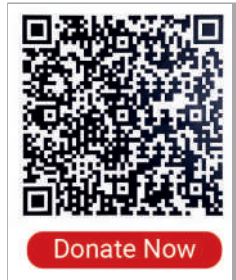
In the past few months, Durva suffered frequent fevers and started developing spots on her skin. Concerned about her health, her parents took her to a doctor who suggested a blood test. Durva's parents were devastated as the blood test results showed that she suffered from Acute Lymphoblastic Leukemia (blood cancer). Durva was shifted to HCG Manavta hospital, Nasik for her further treatment. The doctors there suggested that Durva will need chemotherapy with other supportive care treatments. The cost of her treatment will be Rs. 4,00,000/- (Rupees four lakh only).

Durva's father being a security guard earns very little and is not able to afford the cost of her treatment. Child Help Foundation is supporting the family in their difficult times.



## ONGOING MEDICAL CASES

### 22. Sarthak Thombre



Sarthak Thombre is a seven-year-old boy from Dhangarwada, Satara. His father, Mr. Rohidas Thombre works as a laborer, and his mother, Mrs. Archana Thombre is a homemaker.

A month ago, Sarthak had suffered frequent fevers which would subside when taken medicine but would recur. Concerned about his health, his parents took him to Bharati hospital, Pune. The test results showed that Sarthak suffered from acute lymphoblastic leukemia. The doctor suggested that he would need chemotherapy which would cost Rs. 7,00,000/- (Rupees Seven lakh only).

Sarthak's family consists of 6 members. His father is the only earning member of the family. With a very low income, it is becoming difficult for his father to bear the treatment cost for Sarthak. The family has asked Child Help Foundation for help.

### 23. Aadesh



Aadesh is a six-month-old baby boy from Thanjavur, Tamil Nadu. His father, Mr. Vira works as a receptionist in a lodge and his mother, Mrs. Brindha is a housewife. He has an elder brother of five years, Adith.

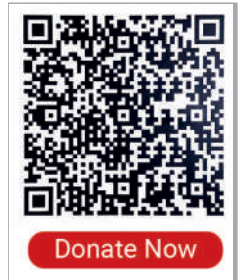
Aadesh was born in a local hospital on 28th November 2020. His heart defect was diagnosed with Congenital Heart Disease (Tetralogy of Fallot with severe pulmonary stenosis) and medical tests on the 2nd day of his birth. After four months of his birth, Aadesh's treatment started in The Madras Medical Mission, Chennai. He is currently in good health but requires surgery for his heart defect, as his skin turns blue on and off. Doctors have suggested he undergo open-heart surgery. The estimated cost of his surgery is Rs. 3,50,000/- (Rupees three lakh fifty thousand). His surgery will be done in the 2nd week of August 2021.

Aadesh's father being a receptionist is not able to raise the required amount for his surgery as he earns very less income. Mr. Vira turned to Child Help Foundation to help save his Son's life.

### 24. Dwitipriya Bera



Dwitipriya is a 10-year-old girl from Brindabonpur, West Bengal. Her father, Mr. Utpal Bera is a farmer, and her mother, Mrs. Tumpa Bera is a housewife.

A year and a half ago, Dwitipriya started suffering from frequent fever. Dwitipriya had also complained about stomachache, which was noticed only when it had turned severe and unbearable. Her parents noticed symptoms that were causing extreme difficulty and pain in her body. Concerned about this she was rushed to a nearby hospital for her treatment. A number of medical tests were done that showed she was suffering from Acute Myeloid Leukemia. A few days back, on the doctor's advice, she was then shifted to the Institute of Child Health for further treatment.

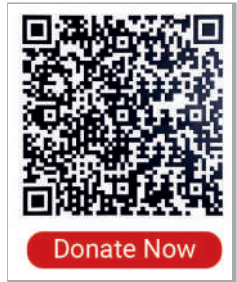
Here she was given continuous treatment for 7 days. But Dwitipriya's body suffered side effects of the chemotherapy given to her. She is currently admitted to the ICU. The estimated cost of her treatment is Rs. 7,00,000/-.

### 25. Sanaya Shaikh



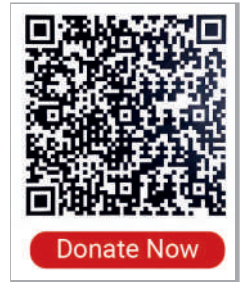

### 26. Vivek Chauhan



Vivek is a seven-year-old boy from Kasarkhed, Akola, studying in std.1st. His father, Mr. Vijay Chauhan is a Farmer and his mother, Mrs. Mala Chauhan is a housewife. Vivek is the youngest among his sisters, Payal, Nisha, and Rani.

Vivek had suffered from a high fever at the age of one, which reduced when given medicines but would recur. Concerned about their only son, Vivek's parents took him to the doctor. After doing the medical tests as suggested by the doctor, it was diagnosed that Vivek was suffering from Thalassemia major. His parents then consulted the doctors in Kokilaben Dhirubhai Ambani Hospital, Mumbai. Vivek needs to undergo a Bone marrow Transplant as a part of his treatment. The estimated cost of his treatment is Rs. 10,50,000/-. Rani, his sister, is his bone marrow donor. Mr. Vijay cannot afford the surgery and has sought help from Child Help Foundation.

### 27. Saloni Chavan



Saloni is an eight-year-old girl from Shahada, Nandurbar. Her father, Mr. Prakash Chavan works as a laborer, and her mother, Mrs. Savita Chavan is a housewife. Saloni is the eldest and has two younger sisters Prachi (seven years) and Ritika Chavan (two years).

Seven months back, Saloni's hands and legs started swelling. She also complained of pain in her swollen hands and legs. Concerned about her condition she was rushed to the doctor. As suggested by the doctor, Saloni's medical tests were done which showed cysts in her stomach. Her cysts were sent for examination. The reports of the cysts left her parents devastated, as the reports showed that Saloni suffered from acute lymphoblastic Leukemia (Blood cancer).

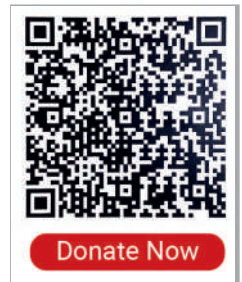
Saloni was immediately shifted to HCG Manavta Hospital, Nasik. She is suggested to undergo chemotherapy with supportive care. The estimated cost of her treatment is Rs. 3,00,000/-. Child Help Foundation is supporting the family in their difficult times.

Master Sharayu, is a 10-year-old boy. He is the son of Mr. Ravindra Samdhan and Mrs. Shweta Ravindra Hiwale. His father is working as a driver in a private firm. His mother is a housewife. Sharayu has one sister. The family consists of 6 members including their grandparents.

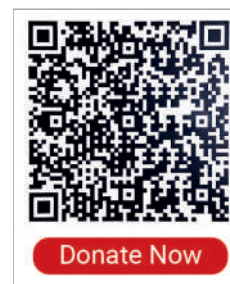
Initially, the family noticed a blood clot on his head, and was then rushed to Lata Mangeshkar hospital, Nagpur. In view of this, the doctor gave him Injections to remove the clot. Sharayu was again given a third injection which led to complications and the doctor felt a lump in his head and hence was suggested for an MRI. Through MRI, a tumor was detected which needed confirmation. Further, it was sent for biopsy, leading to confirmed results that it is cancerous. ### 29. Anam Shaikh



Anam Shaikh is a 10-year-old girl from Buldhana, Maharashtra. Her father, Mr. Ismail Shaikh works as a waiter, and her mother, Mrs. Shahin Shaikh is a housewife. Anam is the eldest with 2 younger sisters, Namira (seven years) and Zunaira (two years). Their family consists of five members.

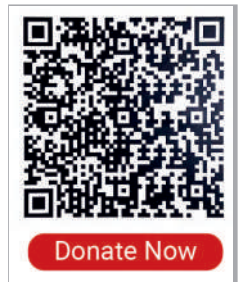
At the age of one year, Anam suffered severe fever. The temperature was high and she had to be admitted to the hospital. As the fever did not reduce, her blood tests were done. Through the blood tests, it was observed that her hemoglobin level was very low. This is when Anam's parents were told that she was suffering from Thalassemia Major. Since then she has been undergoing blood transfusion.

Currently, Anam's treatment is going on in Kokilaben Dhirubhai Ambani hospital, Mumbai. The doctors treating her have said that she needs a Bone Marrow Transplant. Namira, her sister, is her bone marrow donor. The estimated cost of her treatment is Rs. 10,50,000/-. Anam's father being a waiter is not able to afford the cost of her treatment and has sought help from Child Help Foundation.

The estimated cost of her treatment is Rs. 2,80,000/-.

Her father is not able to arrange the finances for her treatment. He has asked Child Help Foundation to support his daughter's treatment.

### 31. Anjali Shaju



Anjali Shaiju is a 15-year-old girl from Kerala. Her father, Mr. Shaiju Thankachan works as a laborer. He is the only earning person in the family of 8 members. Anjali's mother, Mrs. Shiji passed 12yrs ago due to a brain tumor. Since then Anjali and her sister are looked after by their Grandparents.

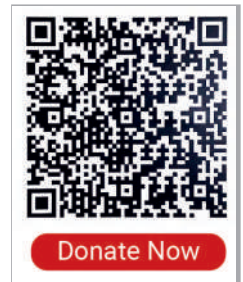

Sneha had to go through surgery to remove the cyst, but unfortunately, her surgery was not a success.

Sneha was then shifted to Manipal Hospital, Bangalore for better treatment. After all the tests in Manipal hospital, she is diagnosed with a Germ Cell Tumor (ovary) for which she has to undergo surgery and 5 cycles of chemotherapy. The estimated cost of her treatment is Rs.6,00,000/-. The family sought help from Child Help Foundation.

### 33. Mohd. Ubaid



Ubaid was born with respiratory issues. He was diagnosed with Severe Subglottic stenosis which means he had a narrow breathing pipe. A few months after his birth, Ubaid underwent surgery for broadening his respiratory pipe, but it did not seem to help him in any way. He continued to face breathing issues. Ubaid now has to undergo a Staged repair of Subglottic stenosis with balloon and coblation surgery which will be conducted in 4 stages. His treatment is going on in Rainbow Children's hospital, Hyderabad. The estimated cost of his treatment is Rs. 9,00,000/-. The family cannot afford such a huge amount and has asked Child Help Foundation for help.



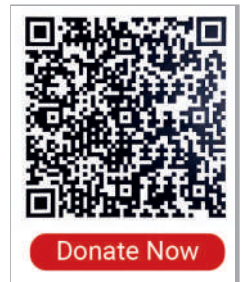

Soham's mother passed away two years ago due to pneumonia. Since her death, Soham's elder sister Vaishnavi (20) has been looking after the family of four. Soham also has another elder sister, Sandhya (15). The family lives in Latur, Maharashtra.

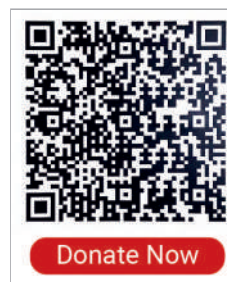
The Borke family got worried sick when they saw their only son's body develop bluish discoloration when he was only eight days old. The doctors diagnosed baby Soham with a heart defect. Since then he has been put on medications. Soham's heart rate increases rapidly if he misses his medicine dosages. When he turned 5, this dosage was increased. However, these medicines are unable to stabilize his condition. He was taken to the Fabiani and Budhrani Heart Institute, Pune, and the doctors there have advised him to undergo a Fontan Completion Surgery. The estimated cost of the treatment is Rs. 4,00,000/-.

With an unstructured job pattern and a very minimal income of Rs. 4,500/- per month, Mr. Ram is left helpless and requested Child Help Foundation to support his son's treatment.

### 39. Aamir Zaman



Aamir Zaman, a 16-year-old boy, lives in Kochi, Kerala. His father, Mr. Abdul Jibeesh moved to one of the Middle East countries for work but lost his job there due to the COVID-19 lockdown. He has now secured a job that pays him a minimal salary. Aamir's mother, Mrs. Shabana is a homemaker; he has a grandfather who is a retired bank manager, a grandmother (homemaker), and a younger brother, Aahil Zayan (10 yrs).

The family-owned a house in Thrissur, Kerala, but were forced to leave due to unforeseen financial situations. Currently, they live in a rented house near Indira Gandhi Hospital in the Ernakulam region.

Aamir was suffering from migraine-like headaches that became severe in March 2021. A bump appeared on the back of his neck as well. The family took him to a local doctor. Looking at his condition, the doctor suggested taking Aamir to Indira Gandhi Hospital, Ernakulam, Kerala. The check-up at the hospital diagnosed Aamir with T-Cell Lymphoblastic Leukemia.

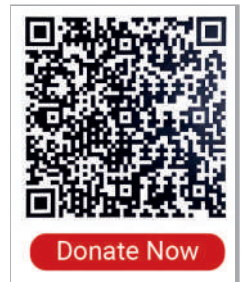
The doctors proposed continuous chemotherapy for two years as a part of his treatment. The chemotherapy sessions started in May 2021. The family used their savings for the chemotherapy sessions till now. Unfortunately, their savings have drained. The family is unable to afford further treatment and support their living expenses as well as the younger child's education.

The estimated cost of further treatment of Aamir is Rs. 5,00,000/-. Aamir's health will improve only if his treatment continues. The family has asked Child Help Foundation for support.



## ONGOING MEDICAL CASES

### 40. Lakshay Singh



Lakshay Singh is the 6-year-old son of Mr. Nirbhay Singh and Mrs. Poonam Singh. His father is a security guard supervisor with a monthly income of Rs. 16,000/-, and his mother is a homemaker. The family of three lives in Mira Road, Mumbai.

On 4th November 2021, when the entire nation was happily celebrating Diwali, little Lakshay met with a horrible accident that changed his life forever. The boy and his father were playing with firecrackers in their society compound when a spark from the phooljhari (sparkles) lit up an entire bag full of firecrackers, and Lakshay's body caught fire. All his clothes got stuck to his body, causing immense pain to the little boy.

His father and neighbors were horrified by the incident and took him to a local clinic. The doctor saw the severity of the injuries and advised the father to take their son to Family Care Hospital, Mira Road. Here, his wounds were cleaned up but unfortunately, they did not have the equipment to treat Lakshay further. He was then shifted to National Burns Center, Airoli.

The doctors have suggested multiple skin grafting surgeries, out of which two surgeries have been performed successfully. The Singh family borrowed money from relatives and neighbors for Lakshay's treatment. All their savings, including Mr. Nirbhay's Diwali bonus, are utilized completely. A total of Rs. 3,90,200/- is the estimated surgery cost, and his father has no means to raise this huge amount. Child Help Foundation is supporting the family in their difficult times.



## SUPPORT DURING COVID-19

### Oxygen Concentrators

Since the pandemic first broke out in 2020, hospitals were in desperate need of protective gear and equipment. Child Help Foundation responded in record time to stand strong beside our healthcare heroes. The record increase of COVID positive patients and fatalities per day and the lack of life-saving equipment like oxygen cylinders and concentrators was crippling the country's healthcare infrastructure. There was a critical and immediate need for oxygen in hospitals and COVID Care Centers.

In response to this, we launched our health campaign "Breathe India" to support critical patients. We donated oxygen concentrators to reduce the burden on the local medical system and save the lives of as many people as possible. Each 10-liter Oxygen Concentrator costs more than Rs. 1.25 lakhs. We provided 13 concentrators to the Hospitals that are tied up with Child Help Foundation for Emergency Medical Support across India. We were happy to save 7800 lives through our support.

For patients in home isolation, especially older individuals and those at increased risk because of medical conditions, a pulse oximeter comes handy for monitoring oxygen levels. Child Help Foundation distributed pulse oximeters to COVID-19 patients in collaboration with Xondhan Foundation, Assam. 50 individuals benefited from this initiative.

## QUALITY EDUCATION (SDG4)

According to the United Nations, 1 in every 5 of 59 million children drop out from school and recent trends suggest that 2 in 5 out-of-school children will never enter a classroom. Even the international community more openly confronts the difficulties of quality and equality in education, and the Sustainable Development Goals recognizes that this gap must be bridged. Through its Education Support Program, Child Help Foundation improved the lives of almost 4,502 underprivileged, single-parent, and destitute children in the year 2021-2022 by ensuring inclusive and quality education for them.

### Child Care Institutions

Education is an important aspect of development for an individual as well as the nation. Child Help Foundation is involved in providing primary education at the grassroots level to the economically backward sections of society. We have enlightened the lives of 414 children by supporting their education through our 10 Child Care Institutes (CCIs) across the country.

It is realized that children should be protected from or against any danger to their life and childhood. They should be provided with every opportunity to build their personality and have positive childhood experiences. Since children are the most vulnerable to any kind of harm and influence, it's important that we provide them with a social safety net. Child Care Institutions ensure such essential services and strengthen structures for emergency outreach, institutional care, family and community based care and counseling and support for the underprivileged children.

Several activities are conducted for these children every year. Teachers' Day, Women's Day, Republic Day, Independence Day, and other special days are thoroughly celebrated. Drawing competitions, dance competitions, elocution competitions, and other educational and entertaining activities were also conducted to promote the spirit of the students. The CCIs had organized a few sessions to raise awareness in children about social evils like early child marriages, the importance of child safety, one-to-one counseling sessions to promote mental health, and the importance of education, among other things.

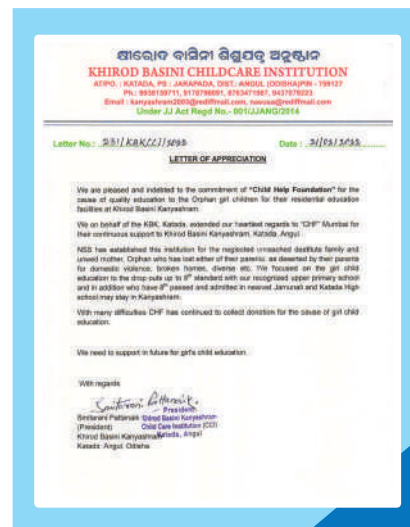

### Success Stories

**Faizan Khalid** is a 16-year-old boy from Mumbai, studying in Genius International Islamic school. Her sister **Insha Khalid** is a six-year-old girl studying in the same school. Their father works as an electrician and supports the family on a minimum wage. Their mother is a homemaker. Their father was hardly able to meet the family's most basic necessities due to his joblessness during the COVID-19 lockdown. They had to discontinue their children's schooling due to a lack of finances. By funding Faizan and Insha's schooling, Child Help Foundation aided them in their time of need. For this, they were given Rs. 20,000/- in support.

**Khan Noore Ayen Jaffar** is a 13-year-old student at Mumbai's Rose English High School, Maharashtra. He is an outstanding student. His father works as an autorickshaw driver in the city. His mother is a homemaker. Because the Covid-19 lockdown had shut down all modes of transportation, his father was jobless. Due to his inability to work, he was unable to continue his son's education. As a result, he turned to the Child Help Foundation for help. Ayen's education was financed by Child Help Foundation, who paid Rs. 7200/- in fees for his seventh-grade education.

**P. Bhavani** is a 17-year-old girl from Chennai. Her father works for a small business, and her mother is a homemaker. Due to his joblessness during the COVID-19 lockdown, their father, as the family's sole breadwinner, was unable to meet the family's most basic needs. Due to a lack of funds, they had to discontinue their daughter's education. Child Help Foundation assisted Bhavani in her time of need by sponsoring her education. She received the support of Rs. 20,000/- for her education.



## QUALITY EDUCATION (SDG4)

### Center For Excellence

Child Help Foundation started the Center for Excellence (CFE) program in the year 2018. The project began with field visits to schools in the Palghar district of Maharashtra. The facilities and amenities provided to the students in schools were noticed to be inadequate. The change was necessary in order to provide quality education to students. Our main goal was to encourage and develop students' interest in various subjects while also aiding them in making wise livelihood choices.

Thus, the CFE program was established in 2018 with a focus on school development projects including the physical, academic, social, and mental needs of children. From 2019 to 2020, the program began with a small initiative, providing supporting classes for SSC students at Government Secondary Ashram School-Sakhre, Taluka Vikramgad, Palghar district, in subjects such as English, Mathematics, and Science. We conducted summer study camps, cultural programs, sports activities, and social and health awareness sessions, as well as established a library for them. The outcome was overwhelmingly positive, as the students went on to achieve outstanding results on their SSC exams.

With the success of the first CFE project, Child Help Foundation decided to diversify and take the project to even more schools and children. In 2021, the CFE project was inaugurated at schools in the Murbad Ashram Shala and the Vangani Ashram Shala in the Palghar district of Maharashtra.

The CFE program aims to provide underprivileged children with modern amenities and educational opportunities. Every child deserves quality and comprehensive education, and Child Help Foundation works to make this a reality for as many children as possible. The CFE program is made up of several different projects. Supporting classes for students in classes VIII to X are conducted in Murbad, Vangani, and Sakhre Ashram Shalas with the help of specially trained teachers in subjects such as English, Math, and Science. These specially trained teachers are also given communication and practical skills training in order to impart knowledge in a more understandable and contemporary manner.





## QUALITY EDUCATION (SDG4)

Since the students of these areas have not been exposed to important topics and ideas prevalent in the world currently, Child Help Foundation organizes specialized awareness sessions on pressing issues. The prevention of COVID 19 (Coronavirus) infection, the prevention of sexual abuse and harassment of children, sexual reproductive health awareness, HIV/AIDS, science and invention, how to study and prepare for exams, and career guidance for students were some of the topics covered during these sessions.

Another important initiative under the CFE is the establishment of digital learning stations in Ashram Shalas. There is an upcoming need for students to be connected on the digital medium, since the information obtained through these digital platforms may help students in their learning process.

Child Help Foundation conducted an educational camp called "Talk in English, Walk in English" in the Murbad and Vangani Ashram Schools from February 2nd to February 9th, 2022. The children were given an idea of extracurriculars and fun activities to undertake beyond the spectrum of textbooks. Drawing, yoga, and fun games were among the activities the children participated in, making the session even more interactive. It was a fun-filled event for both students and teachers, merging education and activities. The camp was a huge success, with a big turnout from students and excellent reviews all around.

Apart from that, educational field trips to libraries, museums, and offices are organized to provide the students with an opportunity to observe the world they are living in and studying about.

In the year 2021-2022, the CFE project has benefitted 210 students from Sakhare Government Ashram Shala, 159 students from Vangani Government Ashram Shala, 305 students from Murbad Government Ashram Shala, and 255 students from Bhopoli Government Ashram Shala.







## QUALITY EDUCATION (SDG4)

### Mini Science Center

In October 2021, Child Help Foundation in collaboration with Samata Equal Footing Foundation and Vikram A. Sarabhai Science Center (VASSC), established its first Mini Science Center in the Sakhare Ashram Shala to help students understand scientific and mathematical concepts with practical knowledge.

The Mini Science Center is designed to emphasize the significance of practical and hands-on learning for students. Students will benefit from models of scientific concepts such as gravitation, motion, reflection, and anatomy, as well as mathematical concepts such as algebraic expressions and geometry. Since science and mathematics rely heavily on problems of day-to-day life, it is important to make students understand those concepts in similar contexts and environments.

Through an orientation training for the school's teachers, VASSC resource persons familiarized them with the Mini Science Center's elements and objectives. The workshop was conducted by Ms. Lata Torvi and Miss. Pooja Desai, scientist at the VASSC. The discussions revolved around the need for properly nurturing the problem solvers and critical thinkers of tomorrow through practical learning and demonstrative teaching in educational institutions. Demonstrations of the new equipment at the Mini Science Center, such as the exhibits, puzzles, learning exercises, and model rockets were also given.

Students and teachers were given interactive models of scientific concepts such as kinetic energy, human anatomy, gravity, light reflection, and space science to help them understand the importance of teaching aids for learning. The final event of the workshop was the launch of model rockets in the schoolyard to explain Newton's Laws of Motion to students and teachers. 16 students participated in the workshop.





## QUALITY EDUCATION (SDG4)

This project has helped in the establishment of Mini Science Centers in tribal schools. It is planned to be expanded to Pali, Vangani, and Murbad Govt. Ashram shalas.



### Education Camp

Child Help Foundation held a Summer Camp at Vangani and Murbad Ashram Schools. The students got an opportunity to present their ideas during the camp, which helped in their overall development and growth.

Various resource persons (Dr. Swati Desai, Dr. Jayshree, DR. Prabha Rastogi, and Ms. Mena Lokhande. Ms. Anjali Patel) were invited to create awareness on subjects like Protection of Children from Sexual Offences (POCSO), Science Interventions, and Tricks for Maths, Letter Writing, Craftwork—best out of waste and drawing. Child Help Foundation volunteers conducted fun sessions by organizing games and sports to create a sense of sportsmanship in the students. The total number of students who benefited from this camp was 464 (305 from Murbad and 159 from Vangani).





## QUALITY EDUCATION (SDG4)

### UPSC Exam Books

Child Help Foundation supports the underprivileged tribal children studying in Sakhare Ashram Shala. With the help of Mr. Prashant Khandekar, Union President, Hotel Taj Mahal Palace, Mumbai, Child Help Foundation donated UPSC examination books to the students. This was done in order to provide access to quality studying material to the underprivileged aspirants.



### Educational Assistance in Bihar

In the year 2018, Child Help Foundation started Additional Learning Sessions in the Sikarhata village, Bihar. Subjects like Maths, Science, English, and Hindi are taught to the students. The students are provided with school uniforms and stationery kits for the smooth execution of their skills. 150 children attend the classes every day.





## QUALITY EDUCATION (SDG4)

### Nanhe Kalam Initiative

The vision for a self-reliant and self-sufficient population in India has been the driving force for many social projects. There is a growing consensus about helping people and communities learn the ways to grow and benefit by developing skills of the modern era.

On 21st October 2021, In collaboration with Self-Reliant India, Child Help Foundation hosted a three-day Fellow Induction Workshop at Bal Bhawan, Rewari. The workshop was organized to orient the newly-inducted teachers about their roles and the kind of tasks that they will be doing in their 2-year fellowship. The workshop included discussions on the community, quality education, school, and their upcoming fellowship processes. Debates and discussions were also done on topics such as the contemporary problems in Indian education, effective classroom management, lesson planning, and the introduction to the SRI mobile application for better and easier communication. The workshop was a success and garnered positive reviews from all participants. It was made more fun and interactive with the use of games and physical activities.

A similar workshop on capacity building was organized on 24th December 2021 in collaboration with SRI. The workshop saw interactive discussions on resolving the challenges of conceptual understanding and the effectiveness of the assessment. The fellows came together for detailed discussions on classroom planning, planning strategies, new procedures for concept and question mapping, assessments, PTM, and logistics to improve their skills and manage the Learning Center. This workshop was informative and engaging for all fellows and benefited their understanding of the projects.





## QUALITY EDUCATION (SDG4)

### Nanhe Kalam Initiative

Due to the increased number of COVID-19 cases and a state-wide lockdown, the next workshop was held in a virtual medium. On 29th January 2022, the fellows of the SRI projects came together on the Zoom application for a workshop on resolving the challenges of conceptual understanding and the usage of data visualization and interpretation in student learning via structured planning. Participants explored different approaches to creating effective meaningful assessments, planning strategies, improving teaching methods, score visualization, and interpretation in student learning. Fellows learned how they can change and modify their teaching approaches by mapping and recording the scores of students. Even though the workshop was virtually conducted, there was a positive and enthusiastic reaction from the fellows attending.

## GENDER EQUALITY (SDG5)

Gender Equality is an established human right which will never be truly eradicated until we address the problem directly. Child Help Foundation thus realistically works towards creating equal platforms for all genders in the community. We promote the education of girl children through various means and by extending our support in dealing with related factors. Our Gender Equality Program is aligned with the National Program 'Beti Bachao, Beti Padhao'. We aim to take action inclusive of the needs of LGBTQIA community groups. Because major sections of such community need to be empowered to stand up for their equal rights and opportunities.

### Self-Defense Workshop

Keeping in view the rising number of crimes against girls and women in our country, self-defense training becomes an imperative to ensure their safety and security. Such training shapes women to become psychologically, intellectually, and physically strong enough to protect themselves. The basic knowledge of self-defense increases one's chance of surviving a violent assault. By making women learn self-defense; we can ensure a society brimming with powerful and strong women who can protect themselves.

Child Help Foundation, in collaboration with For Future India, conducted a Women's Self-Defense Program on 26th August 2021 at Mira Bhayandar Municipal Corporation.

Special black belt volunteers from For Future India taught various self-defense techniques like straight punch, straight kick neck attack, elbow attack, stomach level punch, straight fist punch, palm attack, straight palm to the nose, knee attack, among others, during the program.





## GENDER EQUALITY (SDG5)

### Ration Kit Distribution To The Transgender Community

Ration kits were distributed to 220 transgenders and widows in Bharatpur Kinner Basti, Sampur Baramunda, Bhubaneswar (Odisha), Mira Road (Mumbai), and Khar Road (Mumbai). The Ration Kit Included Rice, Daal, Spices, Tea, Cooking Oil, etc.

Child Help Foundation held pride in being able to reach the needy across various spectrums.



### Water and Sanitation for Girls in School

Millions of women and girls lack adequate facilities for menstrual hygiene management (MHM). Inadequate WASH (water, sanitation, and hygiene) facilities, particularly in public places, such as schools, workplaces, or health centers, pose a major obstacle to women and girls. Major challenges also include lack of separate toilets with doors and unavailability of means to dispose off used sanitary napkins.

In partnership with Filaantro, Child Help Foundation cleaned and refurbished toilets in the Lady Willingdon Girls' Higher Secondary Government School, Chennai. The refurbishments of toilets have made things easier for the 444 girls studying at the school.







## GENDER EQUALITY (SDG5)

### POCSO

The Protection of Children from Sexual Offences (POCSO) Act is a comprehensive law enacted to protect children from a variety of sexual offenses, such as sexual assault, sexual harassment, and pornography, while also safeguarding the child's interests at every stage of the judicial process by establishing a child-friendly mechanism for reporting, recording evidence, investigation, and speedy trial of offenses through special courts. This law defines a child as any person below the age of 18 years. The POCSO Act, 2012 came into force with effect on November 14, 2012, along with the Rules framed thereafter.

Child Help Foundation organized a POCSO training at the Government Secondary Ashram School in Murbad. 464 individuals attended the training. The training was hosted by Ms. Meena Lokhande, Resource Mobilization Head of Child Help Foundation.

#### Learning outcomes:

- Awareness about the Prevention of Sexual Harassment was created among the school students.
- They were taught about Good and Bad touch.
- Girls were explained about harassment at the workplace and how to deal with it.





## GENDER EQUALITY (SDG5)

### POSH

in 2013, the Indian Government approved the Sexual Harassment of Women at Workplace (Prevention, Prohibition, and Redress) Act. It defined sexual harassment, outlined the processes for filing a complaint and conducting an investigation, and specified the appropriate course of action.

Ms. Meena Lokhande from Child Help Foundation is an External Member of the Vishakha Samiti under the Palghar District Collector's office to help them in complying with The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act (POSH) 2013.

This Act makes it mandatory for companies to hold employee awareness sessions. In the Financial Year 2021-2022, Child Help Foundation provided POSH training to its 300 staff and volunteers. We conducted training for 200 government employees across Palghar district in Maharashtra, India.

Child Help Foundation also trained 3070 employees of the following corporate companies.

## CLEAN WATER AND SANITATION (SDG6)

### Menstrual Hygiene

Sanitation and Hygiene are basic requirements to one's living and yet countless number of children and adults do not have access to them. Menstrual Hygiene management among girls and women is a more pressing issue as it directly affects their health and quality of life.

Evidence shows that girl's inability to manage their menstrual hygiene in schools, results in school absenteeism. Many girls in remote areas of India are not even able to purchase sanitary napkins.

To minimize the health risks of girls in rural areas, Child Help Foundation has been undertaking regular activities wherein sanitary napkins are distributed to young girls. Sanitary napkin distribution, undertaken by Child Help Foundation on a pan-India level, reaches out to as many girls as possible.

Child Help Foundation also organizes awareness sessions to provide girls with adequate facilities and knowledge for their menstrual hygiene. Given the multiple challenges women and adolescent girls face, promoting menstrual hygiene management (MHM) is also an important step toward safeguarding their dignity, bodily integrity, and overall life opportunities. Through our initiatives, we aim to encourage women and girls to adopt hygienic menstrual practices and spread awareness of illnesses caused due to unhygienic practices. Child Help Foundation has reached 53,726 females and distributed 3,76,082 sanitary napkins to women and adolescent girls across India.





## CLEAN WATER AND SANITATION (SDG6)

### Chennai, Tamil Nadu

#### Lady Willingdon Girls' Higher Secondary Government School

Located in Triplicane, Chennai, Lady Willingdon Girls' Higher Secondary Government School is a 100-years-old school, built during the British Era. The ancient architecture needed timely renovations which were not possible due to lack of funds. This caused multiple damages like falling off of the compound walls, making the school inhabitable. Students even started dropping out due to a lack of safety and sanitation.

The school management, along with the Madras Mylapore Ladies Circle, reached out to Child Help Foundation looking for some help and support. Child Help Foundation partnered with Filaantro to raise funds to carry out the required developments. Out of a total of 500 students, 444 are girls. It was important for these girls to have access to clean and safe menstrual products, amenities and facilities such as toilets and water, and waste management to maintain hygiene. The refurbishments of toilets made things easier for these students.

During our intervention, Installation of water purifiers and renovation of washrooms and toilets became an essential part of making the school more hospitable for the students studying there.





## CLEAN WATER AND SANITATION (SDG6)

Child Help Foundation also took up the responsibility of making the area cleaner for the students and teachers. The presence of debris and waste was noticed and swiftly removed from the classrooms and hallways, making the school cleaner and safer for students.



### Odisha, India

#### Refurbishment of Toilets

On 15th March 2022, two toilets were refurbished at Hemchandra Simanta Vidyalaya, Sahapur, Odisha by Child Help Foundation volunteers. The newly renovated toilets made it safer for students to spend time in school and helped curb the student dropout rate. 80 students have benefited from this initiative.





## CLEAN WATER AND SANITATION (SDG6)

### Odisha, India

#### Village Cleaning

In the Sahapur Village, Dist. Ganjam, Odisha, 15 students from Hemachandra Sanskrit Vidyalaya with the help of Child Help Foundation, took up the responsibility of making the area cleaner for the villagers. The presence of debris and waste was swiftly removed, making the village cleaner and safer for the residents. Even villagers came forward to lend a helping hand. Child Help Foundation volunteers regularly conduct cleaning drives in Odisha. Around 400 villagers benefited from this initiative.



### Water Purifiers

Child Help Foundation inaugurated water filters at Dongare ZP School, Saphale, Palghar, Maharashtra which benefited 40 students, and at Murbad and Wangini schools, Maharashtra which benefited 811 students. Children are particularly at risk of catching diseases caused by contaminated water. Access to improved sources of water will eliminate such risks and lead to better health, and therefore better school attendance, with positive longer-term consequences for their lives.

## ZERO HUNGER (SDG2)

The United Nations' 2nd Sustainable Development Goal aims to eradicate hunger and lays out methods to address food insecurity among economically and socially disadvantaged people.

India has slipped to the 101st position out of 116 countries in the Global Hunger Index (GHI), from 94th place in 2020 with adequate data to calculate 2021 Global Hunger Index scores. With a score of 27.5, India has a level of hunger that has severe implications. India's GHI 2021 score "unfortunately" reflects the realities of the country, where hunger has worsened since the outbreak of the Covid-19 pandemic. Despite multiple government measures, we still have a long way to go to bridge the gap between food distribution and hunger.

Child Help Foundation started its Roti Ghar initiative in partnership with Khushiyaan Foundation. We feed warm and nutritious meals to 1,800 underprivileged children daily. By doing so, we hope to ensure that children have access to enough nourishment during critical developmental phases. Roti Ghar's mission is to reach out to malnourished children and provide them with freshly prepared meals produced in our centralized kitchen. In the last 4 and a half years of our program, 50 percent of these beneficiaries reported an improvement in their health, and 70 percent of them have resumed going back to school.

Good Nutrition helps students show up at school prepared to learn. Because improvement in nutrition makes students healthier; they are likely to have fewer absenteeism. Their behavior may improve and cause fewer disruptions in the classroom, creating a better learning environment for each student in the class.

She also has an artistic side, which justifies her 'A' grade in the Drawing subject. For a sharp brain and good concentration, Child Help Foundation provided her with healthy nutritious food.



### Odisha

A post-pandemic celebration day was held in Chilika, Odisha for our Roti Ghar program. We held a session with underprivileged women and children to teach them about the importance of health and hygiene. The community was also delighted. They expressed their gratitude to Child Help Foundation and Khushiyaan Foundation for providing the support they need.





## ZERO HUNGER (SDG2)

### Ration Kits Distribution to the Transgender Community

Child Help Foundation distributed Ration Kits to 135 transgenders and widows from two locations, Bharatpur Kinner Basti, Sampur Baramunda, Bhubaneswar (Odisha), and Mira Road, Mumbai. They are one of society's most vulnerable groups, and they require support to sustain themselves. Child Help Foundation takes pride in being able to reach the needy across various spectrums.



**Kamini Ghodke** is a transgender woman who lives in Thane West's Wagle Estate. She works as a 'POOJARI' in a temple, where she looks after the deities. For her livelihood, she is completely dependent on the temple. She and many others like her were helpless and without a means of income during the Covid-19 outbreak when all religious institutions were closed to everyone. CHILD HELP FOUNDATION provided her and 150 other Transgender people with grocery kits and other necessities at the time. Kamini is a dedicated Child Help Foundation volunteer. We strongly condemn any discrimination toward the transgender community. Child Help Foundation always looks forward to offer support to the transgender community in order to improve their lives and inspire the general public to treat them equally and respect their unique identities.





# Village Development





## VILLAGE DEVELOPMENT (SDG 8, 10)

The UN's 8th and 10th sustainable development goals to be achieved by 2030, aim to achieve decent work and economic growth by reducing inequality in all sectors and communities. Child Help Foundation under its Village Development initiative has incorporated these two SDGs of the UN.

Child Help Foundation started the Village Development Program in 2016 under which it formed Self Help Groups at Nagosali Village, Nashik.



In the year 2022, Child Help Foundation initiated another Village Development project in Nashik. As part of this project, we are undertaking the following activities in the village.

A Small Bazar Haat (Market Place) as a business center will be set up where the youth and women can open shops like general stores, electrical equipment repairing, clinics, cosmetics stores, saloons, dairy, bakery, spices (Masala), tailoring, vegetables, etc. A community hall will help them to sell products in masses, or conduct special exhibitions of products. Directional sign boards will also be put up to help them navigate as the village is 10 km inside the main city.





## VILLAGE DEVELOPMENT (SDG 8, 10)

As a part of Village Development, Child Help Foundation will commence Computer Education for Women, Men, and Youth and Skill Development Training for women to learn food processing, make herbal products and sell them in the market. Awareness Sessions will be conducted on Social and Legal rights of Women. POSH Act, Domestic Violence Act, Dowry Act, Right to Education, Government Schemes for Women will be covered. We will support them in expanding and deepening 30 more wells, so that water be easily available to them. This program will support the livelihood of families.

Child Help Foundation aims to support children from the village by supporting their families. We believe that empowered women will be able to provide better care to their children and families by providing them with their basic needs like educational, health, emotional, spiritual, and social needs.





# HUMANITARIAN RELIEF







## HUMANITARIAN RELIEF (SDG 11, 13, 17)

Child Help Foundation, under its Humanitarian Relief initiative, has incorporated three Sustainable Development Goals (SDGs) of the UN – SDG 11, 13, and 17.

During catastrophic events such as floods and cyclones, it becomes a necessity to humanely help each other. Child Help Foundation is committed to such humanitarian coordination in terms of relief personnel and volunteers on the ground. We contribute food packages and relief materials to those in need at times of distress or disaster.

When the COVID-19 pandemic brought the whole world to a halt, many people were laid off and left only with minimal necessities. During such times, Child Help Foundation donated relief packages and food to as many individuals as possible across India. These Ration Kits consisted of essential food items like wheat flour, rice, lentils, soaps, cooking oils, salt, sugar, and spices. Several people were aided with rehabilitation to adjust to the "new normal".

To uplift the underprivileged sector throughout India, we have implemented multiple grassroots-level initiatives in 21 states.





# HUMANITARIAN RELIEF (SDG 11, 13, 17)

## Kerala

The state of Kerala suffered tremendously due to devastating floods in October 2021. Thousands of people were left stranded, without food, drinking water, and shelter. Child Help Foundation was one of the first organizations to begin the relief process for the affected. Food, water, and help kits were provided to around 40 families across the affected areas. Crossing rivers and tricky landscapes, our brave volunteers put all their efforts in helping as many people as possible. Situations like these have brought humanity together and shown us the importance of resilience and cooperation to tackle disasters.



## Tamil Nadu

On 13th November 2021, volunteers from Child Help Foundation distributed Ration Kits to 410 beneficiaries from Kummanur Village, Thiruvallur District, Chennai Metropolitan Region, Tamil Nadu. The residents of the coastal regions in Tamil Nadu were finding it difficult to make their ends meet because of the disruptive floods and bad weather conditions. By distributing these kits, we helped them lessen their suffering and provided them with the nutrition they require.





## HUMANITARIAN RELIEF (SDG 11, 13, 17)

### West Bengal

Cyclone Yaas wreaked havoc on the people of West Bengal in May 2021, causing many families to lose their homes, means of livelihood, and loved ones. When the Cyclone struck Mamudpur Village, Parganas District in West Bengal, the Child Help Foundation team in collaboration with Katakali Empowerment and Youth Association (KEYA) worked tirelessly to reach the areas with flood relief for affected families, supplying them with 1,000 ration kits.



### Bihar

After the floods in Bihar, Child Help Foundation was one of the first groups to visit the underprivileged community of Sugauli village to provide aid. Our volunteers distributed dry Ration Kits to 600 beneficiaries.





# HUMANITARIAN RELIEF (SDG 11, 13, 17)

## Odisha

The 2021 winter presented an unprecedented public health challenge of facing the COVID-19 pandemic and the flu season at the same time. In the colder months, the underprivileged households found it challenging to heat their homes adequately, thus increasing their exposure to health risks. Child Help Foundation distributed Warm Jackets to 115 children of the Gajpat District.

In the Dhenkanal District, Child Help Foundation distributed blankets to 265 individuals to help them survive the lowering temperatures and increasing cold.

The Child Help Foundation team in Odisha worked tirelessly to reach flood-affected families with 1,092 ration kits in Jagatsinghpur.





## HUMANITARIAN RELIEF (SDG 11, 13, 17)

### Maharashtra

During the Maharashtra floods in the month of July 2021, Ratnagiri was one of the many affected areas. Child Help Foundation supported 450 individuals by providing them with household supplies and children's clothing. These floods disrupted many houses, and families experienced both personal and material losses.

Posare Village, Khed had also experienced torrential rains and suffered heavy losses due to the same. It was affected by landslides and 16 -17 houses were buried under the mud. To provide some respite to these villagers Child Help Foundation (CHF) distributed ration kits and household items like steel utensils and clothes for children and adults. 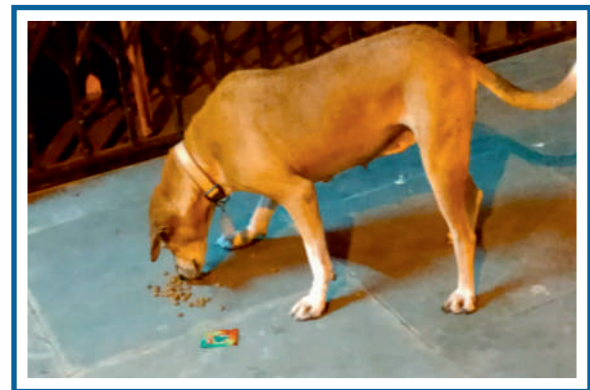


## LIFE ON LAND (SDG 15)

Thousands of stray animals have had almost no sustenance since the lockdown was imposed, while we relax comfortably in our homes and eat at least two meals a day. Stray animals do not have the luxury of a comfortable and secure life. Most animals depend on humans around them to sustain themselves. Our empathy, compassion, and respect for these animals and other species makes the world a happier and more beautiful place.

Overconsumption is wreaking havoc on our planet, and the usage and exploitation of animals contribute significantly to climate change and unending animal suffering. Most cities lack animal hospitals for stray animals, injured or unwell animals, they frequently die from illnesses that are curable.

We strive for a day when all creatures' lives are valued for what they are, whether they are dogs, chickens, cows, or fish. Strays are often very expressive and social animals. But every day is a struggle for them, as they scavenge for scraps of food and shelter while dodging traffic, which aggravates their health problems.



In keeping up with the spirit of our adopted SDG-15: Life on Land, Child Help Foundation strives to make the world a better place for all living beings. We work relentlessly to rescue, provide food, and medical treatment to the un-owned street animals of India who have become ill or injured.

During COVID-19, Child Help Foundation fed 2085 animals in the lockdown. Even if animals in our neighborhood are fed, they are rarely petted, and they are almost never permitted into the houses. Animals who live on the streets are particularly vulnerable to injuries. Fights with another stray dog might result in wounding, a speeding bike can fracture their limb, and inadequate diet and stress can lead to illnesses like mange. The suffering of such animals go unnoticed until it is too late. We appreciate our volunteers' enormous help in spreading animal protection messages to our communities by sharing their wonderful experience as volunteers and animal protectors.



## LIFE ON LAND (SDG 15)

Child Help Foundation extends its gratitude to all the donors and volunteers who have offered support and hands-on assistance in saving the lives of so many animals. We are committed to the welfare of animals and work tirelessly to reach out to stray animals in every nook and corner of the country. We believe that by being kind and compassionate we can make a difference in their lives.



### Tree Plantation Activity

SDG 15 proposes to protect, restore and enhance natural ecosystems. Reforestation and conservation are essential to building a better, more sustainable future. It would take collaborative effort and teamwork of all the citizens of this great country to come together and be the change.

Child Help Foundation organized a tree plantation drive at the BBMP Corporation School in Shanti Nagar, Bangalore. 45 individuals actively participated in this drive. The idea behind this activity was to propagate the message that planting trees helps to maintain a clear eco-friendly environment, reduce pollution and improve the green ambience.

## DAAN UTSAV 2021-22

Daan Utsav is India's 'festival of giving'. Launched in 2009, the festival is celebrated every year from October 2 to October 8. People from all walks of life come together during this time to give back to the society that has sustained them for so long. The 'daan' can be in any form; time, money, resources, or skills. People participate in this event by the smallest of gestures such as giving a home-cooked meal to a homeless person, spending time with some-one to make them smile or simply helping a person out. People also participate in donation drives and community kitchen programs. This way, the spirit of community harmony grows stronger and help is extended to those in need.

Child Help Foundation has been an avid participant in the Daan Utsav for several years now. This year too, Child Help Foundation organized the Daan Utsav in Mumbai and the Northeastern regions of India. The event spanned from 2nd to 8th October 2021 and rightfully upheld the spirit of aid and compassion. Child Help Foundation took the Daan Utsav celebration to schools and educational institutions. We distributed stationery items such as pencils, pens, and notebooks to students in the schools, along with sanitary napkins for female students. Simultaneously, Daan Utsav was also organized in Mumbai and neighboring districts. Child Help Foundation volunteers indulged in several events such as distributing fruits and vegetables to the needy, conducting awareness sessions on menstruation for young girls, and many more. Coloring books and crayons were distributed to the children of cobbler community, along with donations made to old age homes and educational institutions in the form of instant water heaters, books, pens, etc. A special event was organized by Child Help Foundation, honoring the workers of the Brihanmumbai Municipal Corporation and domestic workers for their relentless work. They were given caps and medals as a token of appreciation and safety equipment to make their work easier.

The act of expressing kindness and gratitude does not end with Daan Utsav. Child Help Foundation believes that this event is only a reminder to mark the significance of giving back to society while we continue such engagement throughout the year.

A total of 462 employees enthusiastically participated and contributed to Bringing Smiles into the lives of underprivileged children. The Wish Tree gifts were distributed among 18 Children at Sneha Orphanage in Bangalore.



### Taj Lands End, Bandra

At the Bhopoli Ashram Shala, Child Help Foundation held an informative seminar to teach students how to be safe during the pandemic by properly using masks and sanitizing on a regular basis. It was conducted by Taj Lands End, Bandra, who is one of our donation partners. Child Help Foundation also provided the school administration with 700 masks and 10 liters of liquid sanitizer for the students. The ceremony was attended by 47 children from Sakhare Ashram Shala and 100 youngsters from Bhopoli Ashram Shala.

### Ortho Medical

Child Help Foundation offers medical assistance to beneficiaries suffering from heart surgeries, cancer, brain, liver transplants, organ failures, kidney failures, and other health difficulties since 2011. Twin Babies of Nikitha were admitted to the NICU due to respiratory distress and for preterm care and management. Ortho Medical supported this case. EBM was given to the twins along with HMF and multivitamin supplements. Twins had high serum bilirubin levels and phototherapy was instituted on day 2 of admission and was stopped once levels were normalized. On discharge, the children weighed more than 1.80 kg.





## CSR ACTIVITIES

### Nutanix

The Center For Excellence (CFE) project aims to reach out to tribal children in Palghar district's Jawhar Block, which is regarded as a backward area in terms of human development and literacy. In this predominantly tribal area, the project aims to tutor the tribal children on subjects that they find difficult to learn such as English, Mathematics, Science, and Computer Skills. Nutanix donated Rs. 6,00,000/- to this project. The teachers clarify doubts regarding their respective subjects. They put in at least 6 hours every day to tutor the children. 7 sessions in the Science subject, 7 sessions in the English subject, 6 sessions in the Math subject, as well as examinations are conducted every week.



### Motilal Oswal Foundation

Child Help Foundation won the "Bright IDEAS Contest" organized by Motilal Oswal Foundation (MOF) for our "Center For Excellence" (CFE) project run in the Palghar district, Maharashtra.

With the help of MOF, Child Help Foundation provided television and a water purifier to the school. Subjects like Maths, English, and Science were taught to the children at the Murbad Ashram Shala and Vanghni Ashram Shala. Three new teachers were appointed.

In Murbad Ashram Shala, an awareness workshop on COVID prevention was held.

Child Help Foundation held a Summer Education Camp at Vangani and Murbad Ashram Schools. They got opportunities to present their ideas during the camp, which helped in their overall development and growth. The total number of students who benefited from this camp was 464 (305 from Murbad and 159 from Vangani).

## CSR ACTIVITIES

### Samata Equal Footing Foundation

In October 2021, Child Help Foundation in collaboration with Samata Equal Footing Foundation established its first Mini Science Center in the Sakhare Ashram Shala to help students understand scientific and mathematical concepts with practical knowledge. The MSCs include 79 plugins and play models that are useful to the students. Every year, over 377 students benefit from knowing various scientific and math modules. The one-day teacher training program prepares and trains teachers to utilize these tools effectively.



### ABB Hitachi

ABB Hitachi donated to our medical emergency support program for children suffering from cancer and kidney transplants. This required a large amount of money for the whole treatment. Even the pediatric patients of certain terminal illnesses were supported with the help of ABB Hitachi. They donated Rs 20,00,000/- for 4 children's medical support.





## CSR ACTIVITIES

### ITC Juice Distribution

ITC Limited, based in Kolkata, is an Indian corporation. There are 13 businesses in the corporation, divided into 5 segments. ITC distributed fruit juices and Tetra juice packs to the underprivileged in regions such as Bangalore, Kolkata, Odisha, Mumbai, and others, helping almost 20,000 people across India. These juices have a high nutritional content for children, providing them with energy and quick power to help them get through any activity.



### Alkem Pharmaceuticals

In collaboration with Alkem Laboratories and the Central Railways (Mumbai), Child Help Foundation inaugurated a Baby Feeding Center (BFC) at Kurla Railway Station and Kalyan Railway Station on 27th July 2021 to facilitate nursing mothers. Around 1080 mothers have benefited from this.



## OTHER ACTIVITIES

### Independence Day

Even after 75 years of Independence, the children of our country are struggling for freedom from various social challenges. It is imperative to change this status, empower them and bring a perspective shift in the country. Every year on the eve of Independence Day, we contribute by participating in practical activities like distribution drives to instill hope and joy among children.

This year, Child Help Foundation distributed ITC B-Real fruit juice boxes, fresh milk, biscuits, Bata shoes, and uniforms among 150 underprivileged children in UttarPara, Kolkata; and sweets and soft toys among 85 children from Mehul Nagar, Mumbai. Snacks were distributed among 30 students of Z.P. School, Umele Village, and 50 students of Rajawali School, Mumbai. ### Christmas Celebration

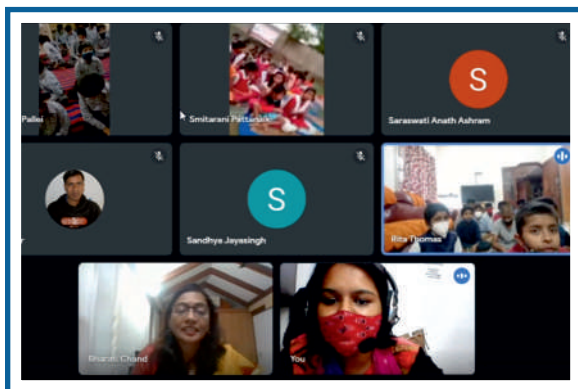
