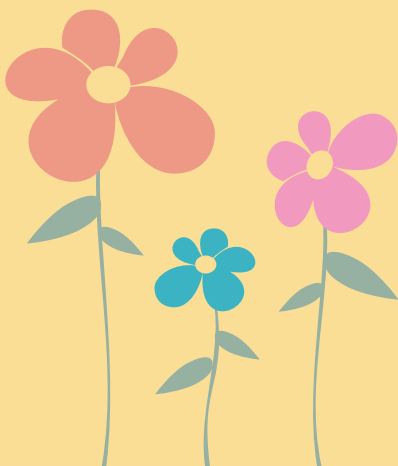

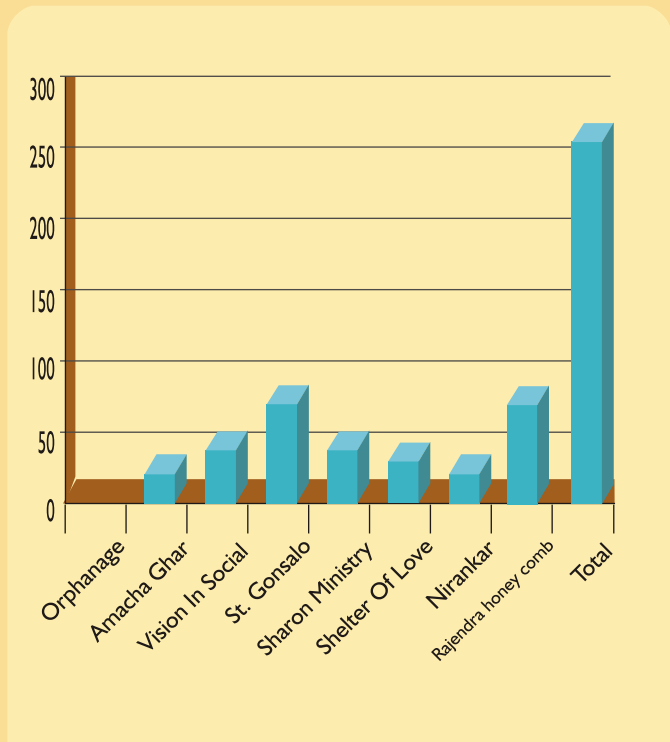
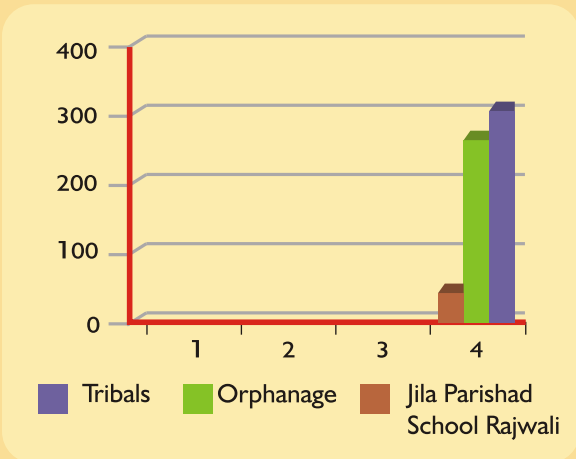
Our programs focused on the vulnerable children for their safety, education and well-being.

Today we are supporting a total number of 762 children in India. We are supporting around 300 tribal children in Maharashtra & Karnataka

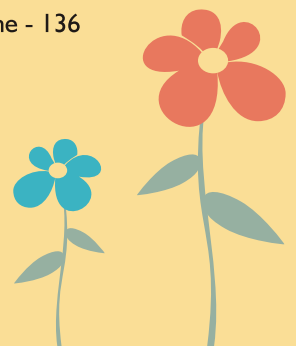
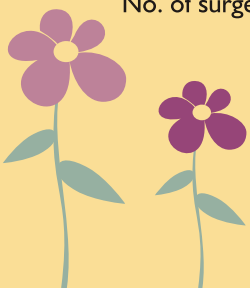

## Girl Child Education:

Child Help Foundation believes that inclusion of girls is only possible through parental engagement and community involvement. Therefore, we believe in empowering girls through education. Educating a girl child can quickly solve immense amounts of social issues that have been prying over the country. Since literacy helps to form a strong foundation based on knowledge, truth and moral values, which if imbibed in a girl child, will only prove to benefit the family that she either belongs to or will be going to in the future. It comes out to be an asset, having female children educated.

Child Help Foundation Committee has laid down some essential steps in order to eradicate or lessen the bias attitudes of the families towards educating a girl child; which we have been following consistently.

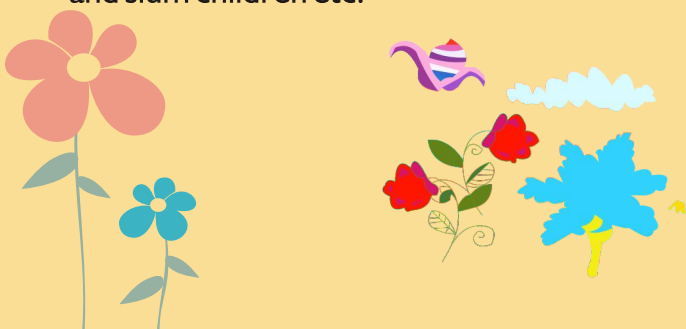


These include:

- Informing the families and parents about the importance of education and motivating them to bestow proper education for their female children particularly.
- Inculcating belief that whether you are addressing healthcare, poverty, population control, unemployment or human rights there's no better place to start than in the corridors of education.

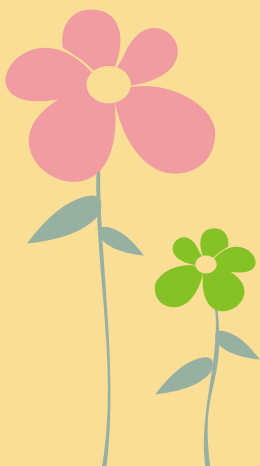

## Orphanage Support Programme:

Child Help Foundation provides shelter, food, clothing and education to the orphan children and also covers their medical expenses. Child Help Foundation gives a holistic approach towards the underprivileged children through 3 orphanages. Two such orphanages namely Vision in Social Arena (Anmol Home) and Shri Rajendra Honeycomb Charitable Children's Trust (Bal Ashram) are both located in Thane District. Anmol Home shelters street children where in 40 school going children are living under healthy circumstances currently. Where as, Bal Ashram comprises of 50 school going children. The third orphanage Karunalaya (Sharon Ministry of Tribals) located in Bengaluru takes care of 42 children.

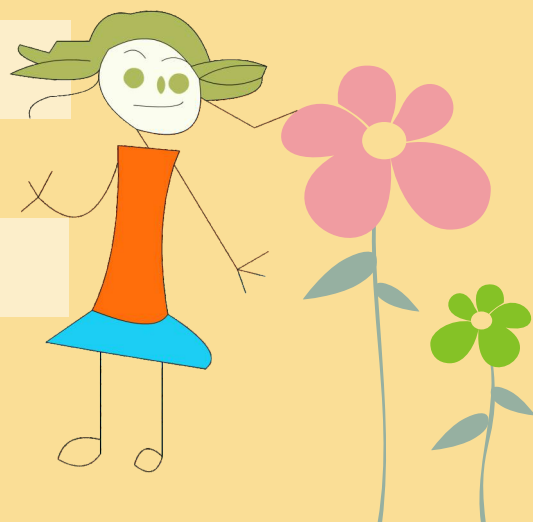

# Educational Support Program

Through this program we support the educational responsibilities of all rural and underprivileged children who are not economically capable of buying an education. With the absence of proper educators to learn from and guidelines to follow, the children in the rural areas are often misguided. Their chance to grow as individuals has been compromised on due to the shortage of real education at an affordable price.

We fulfill their needs by enhancing their computer skills, providing English educators, toys and comics for recreational purposes, a well suited library, good clothes, educational books, school benches and other stationery items like pencil sets and school bags. **Because we believe economic disparities should never stand as an obstacle between a student and his education.**

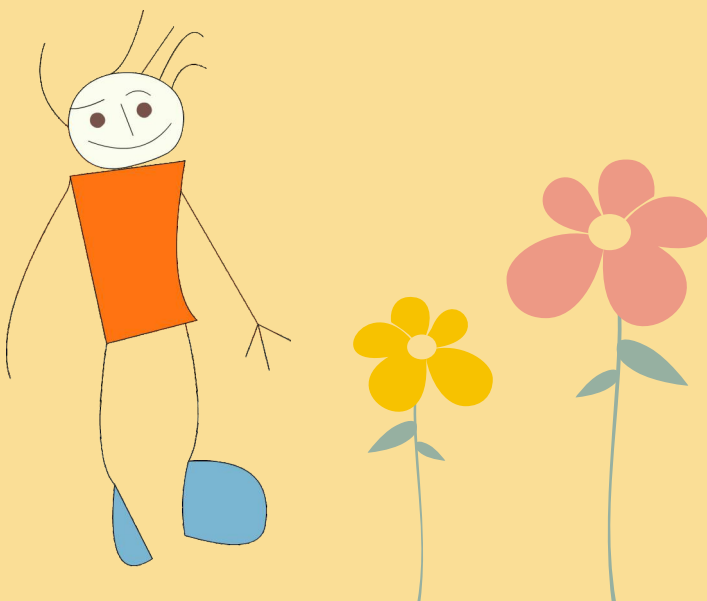

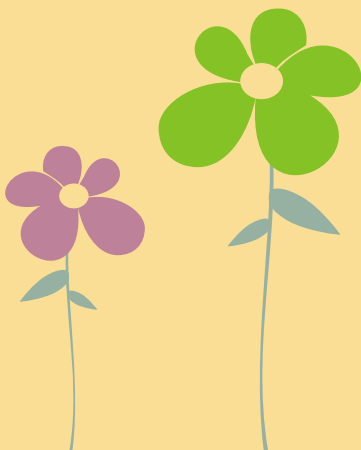


# Education Support Program

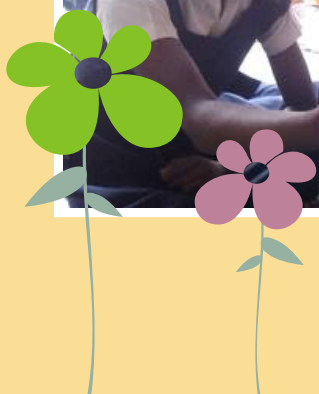

## Case Story of Baby Bhumika



Mr. Mangesh Sawant from Bhandup was working as an office assistant at Navi Mumbai. Due to his financial condition he could not afford the operation of his four month old baby girl Bhumika. The baby required immediate medical surgery and had to be admitted soon. She required an early closure of Ventricular Septal (a hole in her heart). She had already undergone one operation but since the case was critical and she needed another heart surgery at Seven Hills Hospital, Mumbai; the case was referred to our NGO Child Help Foundation for financial help. Baby Bhumika is now in good health.



## Case Story of Manisha Rajput



Mr. Prabhat Singh Rajput working as a helper and earning only Rs.5000/- per month was the only earning member of the family. Financially he was not in a position to pay the entire surgery cost of his 6 year old baby Manisha Rajput who was diagnosed with "Intra Cardiac Repair" (a hole in her heart). She got operated at Prince Aly Khan Hospital, Mazagaon, Mumbai. Child Help Foundation helped this case financially and now she is in good health.



## Case Story of Shejal:



Shejal a 13 year old girl child from Andheri, Mumbai had gone for a wedding at Malad and during the ceremony she fell unconscious. After diagnosis doctors came to know that she had a hole in her heart. She was immediately admitted to the ICU of Riddhi Vinayak Critical Care & Cardiac Center at Malad, Mumbai and was successfully operated. Her families financial condition was not good as her mother was the only earning member & worked as a domestic maid. Child Help Foundation successfully raised the funds for the child's operation. She is in good health and is continuing her education.

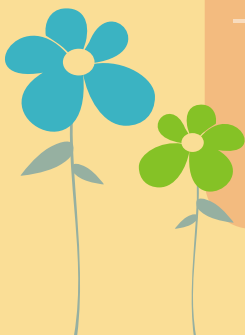


## Medical Support Program:

- Amar Jawan Jyoti Hospital located in Rewari, Haryana a proposed 50 bed multi speciality hospital project to help the needy

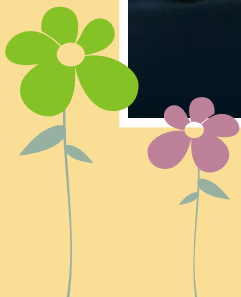

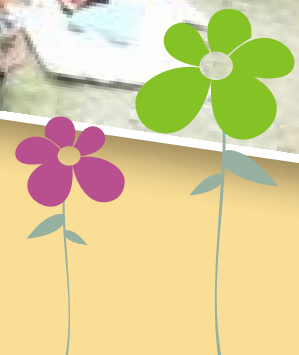
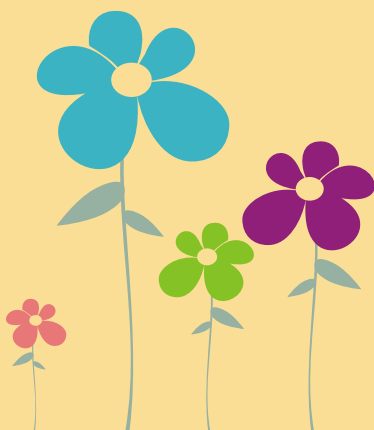




# Calamity Relief Program

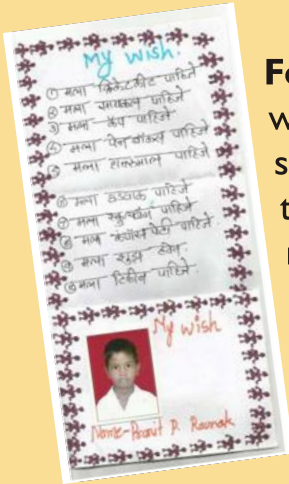

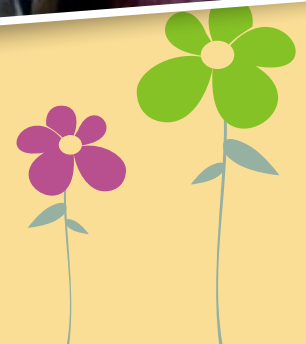


carrying a school bags they used to bring the books in a plastic or a cloth bag. They were proud to own a school bag, a tiffin box and a water bottle.

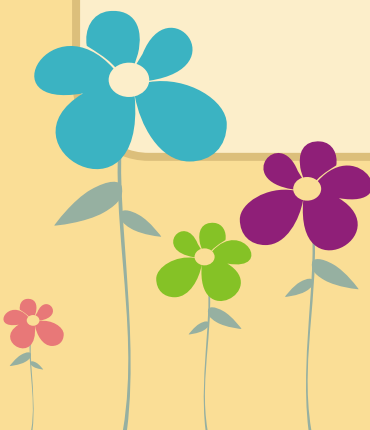

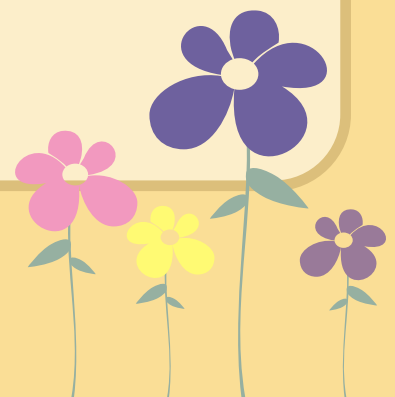
The school was located in Rajawali, Naigaon (East). We began our first social outreach on 17th October 2013. The journey to the school itself was a difficult one, with the school being in a very remote area of Naigaon and the lack of frequent rickshaw services. But we did not let that deter our spirits. The school was fair enough to satisfy every child's requirement and the teachers too seemed to be loving and dedicated. They were more than happy to have us at their aid and help them in teaching students from Class 1 to the Class 8th. Despite of language barrier i.e. lack of fluency in Marathi, we performed our teaching services satisfactorily with the immediate feedback from the children themselves asking us “to come back”- a reward in itself. The children from Rajawali school taught us or rather I would say were a perfect example for us.

- They found happiness in simplicity.
- Were free from pride and prejudice.
- They were contented with all they had which was nothing at all-no shoes, torn clothes, books just to fulfill temporary needs and many other things we affluent will ignore.
- Thus to conclude, the Social Outreach Program was ended with a turning point and we all are grateful to our college for bringing, us there, to that point where “Greed is differentiated by Hunger and wants are differentiated by Needs”.

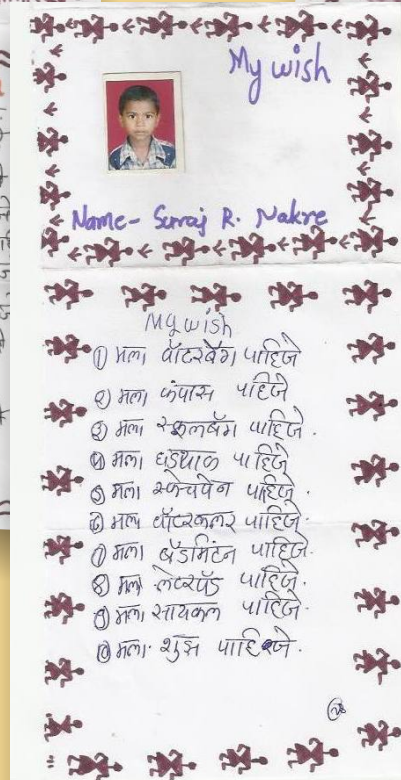
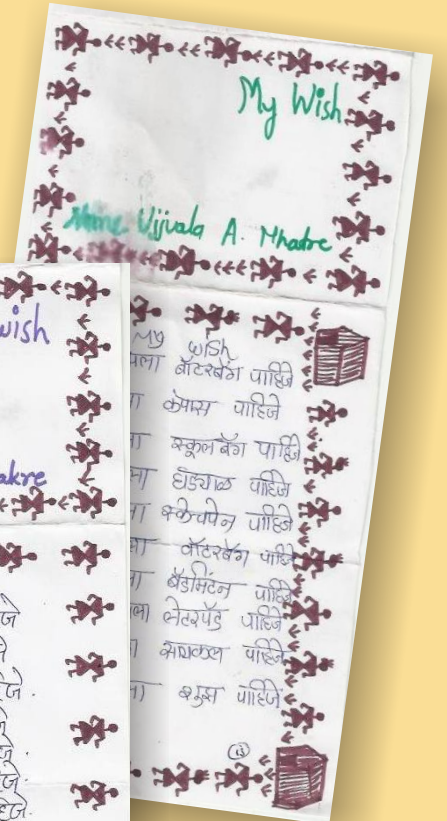
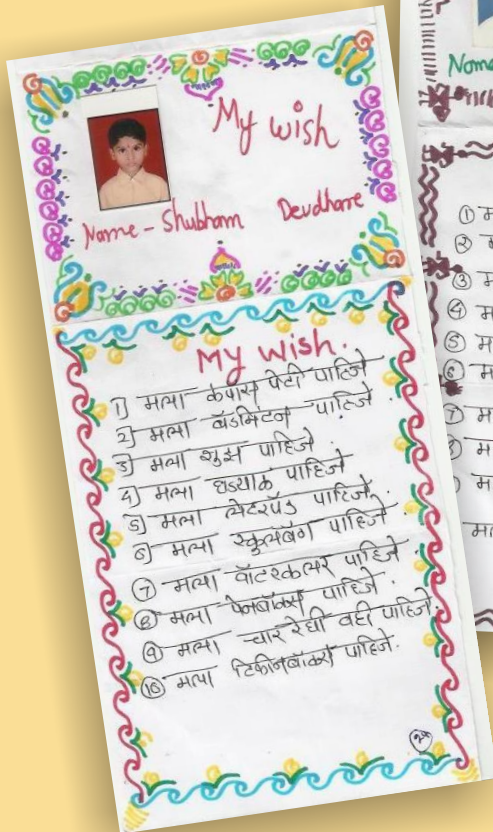
