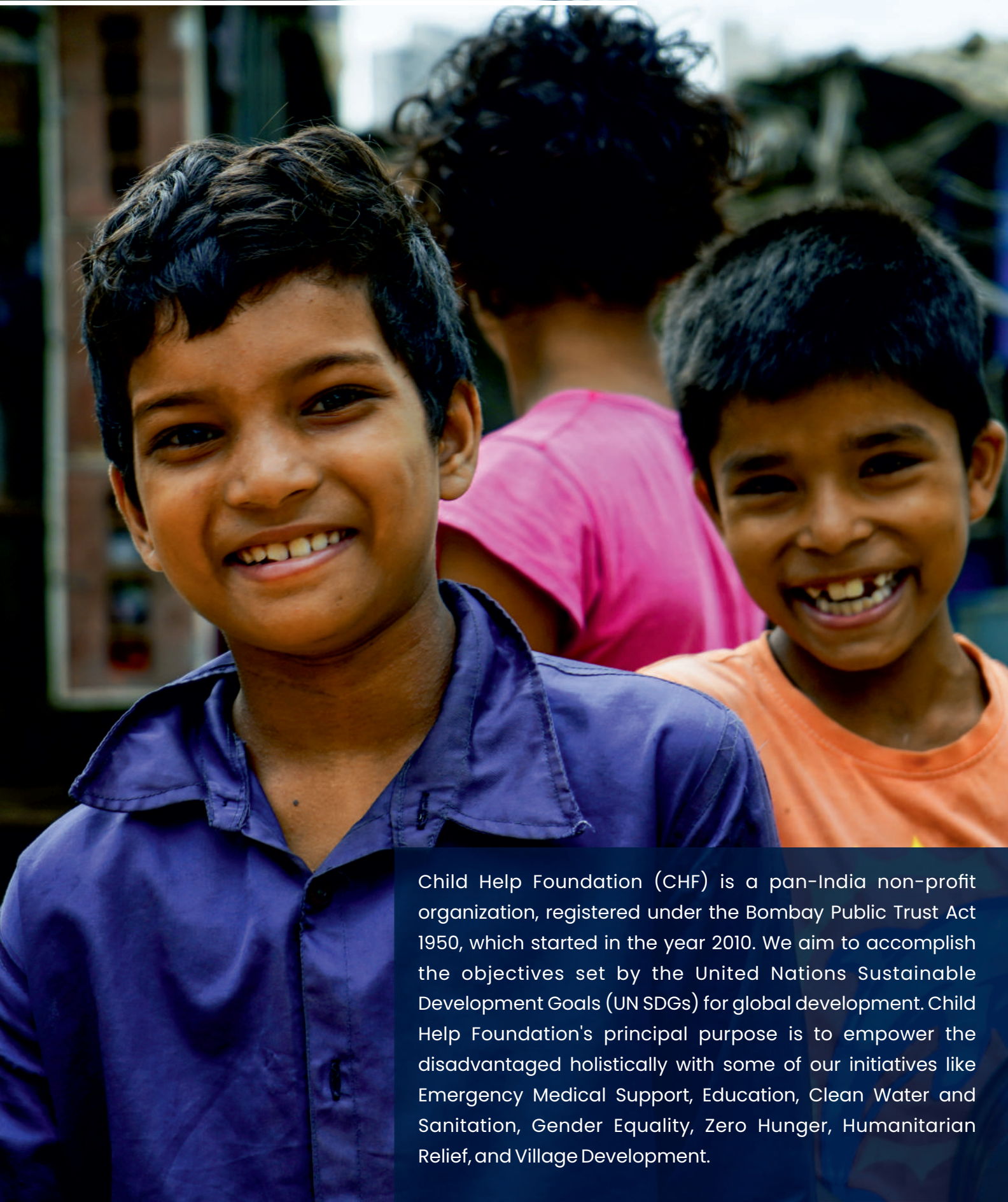

## Help 4 months Sarthak in his battle against a rare genetic disorder

"We were trying to have a child for a long time but we could not conceive normally so we decided to take help of In Vitro Fertilization (IVF). After 6 years we finally conceived and we had our precious little baby boy. When we saw him in pain for the first time, we had lost all our hopes. We have only been running from one hospital to another. I feel so helpless."-

Anup Kumar Das ; (Father)

Sarthak Das is a four-months-old baby of Mr. Anup Kumar Das and Mrs. Soma Das. They hail from Jamtara, Jharkhand. The father works as an CISF (Central Industrial Security Force) constable and single handedly takes care of his joint family. One fine day, the father saw that Sarthak was shivering and having seizures and they immediately rushed him to the nearest hospital. After undergoing several tests, he was diagnosed with Primary Hyperoxaluria. It is a rare genetic condition present at birth. In simple terms, the liver does not create certain proteins and stops functioning. If left untreated, it spreads its malfunctioning effect on other organs of the body.

Initially at Apollo Hospital in Kolkata, the patient was kept under dialysis till any further proposal of intervention was recommended. The parents took a personal loan of Rs. 14,32,000/- to bear the costs. Sarthak is now in need of a liver transplant. He is admitted at the Rela Hospital, Chennai. The estimated cost of the current treatment is Rs 22,00,000/- (Rupees Twenty Two Lakhs only). The parents have no means left to meet this financial requirement. They need your support to help their ailing child.

Sarthak is in a critical condition where his body is unable to respond to natural urges. His treatment journey is longer than just a liver transplant. He will also need to undergo a kidney transplant as he grows older. Be a small part of helping him have a normal life ahead.

# Success Stories



**Warisha Khan**

Warisha Khan is a 13-year-old girl residing in Kolkata, West Bengal. She was diagnosed with End-Stage Renal disease in 2017 after which she was kept on dialysis for 4.5 years. The doctors at the CK Birla Hospital, Kolkata suggested a kidney transplant as the only resolution for Warisha's medical condition. The estimated cost of this treatment was Rs. 10,55,000/- (Rupees Ten Lakhs Fifty Five Thousand Only). Mr. Asjad Khan (father) is a part time assistant accountant at a private firm and he could not arrange this kind of money for his daughter's treatment. Child Help Foundation came forward to help the family in arranging the funds and the transplant was successful.



**Mohd. Husain**

Mr. Afjal And Mrs. Shahnaz Hussain welcomed their third child, Mohd. Husain on 26th August 2020. Little Hussain was diagnosed with Congenital Heart Disease after he was born. At the age of around 1 year, the baby underwent his first operation at the Indraprastha Apollo Hospital, Delhi. The surgery was just phase one of the complete treatment. While Child Help Foundation had supported the family financially for the first operation. The family needed help with arranging the amount of Rs. 4,00,000/- (Rupees Four Lakhs only) for the second Bi-directional Glenn Operation. The father, Mr. Afjal, works as a truck driver on a salary of roughly Rs. 6000 per month to provide for his family of five. In such a scenario, it was impossible for him to pay for his child's health needs. So, Child Help Foundation took further steps in ensuring that Mohd. Husain was successfully operated.



**Andriya Sanil**

Andriya Sanil is a 1-year-old baby girl from Ernakulam, Kerala. Her father Mr. Sanil Varghese works as a daily wage laborer to support his family of seven. At 3 months of age, the baby was diagnosed with Multi Sutural Craniosynostosis. After a successful surgical intervention at the Amrita Institute of Medical Sciences and Research Centre, Kochi, the doctors advised that a Craniofacial Major Procedure (2nd stage surgery) only would complete her treatment. The estimated cost of this surgery is Rs. 3,98,500/- (Rupees Three Lakhs Ninety Eight Thousand And Five Hundred Only). Child Help Foundation was successful in helping Andriya with her complete treatment.



# Success Stories



**Aadi Pakole**

14 months old Aadi is the son of Mr. Nilesh and Mrs. Shridevi Pakole from Pune, Maharashtra. He was born with a complex heart defect called Pulmonary Valve Stenosis. At the Aims Hospital, Pune, the doctors advised urgent medical management following the Balloon Pulmonary Valvuloplasty heart procedure. The estimated cost of the treatment is Rs. 2,55,000/- (Rupees Two Lakhs Fifty-Five Thousand Only). Aadi's parents had spent all their savings on his medical procedures and tests. Then parents then reached out to Child Help Foundation for support. We helped the family in arranging the funds and the treatment was successfully undertaken.



**B/O Sandhya Rani**

Sandhya Rani gave birth to a premature baby boy on 28th Sept. 2022. The baby was suffering from severe symptoms of prematurity, his lungs and eyes hadn't developed properly. The doctors at the Renova Neelima Hospital, Hyderabad had suggested a prolonged NICU stay as a part of his treatment. The estimated cost was Rs. 8,00,000/- (Rupees Eight Lakhs Only). The baby's father who worked as a cab driver could not afford the prolonged medical care and he reached out to us. Child Help Foundation extended support for the care of the child.



**Jinu Jossy**

Jinu Jossy is a school going girl of Mr. Jossy Abraham and Mrs. Bindhu Jossy. Her father is a daily wage worker at a farm and mother is a housewife who takes care of their three children. She was diagnosed with Spherocytosis with Cholecystitis Refractory ITP at a very early age and was consistently provided with treatment at a government hospital. After turning 13 years, the doctors of Aster Medcity in Kochi, Kerala advised Splenectomy Laparoscopic Level 1 and Cholecystectomy Lap Level 1. The estimated cost of which is Rs. 3,50,000/- (Three Lakhs and Fifty Thousand Rupees only). Her parents and relatives had already exhausted all their savings in years of hospital visits. Child Help Foundation thus helped Jinu Jossy with her final treatment towards a healthy life.

# Success Stories



**Arshan**

Five-year-old Arshan from Hasanpur, Uttar Pradesh, suffered from TOF with multiple AP collaterals (a combination of four different congenital heart defects). The family was advised to take their son to Paras Hospital, Bihar, for a Cardiac cath study with tetralogy of fallot repair. They were informed that the treatment would cost Rs. 4,50,000/- (Rupees Four Lakhs Fifty Thousand Only). Arshan's father is a labourer and earns only around Rs. 5000/- per month. It was impossible for him to pay such a huge amount. Child Help Foundation thus completed the necessary verification and helped the family in arranging funds for Arshan's treatment.



**Lochan Bhandari**

9-year-old Lochan Bhandari who originally hails from Nepal but has been living in Bhiwandi, Thane, for the treatment of his heart defect. His medical diagnosis stated Mod-Severe TR, Small VSD, S/P VSD Closure. The doctors of Fortis Hospital, Mulund, Maharashtra advised Lochan to undergo a VSD-closure, Redo TV Repair + residual Vsd Closure + CT Scan surgery. The surgery was already delayed because of the family's financial conditions. The family found out about Child Help Foundation and reached out for help with the treatment costs worth Rs. 2,87,000/- (Rupees Two Lakh Eighty Seven Thousand only). The surgery was done and Lochan has been discharged.



**Aditi Shinde**

Aditi Shinde, suffering from cold and cough, also complained about severe chest pain. The doctors diagnosed her with Osteosarcoma (type of cancer in bone). She was then suggested to undergo Radiations with Supportive Care and Chemotherapy at the HGC Manavata Cancer Centre, Nashik. The father Mr. Kailas Shinde worked on a contract basis to serve a family of 6 members. He was unable to pay for his daughter's treatment. He came to Child Help Foundation for help. With the support of our donors, we were able to help the family with arrangement of funds and her treatment was successful.



# Success Stories



**Krutika**

After 11-year-old Krutika had started suffering from stomach ache and vomiting, she underwent tests to find out the underlying reason for her severe condition. She was then diagnosed with T Cell Lymphoma. She was admitted at the HGC Manavata Cancer Centre in Nashik, Maharashtra. Her Chemotherapy treatment costs were Rs. 6,00,000 (Rupees Six Lakhs only) The family asked Child Help Foundation for help. With the support and prolonged medical care, Krutika has now completely recovered and is doing well.



**Parimita**

Parimita was suffering from a severe cough for a long time before being taken to the doctor for intervention. She was diagnosed with a deadly cancer in August 2019 which was when the chemotherapy was initially started. 3 high dose cycles of chemotherapy have been completed. But Parimita was in need of further treatment. The family of four was being supported by the father who works as an electrician. The mother is a housewife. The family manages to spend their livelihood with a minimal income of Rs. 5000-8000 per month. It was becoming difficult for them to find any help for Parimita. Child Help Foundation then supported the family through the entire treatment procedure. Parimita is now going to school and doing very well.



# How Adopting a Child Creates a Better Family

Adoption can be defined in various ways through different perspectives. Most simply put, adoption is a legal process in which the rights and responsibilities of a child are transferred from biological parents to the adoptive parents. It is a means to create a family, provide safety, love, care and material needs to someone. You may adopt someone who does not have a parent or someone whose parents are incapable of taking care of their child. In any of the conditions, adoption is about the welfare of the child in the picture.

In the process of adoption, every person involved faces challenges. But the most unstable ones are those faced by the child himself/herself. They have a lot of dilemmas in their mind which needs to be dealt with patiently. The new parent child relationship requires delicate nurturing and persistent efforts in helping the child bond, build trust and adapt to a new home environment. Adoption makes families go through a long process of acceptance but it is all worth it.

## Reasons to Consider Adoption:

### 1. To create a progressive family

Every human needs to bond with other humans to survive. We are all a part of the global family where humanitarian connection is the most supreme. However, a close knit connection only exists between a few people which we call our family. When we talk about family, we relate the conditions of sharing the same genes, blood, DNA and last names. We associate creating a family with giving birth to our own child. However, Family is not about the biological bond, but about who shares a home and stays with us at good and bad times. Creating a family through adoption is one of the best ways to do it.

### 2. For the Social Good

World is a beautiful place but the circumstances are differently difficult for each one of us. Together, we are better able to face them. As members of the society, we all want to give back in some way. Charity is one of the options that helps so many underprivileged kids every day. However, it is one sided. Adopting someone and building a relationship is a two way street that does good for both the persons involved. Eventually, making society a better place.

### 3. Better use of your resources

Some of us are conventionally successful but are lonely inside. Some do not even have the resources to source meals for a day. The economic divide in any country is unfairly distributed. Maintaining equity in such a scenario is difficult. However, as sensible citizens, we can always choose to put our resources to better use and help someone in need. It also serves our emotional need of being there for someone and having them for ourselves.

### 4. Witness selfless love for a child

Children make one's world shine. They bring the best out of us. That's why Indian families stress on bearing children. But adopting a child and loving them selflessly is a different feeling that amplifies any home environment. Each member of the family learns and practices the art of sharing selflessly.

### • Visit to Baby Feeding Centers in Kerala

On the 29th November 2022, Mr. K. N. Ninan, Resource Mobilization Manager & Kerala Medical in-charge visited Baby Feeding Centers at the Lakeshore Hospital, Chottanikkara Temple, and General Hospital in Ernakulam, Kerala. As per the feedback received from beneficiaries, the Baby Feeding Center (BFC) has been useful and helpful for them.

Mr. K. N. Ninan recorded the current status regarding the utilization of BFC:

- Chottanikkara Temple's average usage per day has increased to 60.
- Lakeshore Hospital's average usage per day is 14.
- General Hospital, Ernakulum, average usage per day is 13.



### • Visit to Baby Feeding Centers in Palghar & Boisar, Maharashtra

On 5th November 2022, Sandra D'Souza, Project Team Member visited Baby Feeding Centers in Palghar and Boisar. Observations made during the visit are: At the Baby Feeding Center at Boisar, it was observed by the project team member that 4-5 mothers benefited from the center every day. The changes required were also noticed.

The teachers of the school were given the feedback that the confidence of some of the students needs to be boosted.



#### • **Murbad Ashram School, Palghar District, Maharashtra**

On 22nd November 2022, project team members Ms. Chris Shenoy, Ms. Neha Y. Singh and Ms. Jyoti Kamble paid the monthly visit to the Mini Science Centre (MSC) at Murbad Ashram School in Palghar, Maharashtra and also attended the Science Exhibition. A session was conducted with the students on science and maths by Ms. Chris Shenoy. It was observed that the models and the boards at the MSC were not displayed properly. The shelves were not maintained. Feedback was given to the school authorities.



#### • **Vangani Ashram School, Palghar District, Maharashtra**

On 24th November 2022, project team members Ms. Neha Y. Singh and Ms. Jyoti Kamble visited the Mini Science Centre(MSC) at Vangani Ashram School in Palghar, Maharashtra. During the monthly visit, they also attended the Science Exhibition where children presented their projects. It was observed that the models in the MSC were organised properly. The teachers had been taking regular classes and had benefited the children. The next teacher training for utilising the models is planned in December.

## SDG4: QUALITY EDUCATION

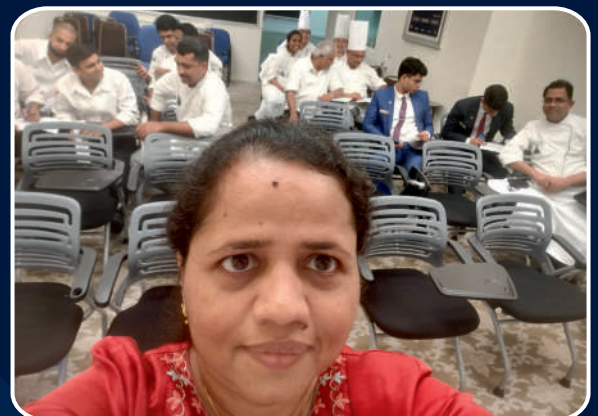
### • Training on POCSO and POSH, Jawhar, Palghar, Maharashtra

On 16th November 2022, training on POCSO and POSH were conducted by the team members of Child Help Foundation, Ms. Meena Lokhande and Ms. Jyoti Kamble for the teachers and staff of seven Ashram Schools at the Vinval Ashram School in Jawhar, Palghar, Maharashtra. The sessions were conducted in two parts. The first part was regarding POSH (Prevention of Sexual Harassment at Workplace) and the latter part was on POCSO (Protection of Children from Sexual Offences). Each session took 2 hours and 30 minutes and was followed by a question answer round with the participants. There was also a meeting with the school principals and the Project Officers of ITDP (Integrated Tribal Development Project) regarding the organization of training sessions for the teachers of other schools in Palghar district. During the first part of the session, provisions of POSH were elaborated and discussions were held on formation of Committee, POSH cases, gender equality, and responsibilities of the principals of the school. POCSO Act was explained in the second part where discussions were about the sensitivity of cases, the confidentiality aspect, mandatory reporting, and formation of Child Protection Cell at the School Level. The participants shared positive feedback about the session.



### • Training on POSH, Mumbai, Maharashtra

In November 2022, three sessions were conducted on POSH at hotel Taj Mahal Palace. The number of attendees on 9th November, 10th November and 11th November were 110, 136 and 80 respectively. The sessions were also screened online for the employees of FSG. The count of online attendees was 36. The feedback response from the attendees was positive.

## SDG4: QUALITY EDUCATION

### • **Session on Ethics of Leadership in Sports, Mumbai, Maharashtra**

On 1st November 2022, a brief introduction about Child Help Foundation was given to the volunteers of Swami Vivekananda College by our project team member Ms. Neha Y. Singh. The volunteers conducted a session on Ethics in Leadership in Sports for the children of

Miragaon Community. They explained about the virtues of respect and dedication. They were also taught some of the ways to enhance communication skills. Examples of some cricketers were shared with the children.

### • **Education Support to Siddhesh Balchede, Mumbai, Maharashtra**

On 26th November 2022, Educational Scholarship was given to Master Siddhesh Belchade. He is a 10th grade student who is very brilliant in his studies. He will be appearing for his board exams. Mr. Prashant (father) has left the family and never returned back. Mrs. Yogita (mother) who takes care of Siddhesh and his elder brother Hithesh could not afford to pay his fees. She works as a housekeeper and earns an income of Rs 10,000/- (Rupees Ten Thousand Only). She somehow manages the needs of her children, household expenses and also pays a house rent. Siddhesh's school fees for the academic year is Rs. 21,100/- of which they have managed to pay Rs. 6,000/- borrowing it from other people. The family is now struggling to pay the remaining amount. Child Help Foundation supported him with the fees of Rs 15,100/-.



### • **Capacity Building Workshop in Schools Dimapur, Nagaland**

In the month of November 2022, a workshop on Capacity Building was organised by Ms. Yashika of Child Help Foundation at Dimapur, Nagaland. Meetings with parents and teachers and outdoor activities related to educational learning were conducted by team.

## SDG2: ZERO HUNGER

### • Roti Ghar

Child Help Foundation in collaboration with Roti Ghar provided cooked food to 1,800 children in Mumbai, Thane, Airoli, Delhi, Bengaluru, Chilika, and Hyderabad. Our main aim is to provide food to the needy children and make their future bright and better. By providing nourishing meals, we ensure that health goals and hunger needs of the children are met. In November 2022, members of the Digital Team visited the project locations for the purpose of monitoring and evaluation.



## SDG5: GENDER EQUALITY

### • Awareness Sessions on Gender Equality, Naigaon, Maharashtra

On 23rd November and 24th November 2022, awareness sessions on Gender Equality was conducted by Ms. Linsa (TBZ Representative), at three schools namely Zila Parishad Shala in Umela, Naigaon-West, Zila Parishad School, Naigaon and Zila Parishad School Umelman, Vasai, Maharashtra. The

beneficiaries in each school were 47, 26 and 20 respectively. The awareness sessions were about equality of both genders. It was explained through lessons on equality related to caste, gender, income, height, dress, and wealth, Resource persons also had a talk on social well-being and respecting each gender. Students responded very well to the questions asked by the resource person. There was a lot of enthusiasm shown by the students for the awareness session. The teachers and principal requested to have such activities in the future also.

### • Cloth Bag Making Workshop in Nashik, Maharashtra

On 11th November 2022, Child Help Foundation organized a workshop on making Cloth Bags with the help of India Infoline Foundation. Using simple techniques to make cloth bags from pieces of old clothes was taught by the project team member, Ms. Shilpa Lokhande. Some beneficiaries used tailoring machines for stitching work while others hand stitched the bags. The participants used their creativity and skills to create bags of various types and sizes. Simple techniques and measurement patterns were shared with the beneficiaries. A total of 10 women attended the training and 16 cloth bags were produced during the training. According to the feedback received, they liked the training and needed to visit the factory to sharpen their skills.

### • Blankets Distribution at Anugraha Seva Mandal, Ambarnath, Maharashtra

On 11th November 2022, blankets were distributed to 35 girl children of Anugraha Seva Mandal, Ambarnath, Maharashtra. These beneficiaries are the orphan children of nearby areas. 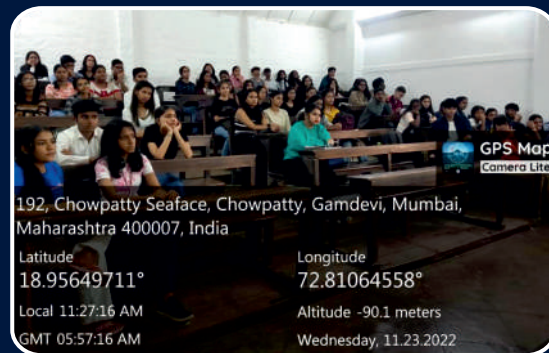

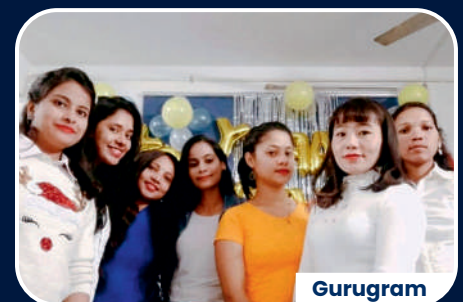
