Manreet Kaur



Mr. Manpreet Singh and Mrs. Tejinder Kaur from Firozpur, Punjab became the proud parents of a now seven-month-old baby girl named Manreet Kaur and all they felt was gratitude for receiving the best gift they could have thought of. They couldn't have been happier as excited as they were for the birth of their daughter. It was the beginning of a fairy tale.

Manreet's body would often turn blue and that she started to have difficulties in breathing. Worried and heartbroken, they rushed to the nearest hospitals and reached out to doctors to figure out what was wrong with Manreet. After going through multiple tests, they found out that there was a hole in Manreet's heart. To seek better medical treatment they were advised to take their daughter to Paras Hospital in Gurugram, Haryana. Manreet often suffers from cold, cough, and high fever and upon further inspection of her reports, the doctors at the Paras Hospital concluded that she would need to undergo an Open Heart Surgery. The estimated cost of which is Rs.4,00,000/-.

Her parents want to start her treatment as early as possible, but their financial conditions are making it extremely difficult to do so, since Manreet's father is a farm laborer and only earns Rs.7,000/- a month, and her mother is a homemaker. Mr. Manpreet is the sole bread earner in their family and after exhausting all of their family's savings in her tests and medical treatment so far. The expense of the surgery is massive for a family dependent on sole earnings and they are struggling to arrange the money for their baby girl's treatment. The family has reached out to Child Help Foundation for financial assistance.

Twins of Mrs. Madhuri Vidhate



Welcoming a child into the world is one of the purest moments of joy that a parent feels and that is what Mr. Ravindra Vidhate and Mrs. Madhuri Vidhate were expecting. They were thrown into a situation of peril when their twin children were born prematurely and needed medical attention. As a consequence of premature delivery, and the complications arising from the same, the children are currently undergoing treatment in a NICU, at Mala New Born And Children's Hospital in Thane.

Seeing their children struggling and dependent on tubes and machines and external oxygen support has been heartbreaking for the parents. Mr. Ravindra Vidhate is the sole earner in a family of six including his wife, his parents, and their newborn twins. He works as a back office employee earning an estimated Rs. 8,000/- per month. The required amount of money for the complete treatment is Rs.10,00,000/-. The family has already spent all of their savings and Mr. Vidhate is unable to secure any further loans. They are in immediate need of financial aid and they reached out to the Child Help Foundation to help them with financial assistance.

Snehitha

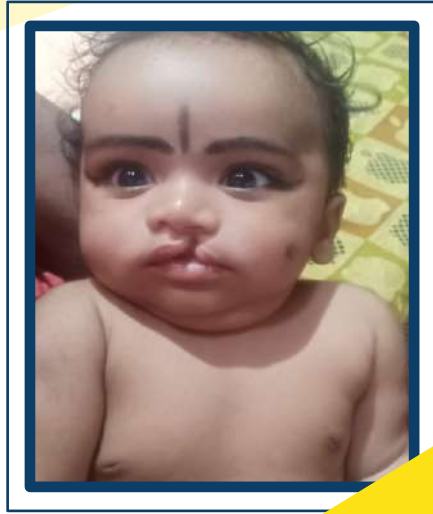


Snehitha is a young, vibrant 12-year-old from the Khammam district in Telangana. She is the eldest daughter of Mr. Hari Boda and Mrs. Bhadramma who works as daily wage farm workers and she has a younger sister Rishita who is 7-years old. The happy family of four lives in a rented house that costs about Rs.1,500/- a month consisting of two daughters that the parents believe are the angels of their family. Unexpectedly, Snehitha started falling ill and after she complained of severe stomach aches, the parents took her to the Rainbow Children's Hospital, Hyderabad, Telangana. The doctors at the hospital ran multiple tests on Snehitha and after a detailed analysis diagnosed her with End-Stage Kidney Disease Secondary to Bilateral Hypodysplastic Kidney in March of 2022.

The doctors have advised that a kidney Transplant is essential to her treatment of the disease. The estimated cost of the treatment is Rs.15,00,000 /-which is a huge amount of money for anybody but especially for people whose collective earning is Rs.9000/- a month. The earnings from both the parents go into supporting their family of four. The extended family and relatives of Snehitha were also doing their level best to help support her treatment but the sum of money required is extensive even after their support. They need all the financial support they can gather and they have reached out to the Child Help Foundation for financial assistance for Snehitha's treatment.

Shiv Dev



Mr. Arun Annukuttan and Mrs. Aswathy were delighted when they became parents to a beautiful little boy named Shiv Dev. The excitement and joy of a newborn only lasted a little while, because Shiv had to be kept under observation and in the hospital. After all, the little child was born with a facial defect known as Cleft Lip and Alveolus (an issue that is essentially a cut in the upper lip that extends to the nasal passage that is formed when facial structures of a child are developing in an unborn child).

Upon tests and diagnosis, the doctors have proposed a Cleft Lip Repair Surgery as a treatment for the defect, which according to the doctors if not treated in time can lead to other infections and such. The estimated cost of the surgery is Rs. 2,25,000/- which is a massive amount for Mr. Arun who works as a daily wage painter earning up to Rs. 600/- a day. The amount is not enough to support a family of five living in a rented home and paying Rs.6,000/- as rent. He is the sole bread earner in the family and they have already exhausted their savings and have even used the option of borrowing money from relatives and friends. They have reached out to the Child Help Foundation for financial assistance.

Warisha Khan



A bright 13-year-old girl Warisha Khan has been battling an End Stage Renal Disease for a few years now. Daughter of Mr. Asjad Khan And Mrs. Farhana, she has a 15-year-old brother named Arham, and the family is originally from Kaimur, Bihar. Warisha is a bright and talented girl who has had to go through a few painful years, which started first in 2017 when she complained of discoloration in her urine. This complaint would be the first of what would turn into many hospital visits over 4.5 years.

After undergoing many tests and getting treated at a local hospital in Bihar, for urine infection. When the problem persisted they moved to Kolkata to get Warisha treated at the Institute of Child Health in Kolkata. There she was diagnosed with a life-threatening disease and was kept on dialysis 3 days a week for 3 months, which was very difficult for the family.

In 2018, in hopes of better treatment, the family took the little girl to AIIMS Hospital, Delhi, but they echoed the same sentiment and assured the parents that being on dialysis was the best chance to keep Warisha safe. After which the family moved back to Kolkata for the treatment. The medical procedure and all the traveling and relocating have been very hard for the family. It has been financially and emotionally draining, especially since Mr. Asjad works as an assistant accounts manager. He can only work part-time and earns only Rs.8,000/- a month. Warisha requires kidney transplantation. The estimated amount of the treatment is Rs.10,55,000/-.The only hopeful light during this process is that Warisha's donor is her mother Farhana, however, finding financial help has been very difficult for the family. They are in urgent need of funds and they have reached out to Child Help Foundation for financial aid.

Mahboob Subhani

Little Mahboob Subhani is the five-month-old son of Mrs. Ruskan and Mr. Abdul. Baby Mahboob seemed healthy and fine the day he was born, so his parents took him home a couple of days later. Mahboob's birth made the whole family ecstatic and very joyful. But the family's days of happiness were very limited. Mr. Abdul and Mrs. Syed Ruskan were thrown into deep distress when they started noticing that their son often struggled to breathe and his legs developed a bluish discoloration. The parents took Mahboob to a local hospital, they found that the baby was diagnosed with Congenital Heart Disease (a heart defect that is present since birth).

Hoping for a better result, Mahboob's parents shifted him to Rainbow Children Hospital, Hyderabad for advanced treatment. The doctors suggested an open heart surgery as a method of treatment.

The estimated cost of which is massive and is estimated to be ₹ 4,00,000/-, which poses a challenge since Mr. Abdul is the only earning member of the family and he works as a daily wage laborer and earns up to Rs.400/- on the days he finds work. The family has exhausted almost all of their means and is now looking for external aid. Looking at their son going through this difficult time has been a struggle for the family and it is very heartbreaking. They have reached out to the Child Help Foundation to help with the financial support.



Divyanshu Kumar

Divyanshu Kumar, a seventeen-month-old beloved son to Mr. Hari Om Kumar and Mrs. Radha Kumari has never seen life without hospitals and needles. He was born with a heart defect at a small community hospital. Because there were not a lot of medical facilities available nearby the parents admitted him to Indira Gandhi Hospital in Bihar. Unfortunately, the doctors were unable to treat him and therefore they decided to move him to Raipur, Chhattisgarh for better treatment but they were met with disappointment yet again. Last hope came in the form of Mahavir Heart Hospital, Bihar where the doctors informed them that Divyanshu was supposed to undergo IntraCardiac Repair for VSD Closure Surgery a year ago and that a lot of time had been wasted because of his late diagnosis. His heart defect has worsened and that Divyanshu now requires an urgent Open Heart Surgery to survive.

Being the only earning member in a family of five, Mr. Hari Om Kumar works as a daily wage laborer earning up to Rs. 12,000/- per month and Mrs. Radha Kumari is a homemaker. The family consists of two more members, Divyanshu's grandmother and uncle. The family has exhausted their sources and they have even borrowed money from their relatives, they are still short of Rs. 2,82,500/- (Rupees Two Lakhs Eighty-Two Thousand Five Hundred Only) more for his surgery. This one-year-old child has been fighting for his life, and has only seen the hospital blinds, his parents are urging financial help and they have reached out to Child Help Foundation for help in accumulating funds for Divyanshu's treatment.

Ayush Phanse



When two-year-old Ayush Phanse was diagnosed with Acute Lymphoblastic Leukemia (blood cancer), after vomiting blood and being rushed to a local hospital, the lives of his parents changed unexpectedly. Ayush has been bravely going through chemotherapy and rigorous treatments for 2 years now. Mr. Shamrao And Mrs. Jayashree Phanse. Ayush has been the light of their lives since the day he was born, but things took a turn when he started falling sick 15 days after his birth and was rushed to a local hospital and then moved to Kolhapur Cancer Center Hospital, in Maharashtra.

The little child has been surviving on tubes and through sessions of intensive chemotherapy. The medical expenses have been extremely straining for the family. Mr. Shamrao who works as a semi-skilled worker at a clothing store is the only breadwinner and has to support a family of five from his salary of Rs.12,000/- a month. To continue his treatment and chemotherapy the family needs an estimate of Rs.8,00,000/-. The family has already used up all alternative methods by borrowing money and loans from family and friends. They are very deep into debt and have to reach out to Child Help Foundation for financial help.

Umar Ali



A sweet five-year-old Umar Ali, is a young boy from Kochi, Kerala. Umar's family consists of his father Mr. Sibab who worked as a daily wage laborer before, and his mother Mrs. Sanju, who is a homemaker. Umar also has two siblings and a grandmother, the family was really happy until Umar started falling sick in March 2022 and things have never been the same. When his mother Mrs. Sanju was doing her usual home chores and noticed that Umar was not feeling well and had a high fever. Despite being put on regular medicines when his fever did not budge they were admitted to a local hospital. After a few check-ups and thorough tests, Umar was diagnosed with Idiopathic Aplastic Anemia. It is a type of anemia in which the bone marrow stops making new blood cells. This moment defined and changed the fate of the family. Later, Umar was shifted to Aster Medicity Hospital, Kochi for better treatment.

The doctors suggested a stem cell transplant as a part of his treatment. The estimated cost of which is ₹ 29,75,000/- The amount is very huge in numbers and seemed impossible for Mr. Sibab who was a daily wage earner until he couldn't work anymore to take care of Umar. They are actively in search of a cell donor. This surgery needs to be performed urgently before it is too late to save the little boy. Umar is currently in ICU fighting for his life. It has been extremely hard for the family to see this little ray of sunshine of their family, stuck in hospital and hooked to wires and tubes to survive and battle for his life every day. They have reached out to the Child Help Foundation for financial aid.

Kartik Kamble



Kartik Kamble is a 6 year old little son of Mr. Nitin Kamble and Mrs. Shubhangi Kamble. Kartik also has a younger sister Kritika who is five, and the family is complete with his grandmother. The Kamble family hails from Osmanabad, Maharashtra where Mr. Nitin works as a daily wage laborer and earns about Rs.7,000/- a month while his wife is a homemaker.

A family with two young kids, vivacious and full of life, was met with a shock that nobody anticipated. After Kartik kept falling sick, he was taken to the hospital and after running tests the doctors announced to the parents that Kartik had a hole in his heart. The Kamble family was distraught and after consultation, the doctors suggested surgery as a method of treatment, but due to lack of financial stability and also considering that Kartik was a mere infant, the family decided to hold off the surgery until Kartik was a little older.

Kartik has been on medication to keep his health stable and is being treated at Balaji Hospital in Mumbai. This sweet little boy needs urgent ICR surgery for VSD Closure to be able to live his life without being tied to hospital tubes and machines and the procedure requires an estimated amount of Rs. 2,50,000/-. The amount is too hefty for the family to bear, especially since Mr. Nitiin is the sole earner in the family. The parents are looking for financial aid and have reached out to the Child Help Foundation for help.

Baby of Mrs. Pooja



Mr. Rambali and Mrs. Pooja who hail from Srikakulam, Andhra Pradesh, were waiting for the most exciting chapter of their lives becoming parents. They were really happy until their baby was born prematurely after Mrs.Pooja suffered from blood pressure fluctuations. And upon consultation, the doctors suggested that she might need an urgent C-Section Delivery since prolonged Pregnancy could put both the mother and the baby in harm's way.Mrs. Pooja gave birth to a premature baby boy on 12th May 2022. The baby's birth weight was 880 grams. The little boy has been under NICU support in Vijaya Marie hospital and Education Society, Hyderabad. He suffers from extreme prematurity along with sepsis (a condition that occurs when the body's response to an infection damages its tissues), and jaundice.

The doctors have advised continuing the NICU treatment for a few weeks for the baby to survive on his own. The estimated cost of the treatment is ₹ 2,00,000/-, which is a hefty amount. Mr. Rambali is the only income producer of the family and works as a car driver and earns Rs.15,000/- a month. He has used up a lot of the family's savings on the delivery and current treatments. The family needs urgent financial help and they have reached out to the Child Help Foundation for the same.

Twins of Mrs. Drisya

The birth of a child brings a joyful time in one's life and the birth of twins brings about double the joy. Unfortunately, The twin baby girls of Mrs. Drisya and Mr. Abhilash were born in the 32nd week of pregnancy, or 7.5 months. They suffer from extreme prematurity, low birth weight, and respiratory distress syndrome. The family of four lives in Calicut, Kerala. Mr. Abhilash is the sole income provider of the family by working as an autorickshaw driver and earns about Rs. 4,000/- per month only.

Due to complications in her pregnancy, Drisya's twin babies had to be delivered prematurely. Both babies weigh 1,270 grams and require NICU stay to maintain stability in their health. They are currently being treated at Star Care Hospital, Kerala and the family needs an estimated amount of Rs.5,00,000/- each totaling Rs.10, 00, 000/-. Abhilash has been disheartened by the suffering of his young babies and needs financial assistance. For help, he has reached out to the Child Help Foundation.



Bilvika

One year and eleven-month-old Bilvika is the younger daughter of Mr. Giribabu and Mrs. Yamuna. She has an elder sister Sanvika who is 4 years old. The family of four lives in a rented house in Godavarikhani, Telangana and pays a monthly rent of Rs. 1,600/- only. Mr. Giribabu is the income producer in the family working in a private company and he earns about Rs. 15,000/- per month.

Little Bilvika was born in the family's native place Godavarikhani at Sridevi hospital. Three days after her birth, Bilvika's health started deteriorating and she was diagnosed with a congenital heart defect around the same time when the country was under the first lockdown due to COVID-19. The parents who were tensed and worried became more paranoid because of the pressures added by the external COVID-19 situation.

They wandered from hospital to hospital for several months in search of the right treatment. They spent every penny they had on this entire procedure. For the travel and each hospital visit, he also had to borrow money from family and friends. Eventually, they arrived at Care Hospital in Hyderabad. The doctors here have recommended that Bilvika undergo a primum atrial septal defect disclosure and cleft repair procedure. This treatment is estimated to cost Rs. 5,00,000/-. Getting Bilvika to the right hospital has been financially draining, and since Mr. Giribabu does not have an additional source of income to be able to pay for the treatment, he has reached out to Child Help Foundation for financial assistance.

Baby of Jahana



During the seventh month of her pregnancy, Mrs. Jahana gave birth prematurely to a girl. Mr. Shabeer, the baby's father, recently joined a company that distributes medical supplies. In this family of six, which includes the baby's grandparents and uncle, he is the sole breadwinner. Mr. Shabeer earns Rs. 8,000/- per month. His family hails from Kozhikode in Kerala. During her pregnancy, Mrs. Jahana's uterus experienced some complications, and thus, she could not carry the baby for more than seven months. She lost her first child in March 2020, who was born prematurely as well. It is this sweet little girl who is the miracle baby in their family.

For the baby girl to develop fully, the doctors at Iqraa Hospital in Kerala have recommended a prolonged NICU stay. This is estimated to cost Rs. 3,00,000/-. To pay for his wife's treatment and medicines, Mr. Shabeer has already borrowed a significant amount of money from family and friends. There are no other means by which he can pay for the treatment, so he's looking for outside assistance. He has reached out to the Child Help Foundation for financial aid.

Hussman



Hussman is a six-year-old sweet boy of Mr. Sayyad Hussain and Mrs. Sayyad Sonia, who resides in Andhra Pradesh. Mr. Hussain and Mrs. Sonia were ecstatic when they got to know that they are pregnant with their first child. Unfortunately, Sonia's last sonography reports revealed that their baby has a heart defect. Though doctors affirmed them that surgery will help correct the defect, their baby will require extra care to survive. Sonia gave birth to a baby boy Hussman, on 4 September 2015. Doctors diagnosed him with Ebstein's Anomaly with Pulmonary Atresia (a defect in the heart's electrical system). After eleven days doctors performed heart surgery on Hussman to correct a part of the defect. He struggled to breathe and had poor blood circulation.

In 2018, another minor heart surgery was performed on him as this little child's body would not have borne a major surgery. Medicines and hospital visits have been a regular part of his life. Doctors have proposed a Complex open-heart Surgery as the final part of his treatment. Hussman's parents sold their house, and all their belongings to pay for his treatment for the past five years. They have to take Hussman to Apollo Institute of Medical Sciences and Research, Hyderabad for check-ups that are far from their house. The estimated cost of his treatment is ₹ 4,50,000/-. Mr. Hussain works as a bus driver and earns ₹ 10,000/- a month. He pays a rent of ₹ 3,500/- per month and his wife Mrs. Sonia is a homemaker. They have to repay the loans they had taken during Hussman's previous heart surgeries. They are in dire need of funds so they can afford this surgery. They have reached out to the Child Help Foundation for financial aid.

Rehanshi



Rehanshi is the four-month-old baby of Mr. Dasru and Mrs. Priyanka. The couple got pregnant with her after 10 years of marriage and Rehanshi is their only child. The family lives in a rented house in Suryapet, Telangana. Rehanshi often cried in pain when she was two months old. Her parents took her to Little Star Hospital in Hyderabad where it was determined that she had a liver defect. The doctors performed a Kasai Procedure to get to know the severity of the situation. Surgery alone was not enough and little Rehanshi needs a liver transplant.

The parents took their baby to Prathima Hospital, where the liver transplant will be performed. The baby's mother Mrs. Priyanka will be the donor. The cost of this procedure is Rs. 20,00,000/- The amount is too huge for Mr. Dasru to bear. He earns Rs. 12,000/- a month working as a clerk in a private office. Rs. 5,000/- is used for house rent out of this The family is already in debt to their relatives and friends who had lent them money for Rehanshi's initial treatments. They've exhausted all their options for help and reached out to the Child Help Foundation for financial support for their daughter's treatment.

Hitanya



Hitanya and Harnoor were born in September 2015 in Fazilka, Punjab to Mr. Subhash Chander and Mrs. Paramjeet The couple welcomed angels into their lives. One of their angel's hearts had been born with congenital heart disease. Hitanya, three months old, began experiencing shortness of breath and a high fever. Her parents took her to a local hospital in Bhore Village, Punjab. Tests on her were performed and the family learned that her baby had pneumonia. Even after a lot of treatment and medication, Hitanya struggled to breathe and cried in agony. She was taken by her parents to Rainbow Hospital, Punjab. Hitanya underwent medical tests and had a heart defect diagnosed. She has AVCD which is a hole in her heart. The doctors suggested a surgical procedure called open heart surgery. Hitanya's parents were unable to afford such a huge amount, so they decided to delay her surgery. She spent almost a year in the same hospital.

She was 3 when her mother, Mrs. Paramjeet, had three major surgeries for which they had to borrow money from friends and relatives as they had drained all their savings on Hitanya's treatment. Hitanya began experiencing shortness of breath about the time the second COVID-19 wave started. She would trip while walking and cry every night because of the pain in her legs. One of their friends suggested that the parents take Hitanya to Bathinda, Punjab. She was admitted there. The parents were informed by the cardiologists that their daughter would need surgery as soon as possible to survive because the hole in her heart grew larger as Hitanya grew. Her father makes up to Rs.7,000/- a month as a mechanic. He used every rupee saved to save his daughter. The family is in financial trouble and is unable to raise Rs.4,50,000/- the required amount for Hitanya's surgery. They are looking for external help and have reached out to the Child Help Foundation for financial assistance.

Nandini Kumari

Five-year-old Nandini Kumari is suffering from a complex heart defect. Her father, Mr. Dinesh Kumar, is a laborer who makes up to Rs. 600/- per day depending on the availability of work. He is the only breadwinner in the family, which includes his wife, Mrs. Guriya Kumari, Nandini, and her two younger siblings. Nandini was born on 1st December, 2016, and her parents were excited to welcome their little angel into their lives. Their happiness was infinite. But the doctors had some troubling news to announce. Nandini developed a large size VSD sub valvular aortic stenosis. It's a rare disorder in infants that causes a fixed obstruction to blood flow. Doctors at that time gave Nandini the necessary treatment and informed her parents that she would need heart surgery in the future.

Nandini has been taking medicines since she was born. Nandini has struggled since she was born. She struggles to breathe and has poor blood circulation. Nandini's health declined when she was five years old. They took her to Mahavir Heart Hospital in Patna, Bihar. As part of her treatment, doctors have suggested that Nandini undergo a VSD closure PM VSD The estimated cost of which is Rs. 2,30,000/-. The family is in dire need of funds as they cannot afford this hefty amount and they have reached out to the Child Help Foundation for financial help.



Purvi

Purvi Pardeshi is the nine-year-old daughter of Mr. Amol Pardeshi and Mrs. Pooja Pardeshi. She has a sister, Aditi, who is 12 years old, and a younger brother, Samarth, who is 6 years old. The family currently lives in a rental house in Pune, Maharashtra. Mr. Amol makes about Rs. 10,000 /- per month working at a printing press. The minimum income is not enough to support the family. She started to fall ill when she was two years old. She was always sick with high fever, extreme cold, and cough and had numerous boils appearing on her body. When she went to the local hospital, she received a few medicines. The medicines did not help. Purvi was constantly crying in pain. Purvi's parents noticed that fluid was coming out of her ears. Then they took Purvi to the local hospital.

A few check-ups at the hospital diagnosed Purvi with Bilateral C.S.O.M, which is hearing impairment. The doctors recommended some medicines and syrups to reduce Purvi's suffering. They informed Purvi's parents that surgery would be needed to cure Purvi, but it could not be performed as Purvi was too young at that time for major surgery.

Purvi has been taking medicines since she was two. Fluid sometimes pours out of her ears, and it pains her a lot. She cannot attend school regularly, nor can she play or do any other activities. She is 9 years old and has been informed by doctors that her body is ready for surgery. She was taken to the AIMS Hospital, Pune by her parents. The doctors here have suggested an urgent Bilateral Tonsillectomy. The estimated cost of the surgery is Rs.2,40,000/-. The amount is beyond the Pardeshi family's financial capabilities and they have reached out to the Child Help Foundation for financial help.

EMERGENCY MEDICAL SUPPORT

Shivadarshini



Shivadarshini is a six-year-old girl from Chamrajnagar, Karnataka. Her parents dreamt of raising her into a beautiful and healthy child. They were excited to see her walk and play like a regular child. But fate had written something dreadful for them. Shivadarshini's parents thought that her delay in crawling and walking was normal, but it started to worry them when they noticed that even after 1.5 years of her birth. Shivadarshini cannot sit or walk properly. Her body seemed to be shifted on one side. Worried, her parents took her to a local hospital where a few check-ups found that she was diagnosed with Congenital Thoracolumbar Scoliosis (a sideways curvature of the spine that is caused by a defect that was present at birth). Shivadarshini's parents took her to Bhagwaan Mahaveer Jain Hospital, Bengaluru, Karnataka, for better treatment.

The doctors have suggested vertebral column resection, deformity correction, and fusion as a part of her treatment. For four years, due to the high cost, Shivadarshini has not received any treatment. The COVID-19 lockdowns had delayed her treatment even further.

Shivadarshini's father, Mr. Maadu works as a daily wage laborer and earns up to Rs. 200/- per day. He is the only earning member in the family of four and must pay a house rent of Rs. 1,000/- per month. The estimated cost of Shivadarshini's treatment is Rs. 5,00,000 /- The family was in peril and was struggling financially. They have reached out to the Child Help Foundation for financial help for Shivadarshini's treatment.

Saisha Shinde



Saisha Shinde is the six-year-old daughter of Mr. Ankush Shinde and Mrs. Kirti Shinde from Pune, Maharashtra. The feeling of parenthood gave them extreme excitement when Mrs. Kirti conceived their baby. It was until the last sonography that they were in the bliss of happiness. The final sonography report discovered that the baby is suffering from Tricuspid Atresia, a heart defect. The couple decided to provide their unborn child with everything needed and face their fate bravely. A month later, on 14th August 2015, Mrs. Kirti gave birth to a sweet baby girl, Saisha. Because of her heart defect, she was kept under observation and was discharged when it was safe for her to be without any medical support for the time being. Mr. Ankush and Mrs. Kirti were scared yet looked after her with the utmost care. When she turned four, her parents noticed that Saisha's skin turned blue, and she struggled to breathe often.

Her parents took her to the Fabiani and Budhrani Heart Institute in Pune, Maharashtra. Heart surgery was performed on Saisha. Because her body was too weak to handle a major surgery all at once, this surgery only corrected half of her heart defect. Saisha began to have breathing problems after that. The medical team advised her to undergo TCPC surgery as a continuation of the previous treatment. surgery (Total Cavopulmonary Connection) as a continuation of the previous treatment. The estimated cost of the treatment is Rs. 4,00,000 /-

Mr. and Mrs. Shinde do not have the funds to get the surgery done. The father works under a photographer and gets to work as and when the need arises. He is the only income producer in the family and earns up to Rs. 10,000/- per month. They have exhausted all their savings and have reached out to the Child Help Foundation for financial support.

Arun Kamboj

Arun Kamboj is a one year seven months old boy, suffering from complex heart disease. His father Mr. Sanjay Kumar is a daily wage laborer who earns a minimum income of Rs. 4,000/- per month. His mother Mrs. Bimla is a homemaker. Arun along with his parents, grandparents, and twin brother (Varun) live in Haryana.

After his birth, Arun's parents noticed that he was born with fused fingers. They took him to doctors and a few tests later it was discovered that Arun was suffering from complex congenital heart disease. The parents took Arun to Paras hospital, Gurugram for further treatment. The doctors there suggested that Arun needed to undergo open heart surgery to overcome the condition.

The estimated cost of the surgery was Rs. 4,50,000/- The Kambhoj family was very scared that they would lose their child because they couldn't afford the surgery and they were getting no help. That is when they reached out to the Child Help Foundation and we were able to help them through this peril.

Arun successfully underwent the surgery and was discharged on 2nd April 2022 and is back home with his family.



Omakar Mohite

10-year-old, Omakar Mohite lives in Osmanabad, Maharashtra. His father Mr. Ram Mohite, and mother, Mrs. Vaishali Mohite work as daily wage laborers, and they both earn a minimum income of Rs. 500/- collectively per day. The family consists of seven members- Omakar, his parents, three sisters, and his grandmother.

Two years ago, when Omakar was coming back from school, his sister noticed that his eyes were swollen and red, and his tongue and nails were discolored. The family rushed him to a nearby hospital. After a few check-ups, Omakar was diagnosed with Tricuspid atresia with severe pulmonary stenosis perimembranous VSD with large ASD. In simpler terms, a portion of his heart was undeveloped, resulting in respiratory issues.

Omakar's parents then took him to Balaji Heart Hospital and Diagnostic Centre, Solapur, for better treatment. The doctors there suggested that Omakar needed to undergo Bidirectional Glenn (BDG) Shunt, a surgery to improve blood oxygenation for patients with a congenital cardiac defect. The estimated cost of the surgery was Rs. 3,30,000/- For a family who lives in a remote village, and earns very little to meet their basic requirements, the amount of the surgery was enormous to bear and they were heartbroken. They reached out to Child Help Foundation and were provided financial support for Omakar's treatment. Omakar's surgery was successful and he was then discharged on 4th May 2022.

Sarthak Thombre

Sarthak Thombre is a 7-year-old boy from Dhangarwada, Satara. His father, Mr. Rohidas Thombre works as a laborer, and his mother, Mrs. Archana Thombre is a housewife.

A month ago, Sarthak had suffered frequent fevers which would subside when taken medicine but would recur. Concerned about his health, his parents took him to Bharati Hospital, Pune. The test results showed that Sarthak suffered from acute lymphoblastic leukemia. The doctor suggested that Sarthak would need chemotherapy which would cost Rs. 7,00,000/-

Sarthak's family consists of 6 members. His father is the only earning member of the family. With a very low income, it had become very difficult for the father to bear the costs alone for Sarthak's treatment and he was trying his level best but his son needed the surgery urgently. Mr. Rohidas Thombre reached out to the Child Help Foundation for assistance. We were able to help aid in Sarthak's treatment and after the beginning of the chemotherapy, he has been doing better and was discharged on 6th May 2022.



Dimple Kumari

Dimpal Kumari, a 4-year-old, is the elder daughter of Mr. Mangal Thakur and Mrs. Rani Kumari. The family consists of five members, including Dimpal's grandmother and her younger brother Rishabh, who is 2. They live in Muzaffarpur, Bihar. Dimpal's father is the only breadwinner in the family and earns only Rs. 7,000/- per month.

When Dimpal was around 3.5-years-old, she constantly suffered from respiratory issues, wherein she was unable to breathe properly. She often wheezed and coughed while breathing. Her parents were worried about this and took her to a local doctor. The doctor indicated that Dimpal could be having a heart problem. Later, she was taken to the Mahavir Heart Hospital, Patna.

Several medical test reports diagnosed Dimpal with Adult Congenital Heart Disease (ACHD), Trivial Aortic regurgitation (AR), and Dilated left atrium and left ventricle. The doctors suggested that she undergo a PDA Device Closure. The estimated cost of this procedure was Rs. 1,20,000 /-. The family was struggling to get sufficient funds for Dimpal's surgery and with the Child Help Foundation's help, her procedure was successful and Dimpal was discharged on 6th April 2022.

Mohd. Ubaid

Mohd. Ubaid is a 2-year-old boy from Hyderabad. Ubaid's father, Mr. Arif, works as a ramp supervisor at the airport on a contract basis while his mother, Mrs. Afreen Unnisa Begum, is a housewife. The family consists of four people. Ubaid is the younger son of the couple and has an elder brother of 3 years, Mohd. Umair.

Ubaid was born with respiratory issues. He was diagnosed with severe subglottic stenosis which means he had a narrow breathing pipe. A few months after his birth, Ubaid underwent surgery for broadening his respiratory pipe, but it did not seem to help him in any way. He continued to face breathing issues. The doctor had advised that Ubaid needed to undergo a staged repair of Subglottic stenosis with balloon and coblation surgery which would be conducted in 4 stages. He was receiving his treatment in Rainbow Children's hospital, Hyderabad. The estimated cost of his treatment was Rs. 9,00,000 /-. Mr. Arif was struggling financially to get the funds for his son's treatment and that is when he reached out to the Child Help Foundation for support with the organization's help, Ubaid's treatment was successful and he was discharged on 9th May 2022.

Shristi Kondhare

Shristi Kondhare, a nine-month-old baby girl, was suffering from a critical heart condition. Her father, Mr. Haridas Kondhare, owns a small piece of land for farming. He is the only income provider of the family and earns up to Rs. 3,000 /- per month. Shristi along with her parents lives in a very remote area of Osmanabad, Maharashtra.

Mr. and Mrs. Kondhare, like all new parents, were taking utmost care of their only child. After a few months from her birth, they noticed that Shristi was not gaining weight as a healthy child would and she even appeared to be very weak. Tensed, the parents took their baby to a local hospital in Osmanabad, where medical tests revealed that Shristi is suffering from a Large Perimembranous Ventricular Septal Defect. It is a congenital heart defect. The doctors then suggested that Shristi needed an Intracardiac Repair of VSD Closure as a part of her treatment.

Shristi's parents then shifted her to Balaji Heart Hospital, Mumbai for treatment. Here they discovered that the estimated cost of the treatment was Rs 2,50,000/-. With time all of their savings had exhausted and they were heartbroken that they couldn't help their little girl. Child Help Foundation financially supported the family and Shristi's surgery was successful and she was discharged on the 9th of May, 2022.

Hemavathi

Three-year-old Hemavathi is the younger child of Mr. Shreenivas, a tailor, and Mrs. Renuka, a homemaker. Hemavathi's elder brother Lakshman is five. The family of four lives in Shorapur Taluka, Yadgir District, Karnataka.

Baby Hemavathi suffered from Dorsal Lumbar Kyphoscoliosis. In simpler terms, Kyphoscoliosis is an abnormal curve of the spine on two planes: the coronal plane, or side to side, and the sagittal plane, or back to front. Since Hemavathi was six months old, her parents noticed that she was not growing like a normal baby. She was frail, and her body lacked many essential vitamins. Her parents took her to a local doctor, who suggested that the baby required advanced treatment.

The family then took her to the Department of Spine Surgery at Bhagwan Mahaveer Jain Hospital, Bengaluru, Karnataka. Here, the doctors suggested that Hemavathi needs Posterior instrumentation with growth rod application. The estimated cost of this treatment is Rs. 3,50,000/- Mr. Shreenivas is the sole breadwinner who only earns Rs. 8,000/- per month. The family's survival was becoming very difficult, and the medical expenses were draining emotionally and financially. With the support of the Child Help Foundation, Hemavathi was able to get the treatment she required and she was discharged on 13th May 2022.



Moni Kumari

Moni Kumari is a 12-year-old girl from Faridabad, Haryana. Her father, Mr. Dawlu Mandal, and mother, Mrs. Archana Devi, are factory workers who make an income that barely supports their monthly expenses. Moni has two siblings, Soni (20) and Shweta (10). The family of five live in a rented house which costs them Rs. 2,000 /- per month. Moni had a cleft lip, which is a split in the upper lip. This means that there was a complication during the development of her facial structure. The doctors, after Moni's birth, suggested surgery for her condition. But because of their poor financial condition, her parents could not manage to afford the cost of treatment. As she grew up, Moni started to face difficulty breathing and had frequent colds. When checked with the doctors, it was discovered that Moni was suffering from Aspiration Pneumonitis, which is an infection of the lungs caused by inhaling saliva, vomit, and even small foreign objects. A delay in the surgery for the cleft lip had caused this condition. Moni's parents took her to Swastika Multi-specialty Hospital, Haryana for treatment.

The doctors had suggested treatment for Moni's condition. The estimated cost of which was Rs. 2,00,000/- The parents were worried because they were financially in a poor condition and they were afraid that they wouldn't be able to collect the amount for the surgery. They had reached out to the Child Help Foundation for help and Moni's treatment was successful, and she was discharged on 9th May 2022.

Andriya

Andriya Sanil is a 9-month-old baby girl from Ernakulam, Kerala. Her father Mr. Sanil Varghese works as a daily wage laborer with an annual income of Rs. 30,000/- only. He is the only breadwinner in the family of seven. The baby's mother Mrs. Joby Paul is a homemaker. The couple has an elder son, Albert (2.5 yrs), and a set of triplets- Alchya, Anliya, and Andriya.

When Andriya was 3-months-old, her parents noticed that her head was growing abnormally. It grew in an elongated shape. Worried, the parents took her to Kottayam Medical College Hospital, Gandhi Nagar, Kerala. After several tests, it was found that Andriya is suffering from Multi Sutural Craniosynostosis. This congenital condition causes the head of the infant to stop growing in some areas as it would grow healthily and expand abnormally in other areas.

Andriya's parents took her to Amrita Institute of Medical Sciences and Research Center, Kochi, Kerala, for better treatment. The doctors at the hospital had advised that Andriya should undergo Craniofacial surgery (correction for craniosynostosis). The estimated cost of the surgery was Rs. 2,05,000/- The medical expenses had drained the family of its savings and they reached out to the Child Help Foundation. With the help of the organization, Andriya's surgery was a success and she was discharged on 16th May 2022.

Lakshay Singh

Lakshay Singh is the 6-year-old son of Mr. Nirbhay Singh and Mrs. Poonam Singh. His father is a security guard supervisor with a monthly income of Rs. 16,000/-, and his mother is a homemaker. The family of three lives in Mira Road, Mumbai. On 4th November 2021, when the entire nation was happily celebrating Diwali, little Lakshay met with a horrible accident that changed his life forever. The boy and his father were playing with firecrackers in their society compound when a spark from the Phooljhari (sparkles) lit up an entire bag full of firecrackers, and Lakshay's body caught fire. All his clothes got stuck to his body, causing immense pain to the little boy.

His father and neighbors were horrified by the incident and took him to a local clinic. The doctor saw the severity of the injuries and advised the father to take their son to Family Care Hospital, Mira Road. Here, his wounds were cleaned up but unfortunately, they did not have the equipment to treat Lakshay further. He was then shifted to the National Burns Center, Airoli. The doctors have suggested multiple skin grafting surgeries, out of which two surgeries have been performed successfully. The Singh family borrowed money from relatives and neighbors for Lakshay's treatment. All their savings, including Mr. Nirbhay's Diwali bonus, were spent and exhausted on the medical. A total of Rs. 3,90,200 /- is the estimated surgery cost, and his father had no means to raise this huge amount. Child Help Foundation was able to support them financially for the treatment and Lakshay's surgery was successful and he was discharged on 16th May 2022.

Twins Of Neeta

The twin baby girls of Neeta Changlani are 26-days-old premature babies who were born in Jaipur, Rajasthan. Their father, Mr. Nitin Changlani, works as a salesman in a local shop and earns Rs. 8,000 /- per month and their mother, Neeta is a homemaker. Mr. Nitin's father and mother live with them in a rented house which costs them Rs. 3,500/- per month.

During the sixth month of pregnancy, Mrs. Neeta suffered from blood pressure fluctuations. She was rushed to Rohit Hospital in Ajmer. Prolonged pregnancy was a danger to the twins' and mother's lives, and hence, Mrs. Neeta had to undergo an immediate C-section delivery. The twin girls were born with extremely low birth weight and suffered from other symptoms of prematurity.

The doctors at Rohit Hospital had advised keeping the twins under NICU treatment for the next couple of months. The twins were shifted to Neo Clinic, Jaipur for NICU stay. The estimated cost of their treatment was Rs. 13,00,000 /-. The family was extremely disheartened because they were struggling to get the money. Child Help Foundation was able to help them with financial support and the twins were discharged on 20th May 2022.



Muhammed Shahal

Muhammed Shahal, a 14-year-old boy, was suffering from T - cell Lymphoblastic Lymphoma. His father, Mr. Saleem works as a laborer, and when he gets work he earns up to Rs. 900/- per day. His mother, Mrs. Rasina is a homemaker. The family lives in Kozhikode, Kerala.

In December 2021, Muhammed Shahal noticed that he was not able to breathe properly and it pains in his chest whenever he tries to breathe. His parents took him to a government hospital, where a test result showed swelling in his lungs.

Later when his parents took him to MVR Cancer Centre and Research Institute, Kerala, several tests diagnosed him with blood cancer. The doctors then advised the family that Shahal needed chemotherapy as a part of his treatment.

The estimated cost of the treatment was Rs. 6,00,000 /- The family was struggling to get funds for Shahal's treatment and reached out to the Child Help Foundation for support. With the support of Child Help Foundation, the family was able to get Mohd. Shahal received urgent treatment and was discharged on 23rd May 2022.

Aliya Fatima

Aliya Fatima is a 15-year-old beautiful girl from West Bengal. Being the youngest daughter of a family, she has always been loved beyond words. When she was 14, Aliya developed a severe fever. She had trouble breathing and felt nauseous. Concerned, her parents, Mr. MD Aslam and Mrs. Aasma Khatoon took her to a neighboring hospital. Their world came crashing down in March 2020, when they got the worst news any parent could receive. Their beautiful girl was diagnosed with End-Stage Renal Disease.

Aliya's treatment began immediately, but due to the COVID-19 lockdown, it became a challenge for her family to continue her treatment. Her father is a driver and earns up to Rs. 10,000 /- per month supporting the family of six. Having depleted all of his savings while treating his ailing daughter and tending to his family's basic needs during the pandemic, Aliya's father still managed to raise money from his generous relatives and friends. Her siblings had to drop out of school because the majority of their funds were going towards their sister's treatment.

Aliya was treated at home for two years, but her condition began to deteriorate, and doctors had advised that a Kidney Transplant was her last hope of survival. After a lot of challenges, the family was striving to face this difficult phase of their life. The estimated cost of the surgery was Rs. 10,30,000 /- All the tests were initiated, and the family had prepared themselves for Aliya's kidney transplant. Her mother being her donor was her only savior. The expense was too huge for the family to bear. They had already put everything they own at risk to save Aliya. The family lacked the financial means to help her undergo the urgent treatment and with the help of generous donors and the support provided by the Child Help Foundation, Aliya's surgery was successful and she was discharged on 23rd May 2022.



BABY FEEDING CENTER (BFC)



Child Help Foundation's Resource Mobilization Manager Mr. Ninan visited the Baby Feeding Centres (BFCs) at Lakeshore Hospital and the General Hospital in Kerala. The BFCs have been useful to **75** mothers by providing a safe space for these mothers to breastfeed their infants. The feedback received from the beneficiaries has been very positive.

Our BFCs are maintained properly as well, keeping the babies' and the mothers' hygiene needs in mind. Mothers are grateful for the facilities provided in the center.

Child Help Foundation's volunteers visit the centers every month to check on the working and maintenance of the BFCs.



MEDICAL CAMP



Child Help Foundation in collaboration with the Indian Cancer Society organized a Medical health check Up camp on the occasion of World Ovarian Cancer Day on 7th May 2022 at Jahangir State, Mumbai. The camp was managed by Child Help Foundation Volunteer Ms. Neha Singh. Through this camp health check facilities were provided to **45** people. The camp included ladies' routine check-ups, Oral check-ups, BP checks, and more. The camp was open to all and free of cost.





EDUCATIONAL SUPPORT



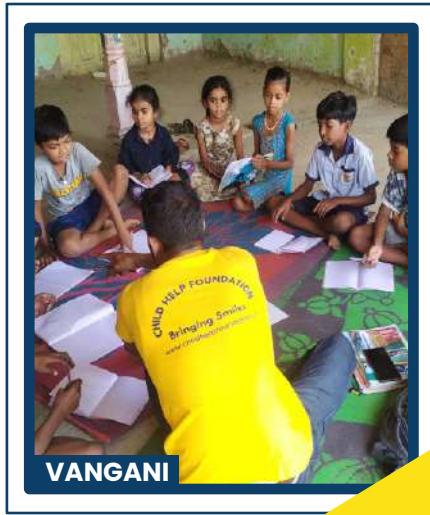
1. Digital Classroom:

Construction of Toilet

ZERO HUNGER



Child Help Foundation in collaboration with Roti Ghar provided fresh warm meals to 1800 children daily in Mumbai, Delhi, Bangalore, Odisha, and Hyderabad. The Idea behind this initiative taken by Child Help Foundation and Rotighar is to reach children in need who are malnourished and serve them freshly cooked meals that are prepared in our centralized kitchen. The zero hunger program has already helped **54,000** beneficiaries monthly.





LIFE BELOW WATER



Child Help Foundation Volunteers conducted weekly Beach clean-up activities, thereby contributing to saving the environment. MBMC workers/staff also provided their support to the event. Many people from surrounding localities involve themselves as volunteers. During our beach clean-up activities, several college students had come forward to volunteer with us. Around **19,400 kgs** of plastic waste were collected in April. These activities were conducted at Manori, Uttan, Bhayander East, Velankanni, and Gorai beaches in Maharashtra.





Village Cleaning

Sahapur, Odisha

A monthly village cleaning activity is done by almost 10-15 volunteers of Hemachandra Sanskrit Vidyalaya at the village of Sahapur, Odisha. Volunteers clean community and temple places and proper instruction is given to villagers to keep their areas clean and tidy. Through this activity, they have learned to clean the premises of the village and also gave motivation to others. This activity has helped over **400** villagers living in the area.

Village Development Project

Bhintghar Village-Gulabi Gaon- Inauguration of the Foundation of Business Hub and Community Hall:

On 13th May, the Business Hub and Community Hall foundation's inaugural ceremony was laid by Dr. Bharati Pawar, Union Minister for Health and Family Welfare of India at Bhintghar Village, Nashik, Maharashtra. This new project was implemented by the Child Help Foundation with the support of the India Infoline Foundation (IIFL). The project is about women's empowerment.

The aim of the project is to support children from the village by supporting their families. The total number of beneficiaries who attended the program was 104. The program started with the lighting of a lamp and ended with the felicitation ceremony and valuable words of dignitaries including top members of the management at Child Help Foundation.

As per the feedback given by the villagers, they have appreciated the project concept and the project will help them to stop the migration of people due to a lack of source of livelihood, and also it will promote the education of their children.

21 Volunteers from the Child Help Foundation, Bengaluru participated in Majja Run. They ran a 10 Km marathon that was organized by TCS to spread awareness about the Sustainable Development Goals (SDGs) that were adopted by the United Nations in 2015.
